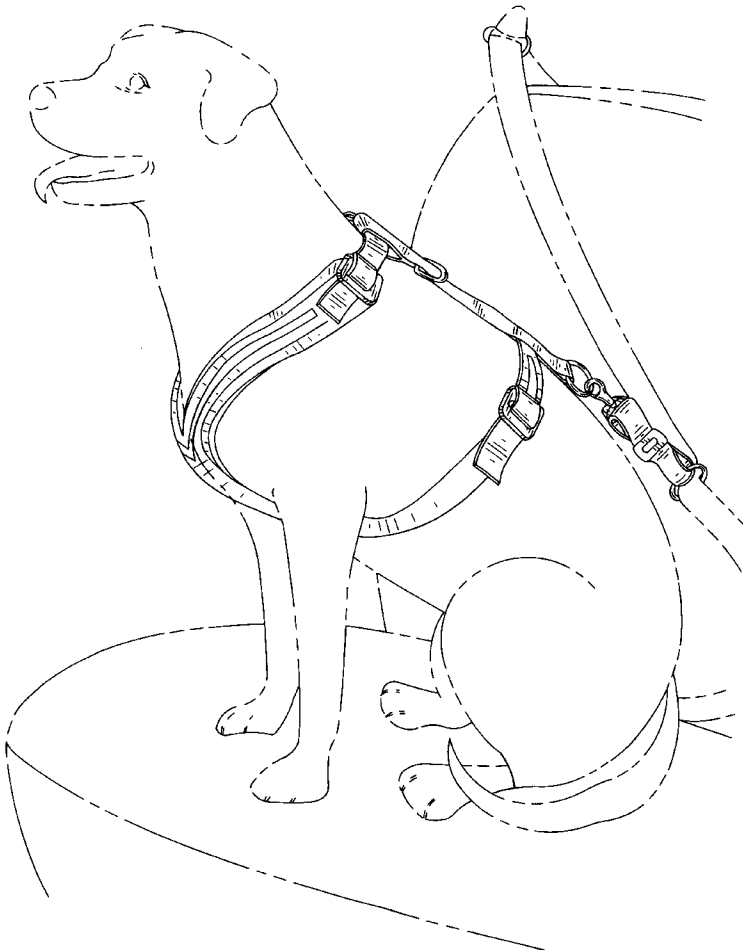
[57] CLAIM

DESCRIPTION

FIG. 1 is a perspective view of the top of a dog leash showing my new design;
FIG. 2 is a perspective view of the bottom of the dog leash showing my new design;
FIG. 3 is an perspective view thereof, showing the claimed design in use;
FIG. 4 is an exploded perspective view thereof;
FIG. 5 is a top view thereof;

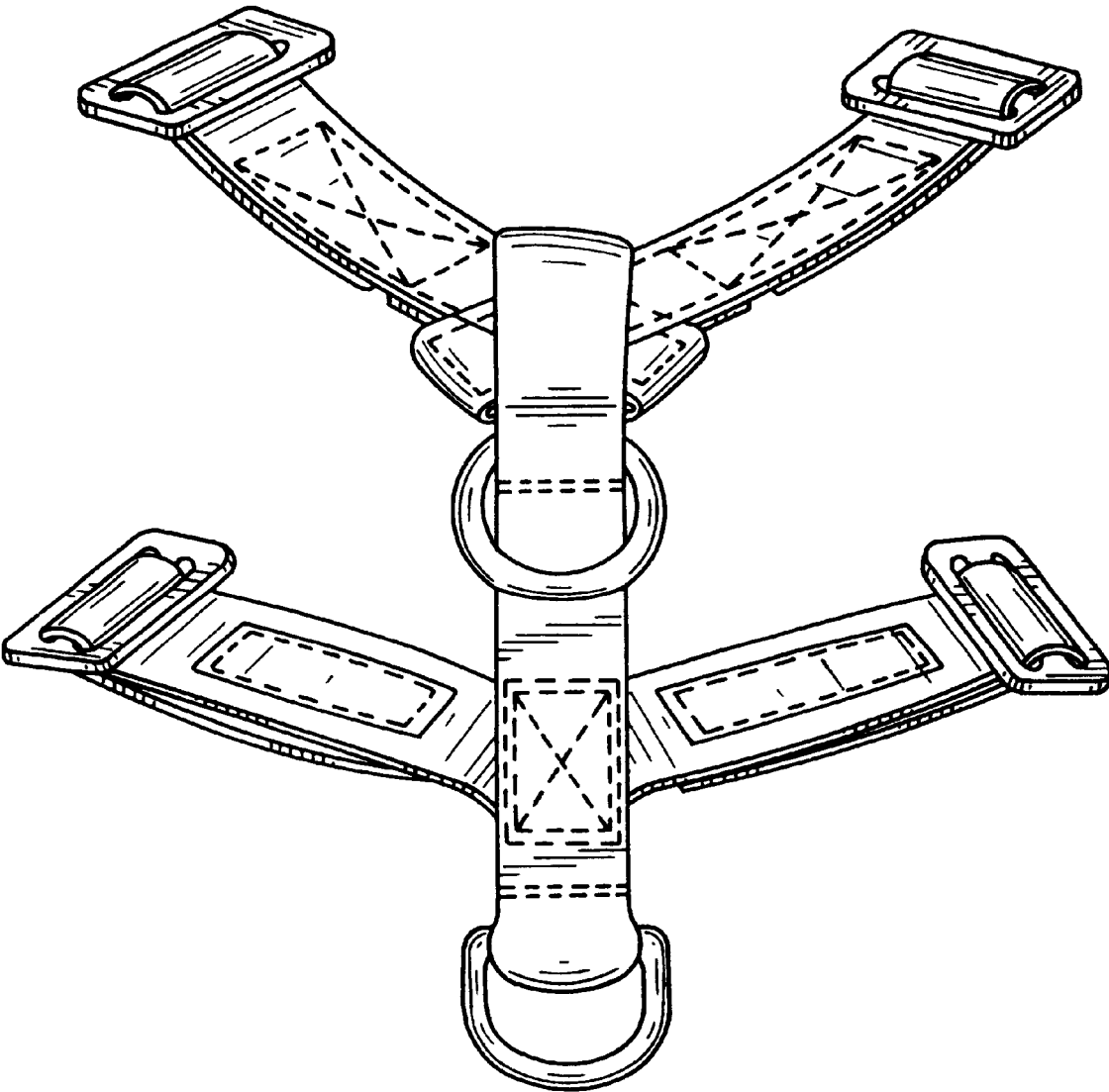

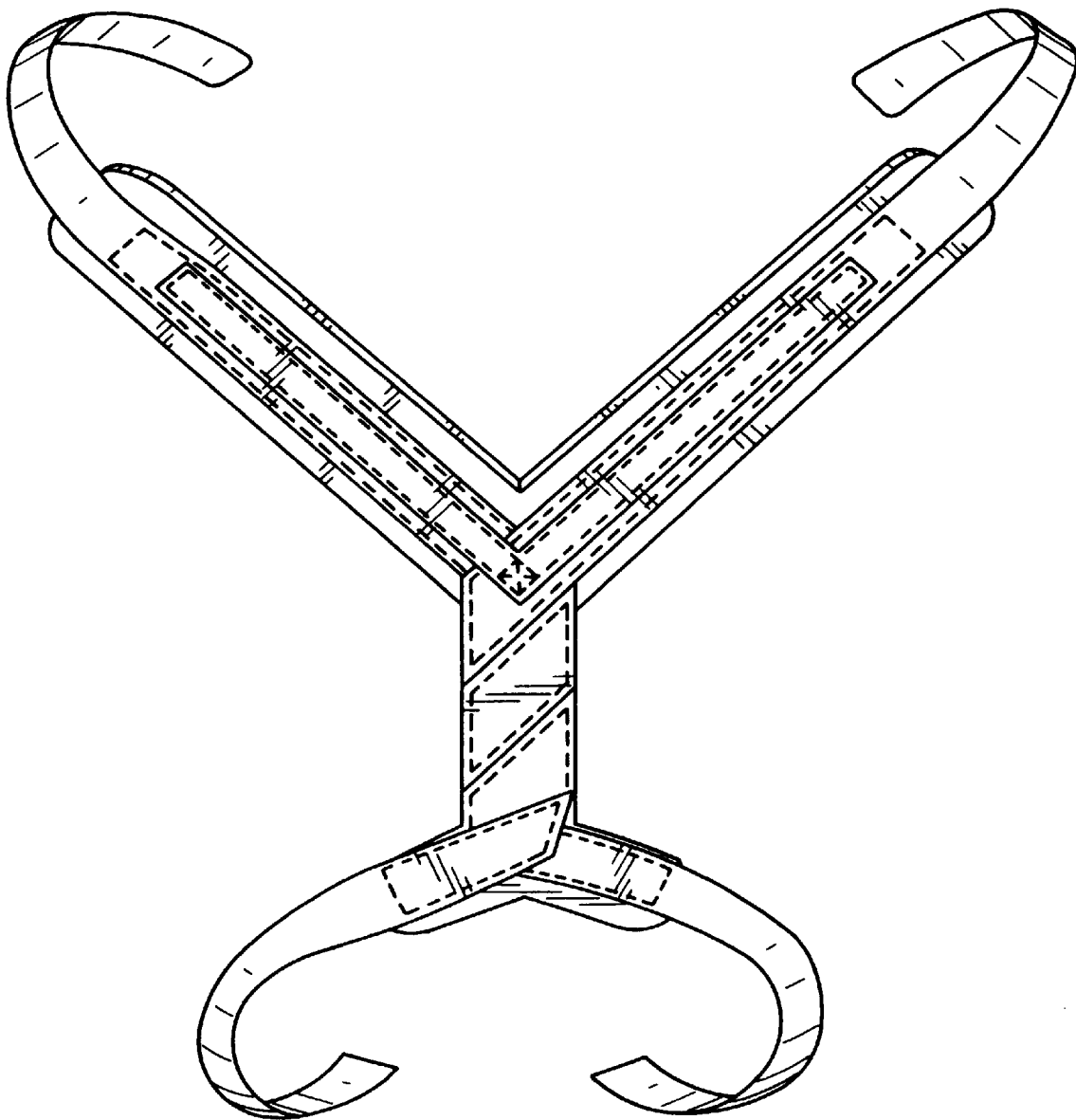

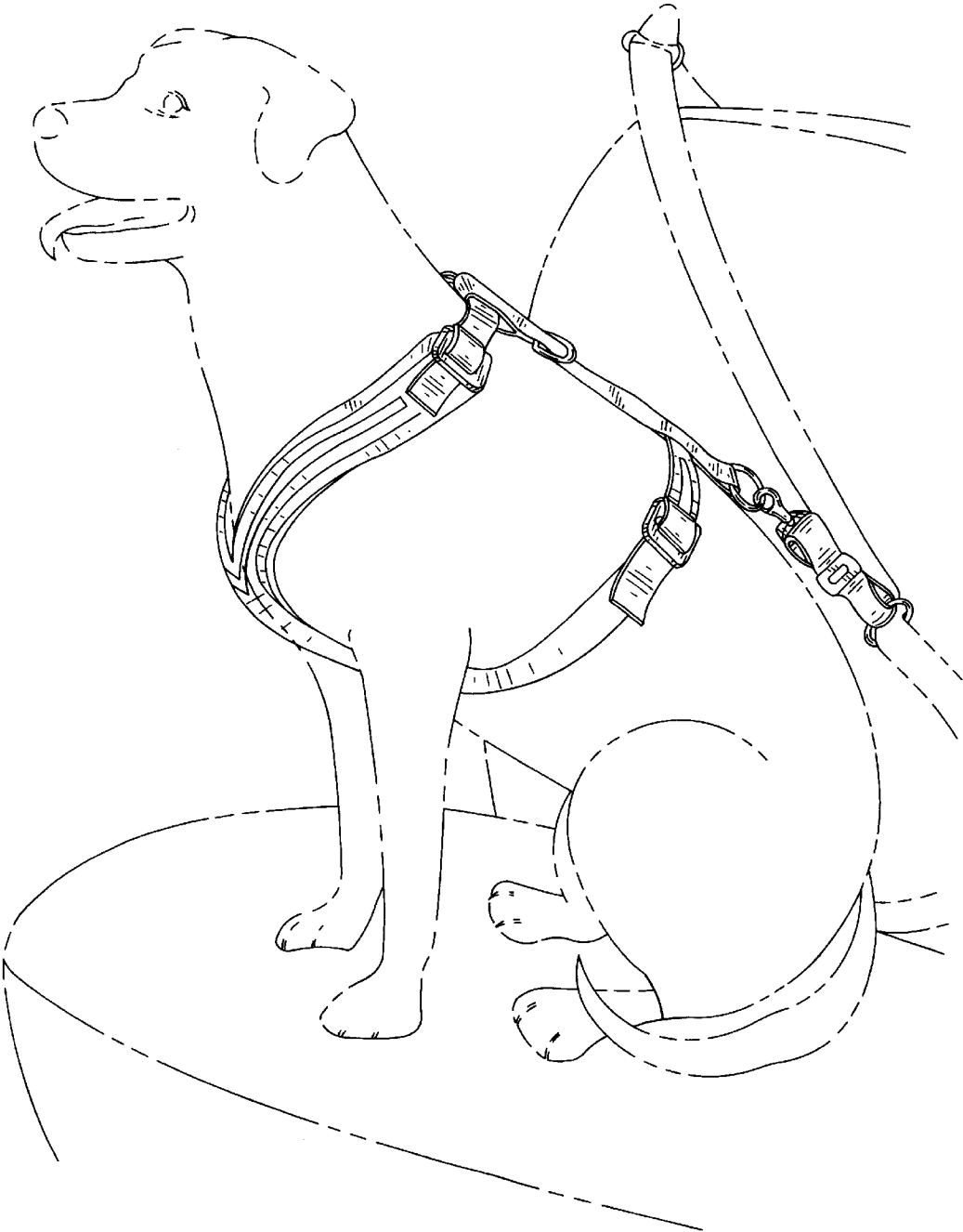
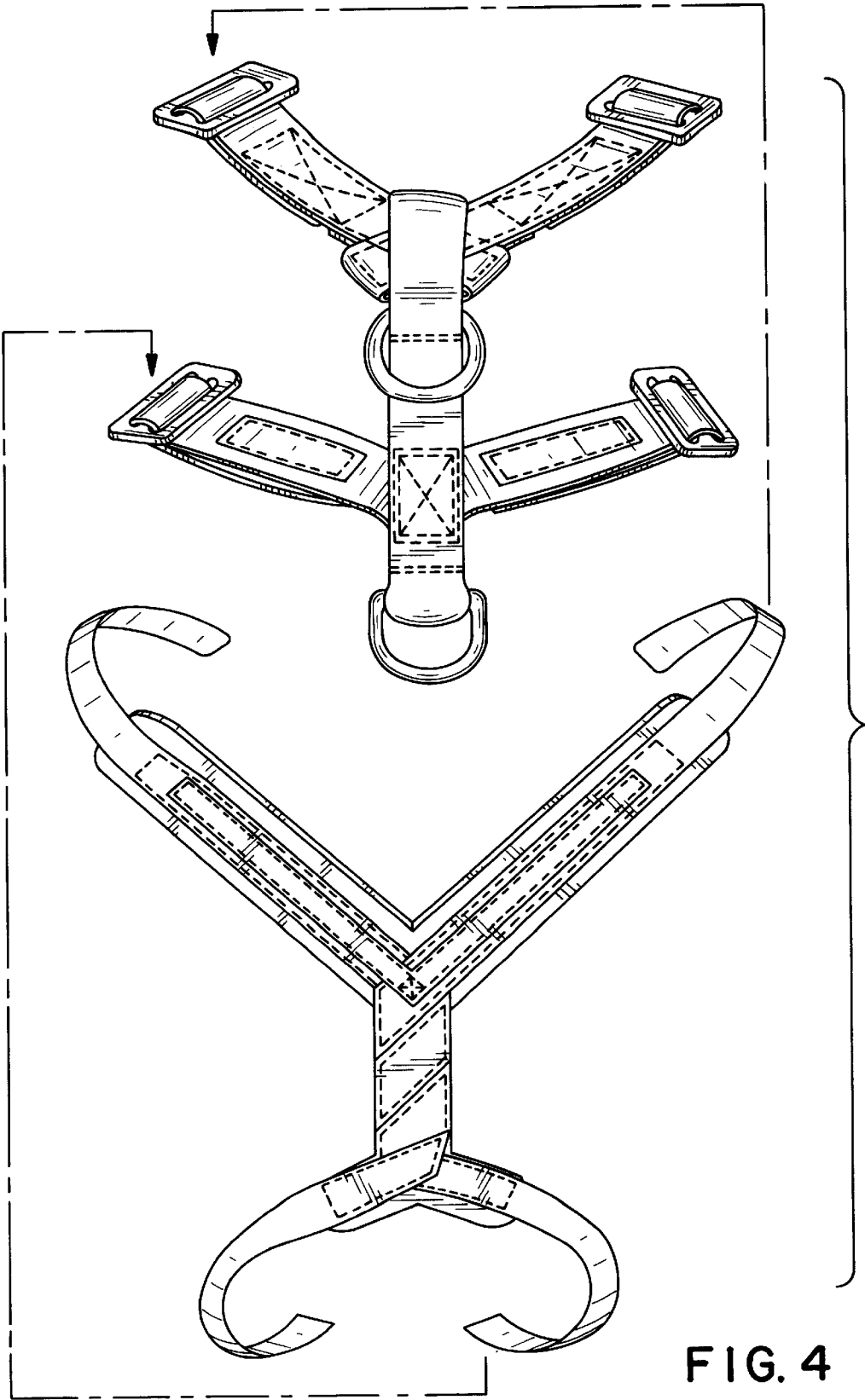

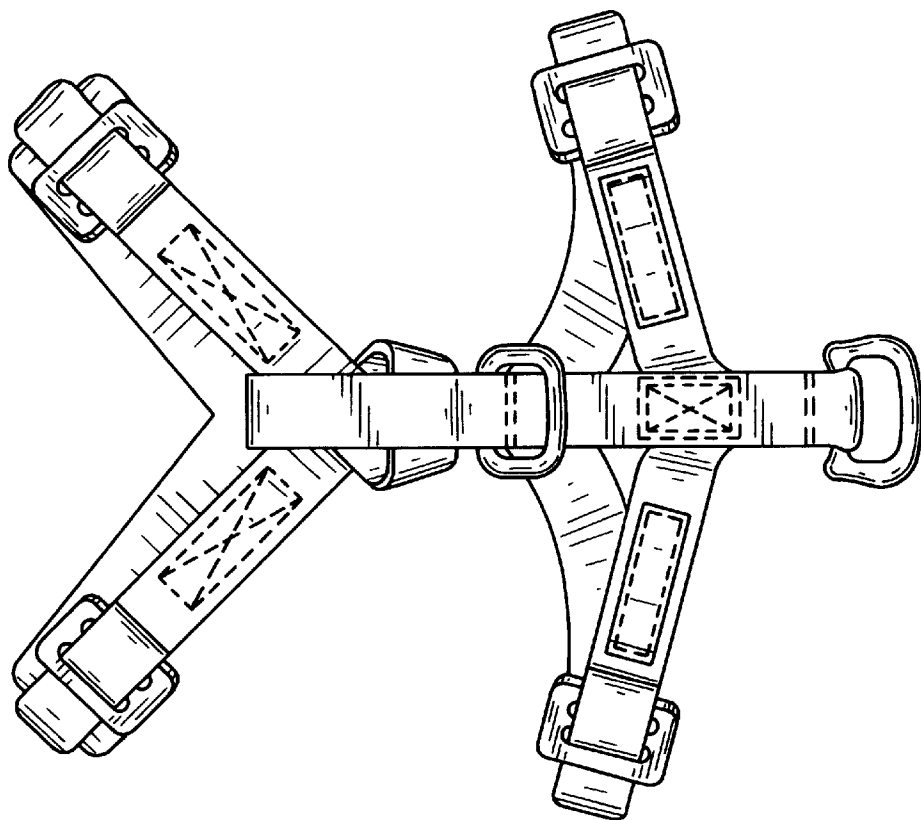

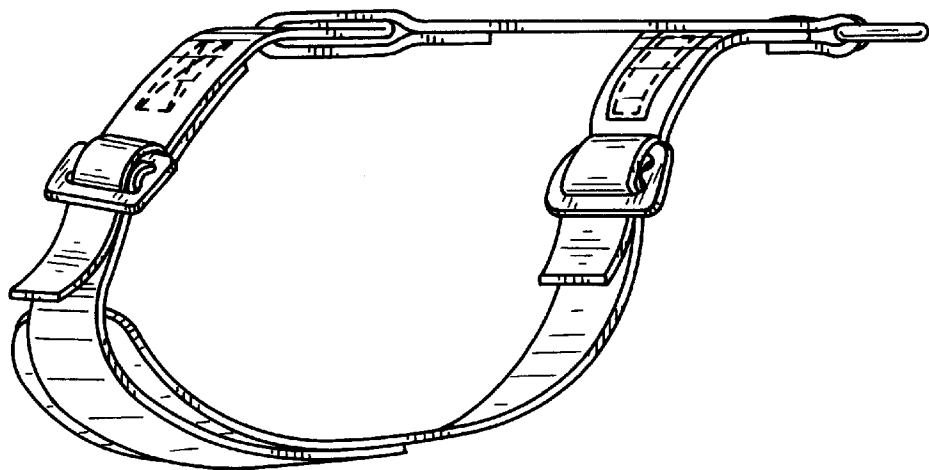

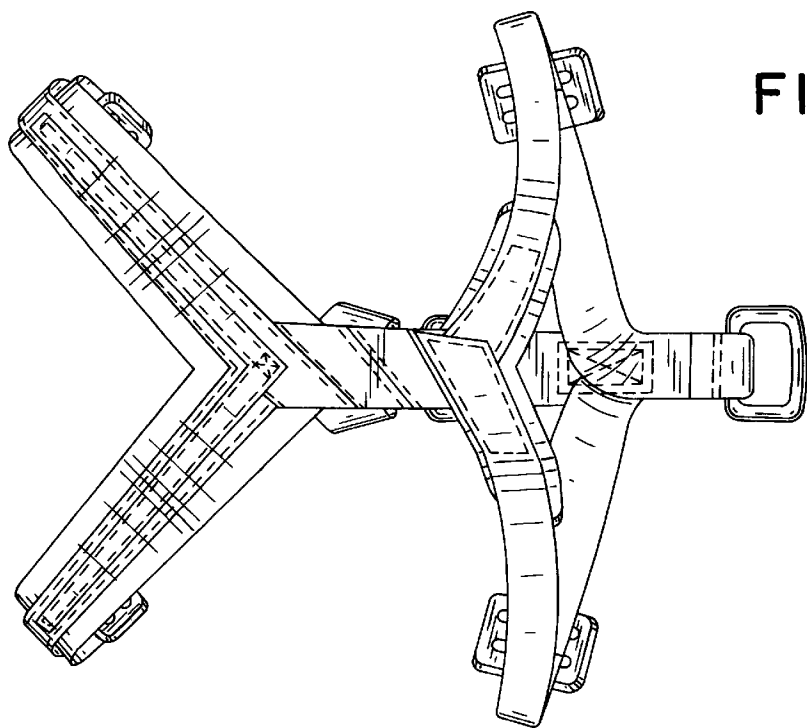

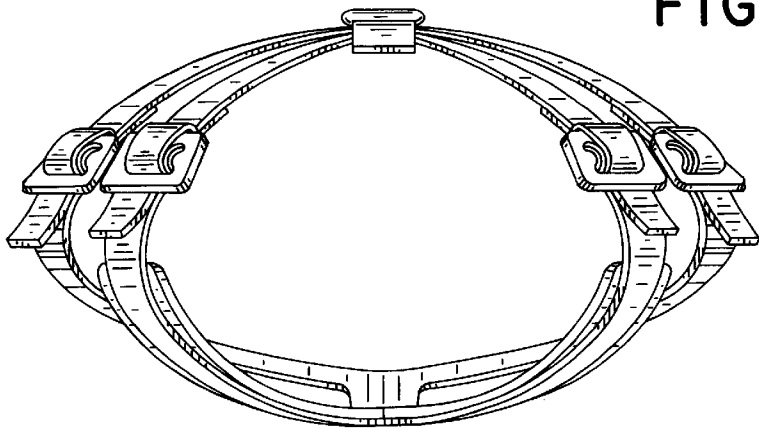

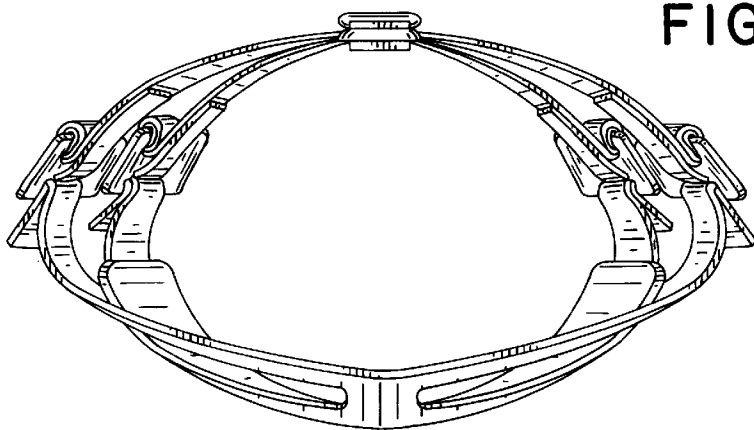
