(57) **CLAIM**

The ornamental design for a tattoo needle holder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a tattoo needle holder showing my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view thereof.

The broken lines shown in FIG. 3 illustrate portions of the tattoo needle that form no part of the claimed design. The broken lines shown in FIG. 7 illustrates environmental subject matter and forms no part of the claimed design.














