The ornamental design for a pair of mounting brackets, as shown.

DESCRIPTION

FIG. 1 is a perspective view, taken from the front, top, and left side, of a pair of mounting brackets, in accordance with my new design;

FIG. 2 is a front elevational view of the pair of mounting brackets shown in FIG. 1;

FIG. 3 is a rear elevational view of the pair of mounting brackets shown in FIG. 1;

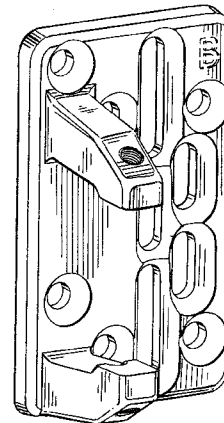
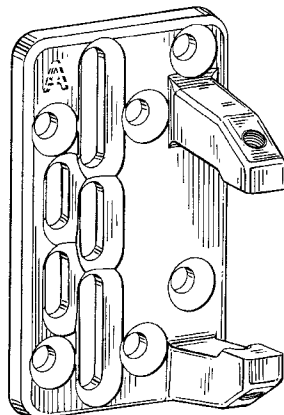
FIG. 4 is a top plan view of the pair of mounting brackets shown in FIG. 1;

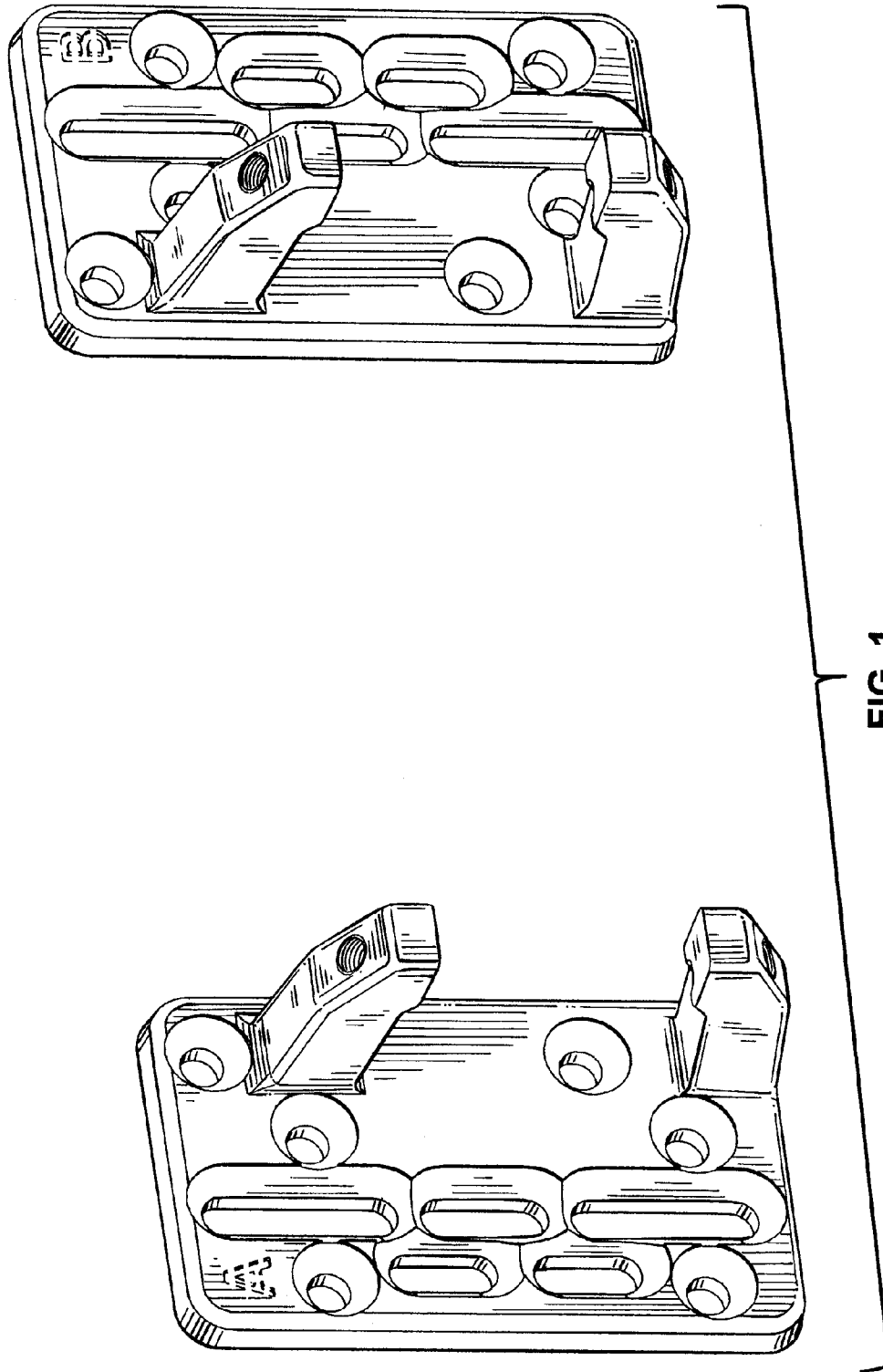
FIG. 5 is a bottom plan view of the pair of mounting brackets shown in FIG. 1;

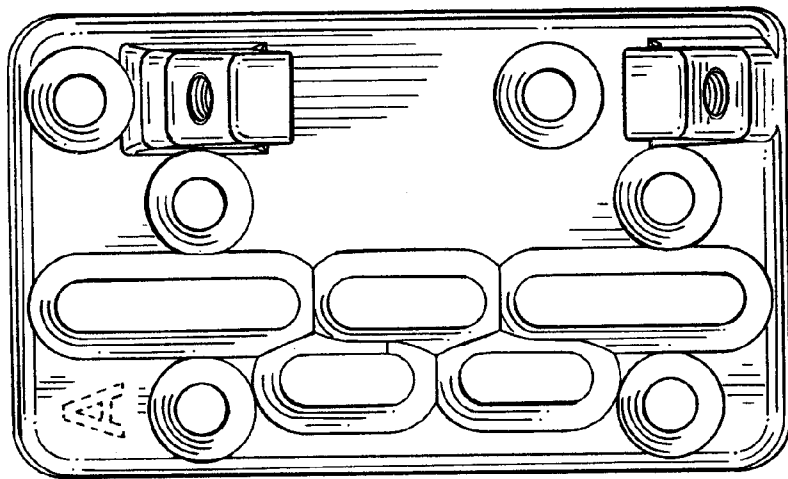
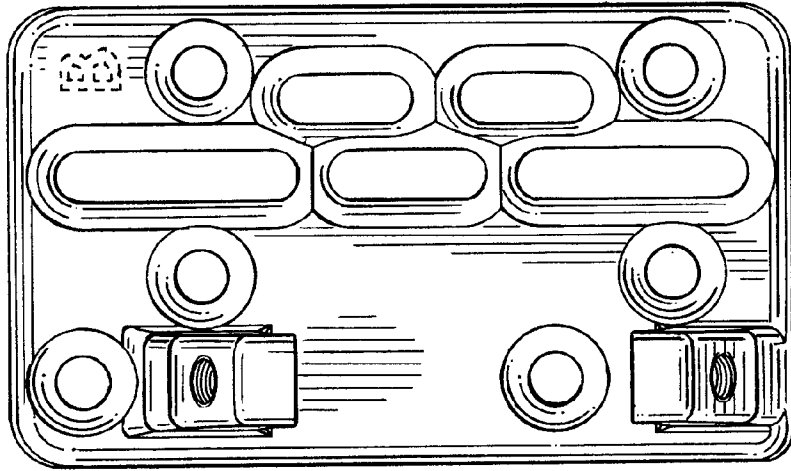

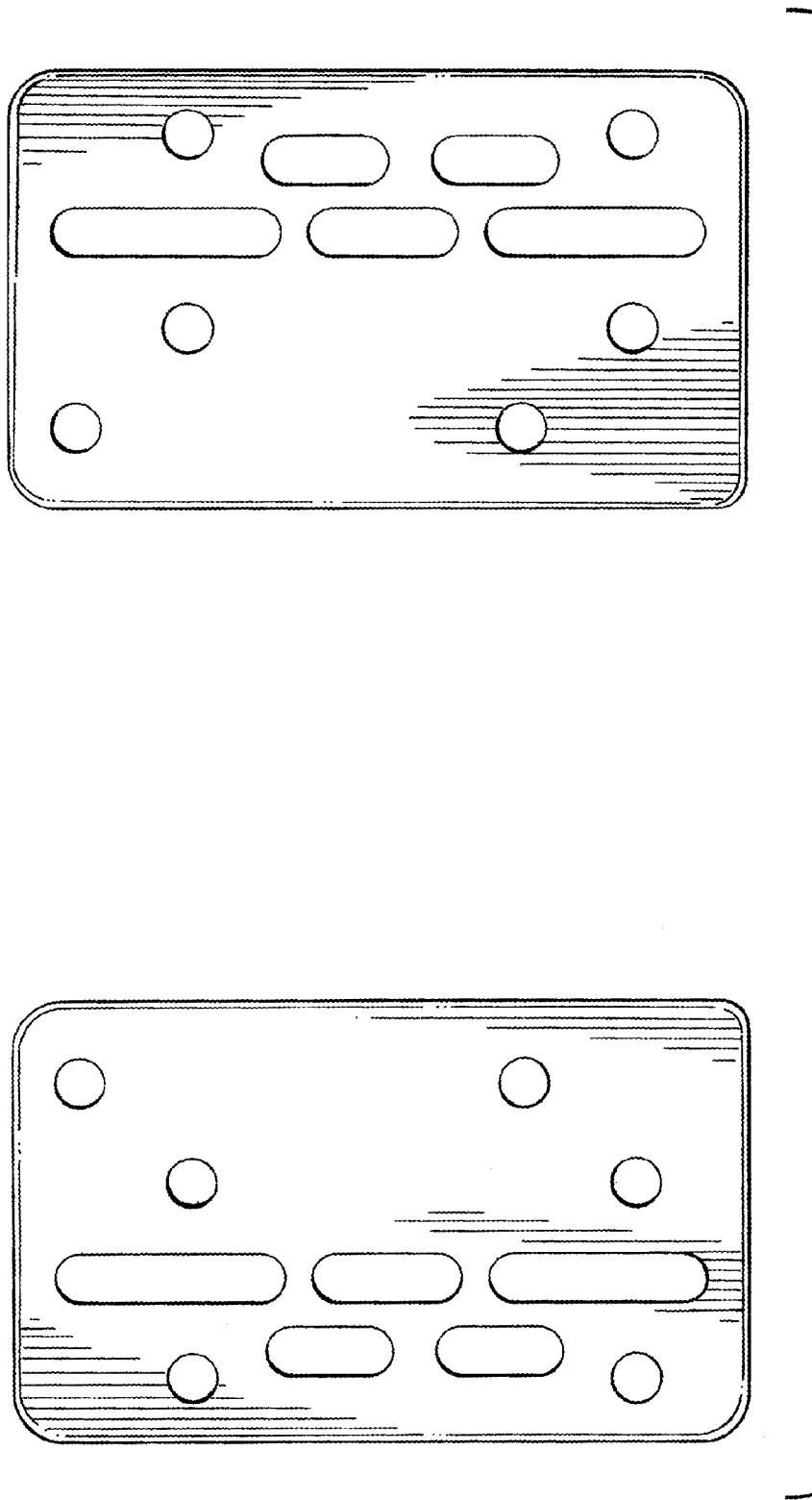

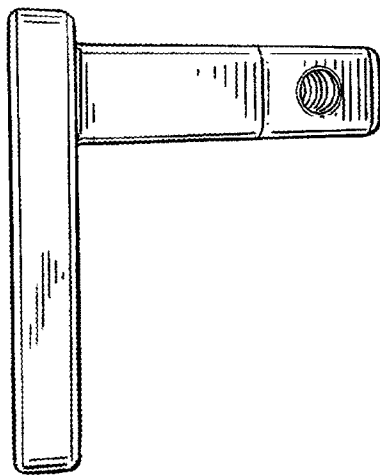
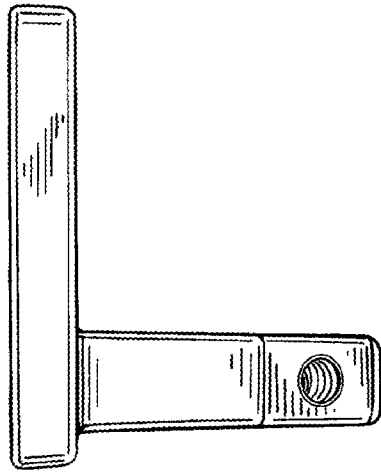

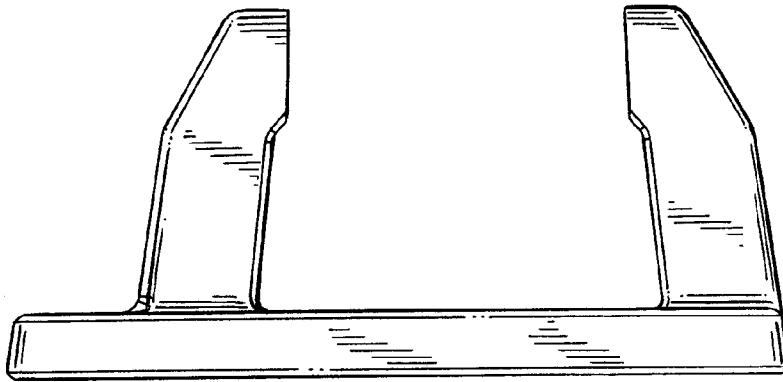

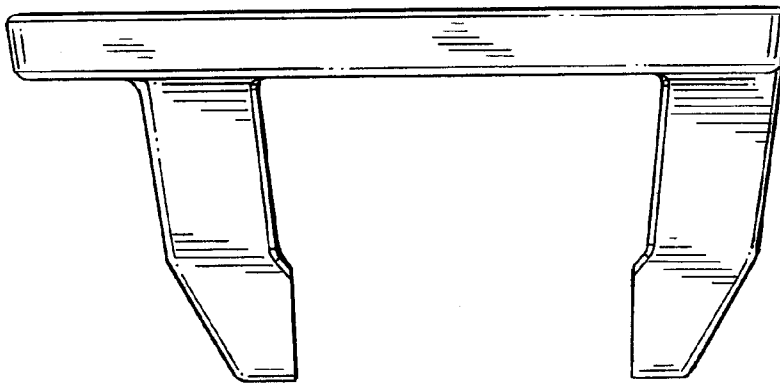
