(57) **CLAIM**

The ornamental design for a jig as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a jig;  
FIG. 2 is a back perspective view of the jig shown in FIG. 1;  
FIG. 3 is a front view of the jig shown in FIG. 1;  
FIG. 4 is a back view of the jig shown in FIG. 1;  
FIG. 5 is a right-side view of the jig shown in FIG. 1;  
FIG. 6 is a left-side view of the jig shown in FIG. 1;  
FIG. 7 is a first plane side view of the jig shown in FIG. 1;  
FIG. 8 is a second plane side view of the jig shown in FIG. 1; and,  
FIG. 9 is a cross-sectional view of the jig shown in FIG. 1 as seen through the plane along the line A-A in FIG. 3. The broken lines in the drawings illustrate portions of a jig which form no part of the claimed design.

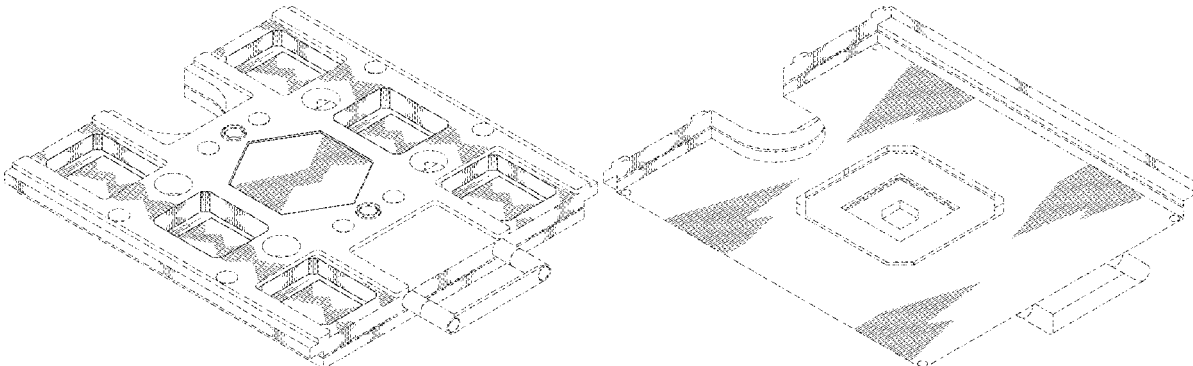

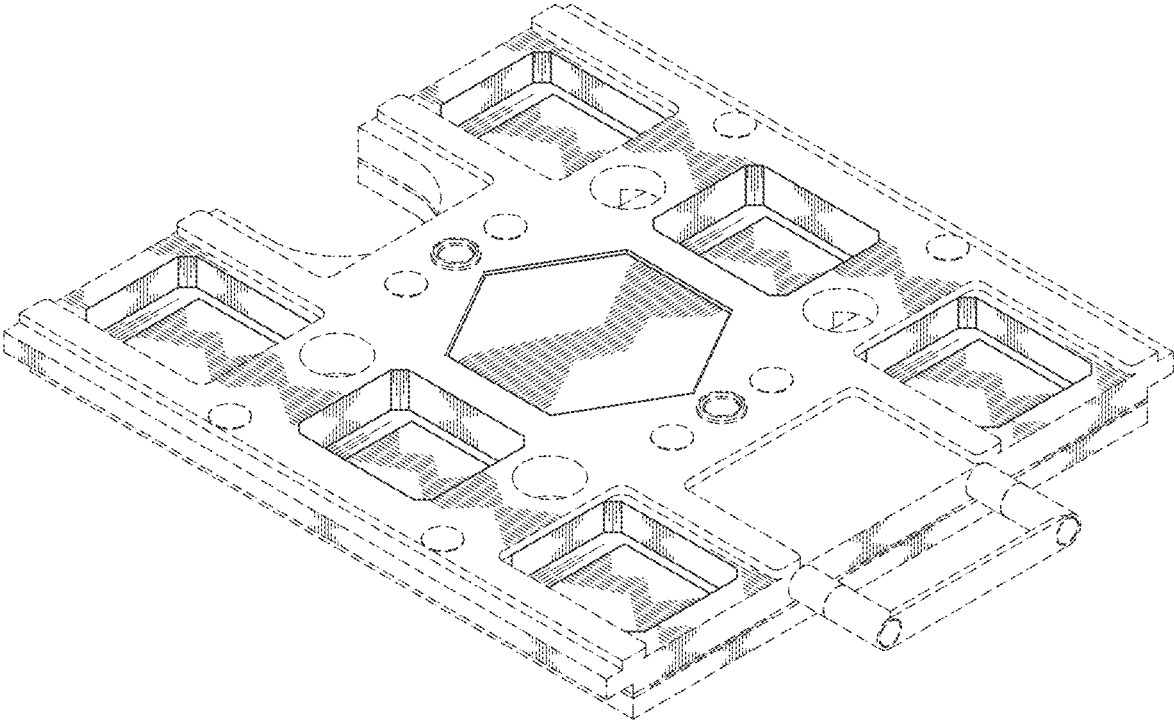

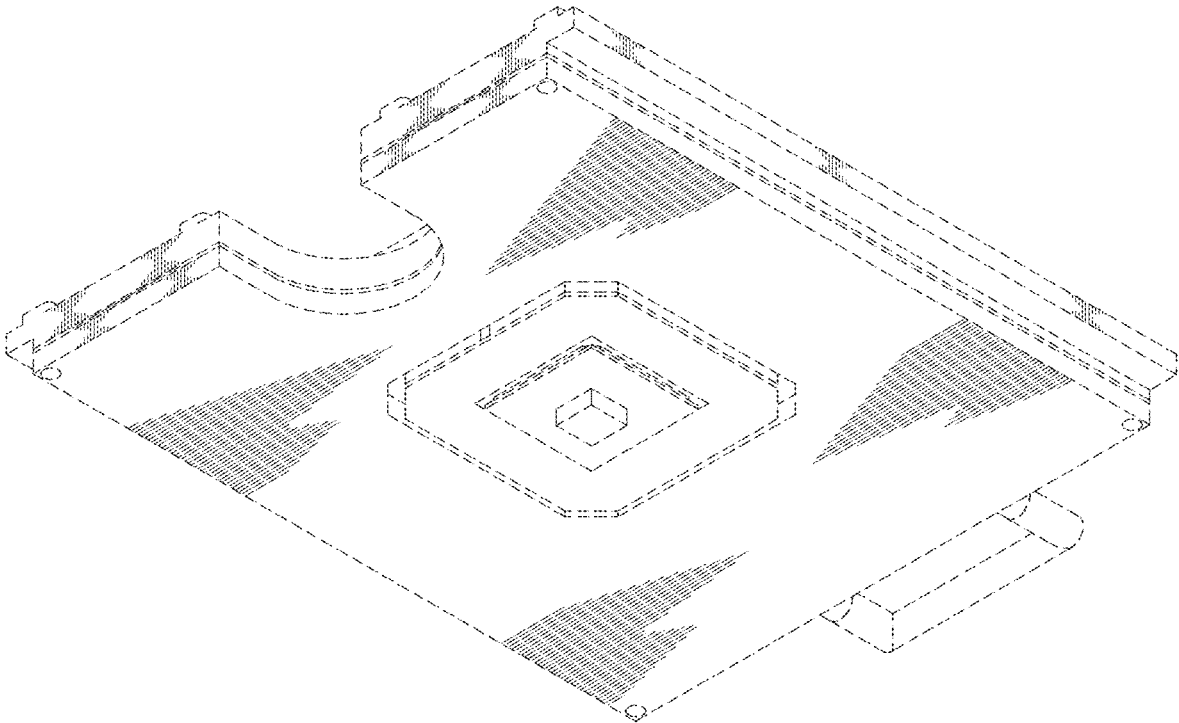

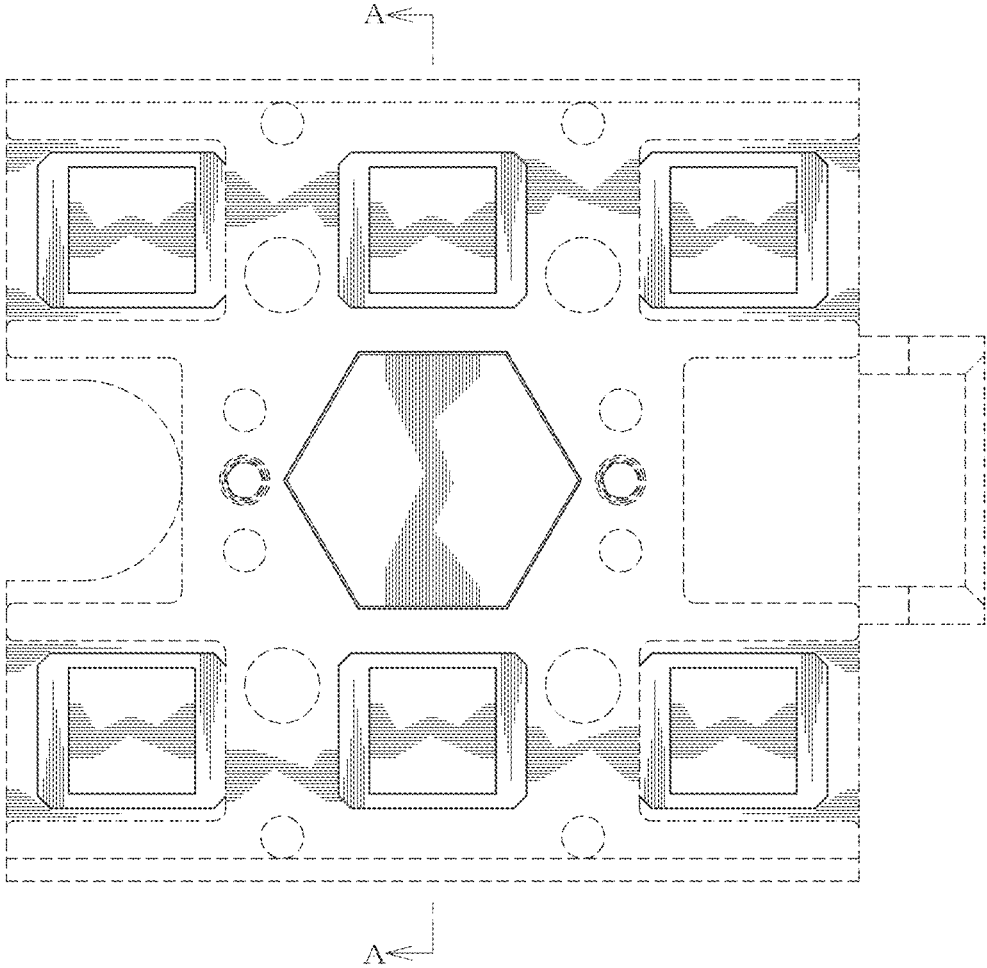

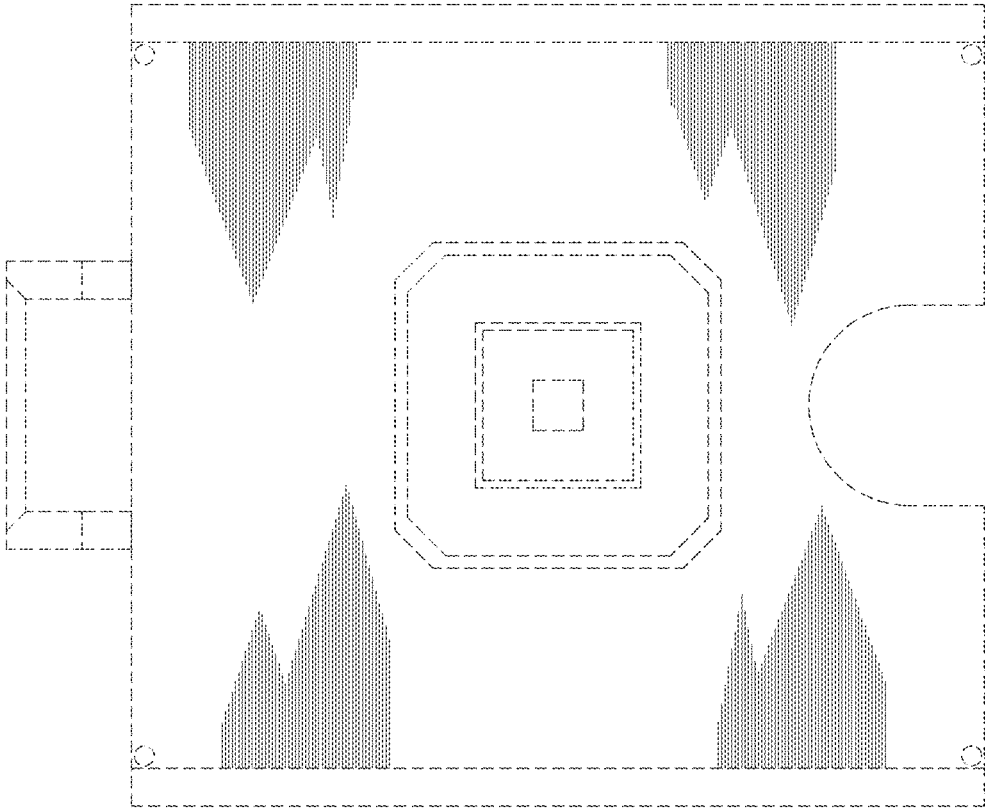

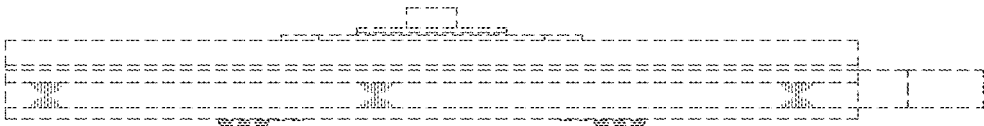

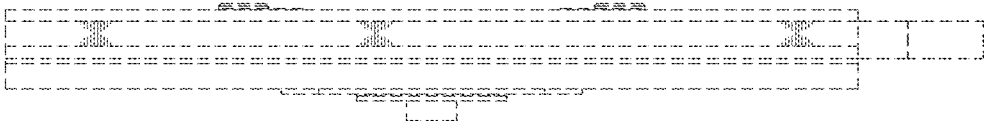
