(57) **CLAIM**

We claim, the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a bottle showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a side elevational view thereof;

FIG. 5 is the opposing side elevational view thereof; and,

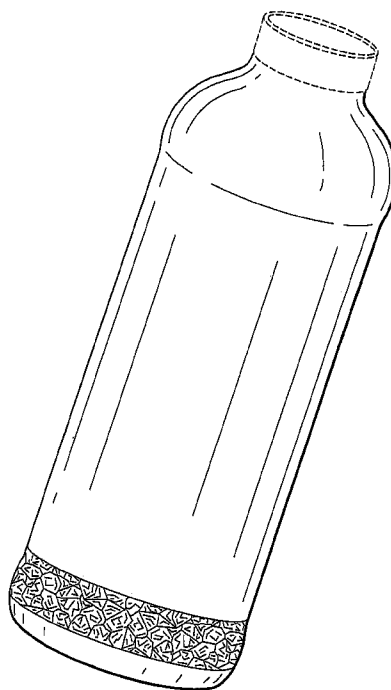

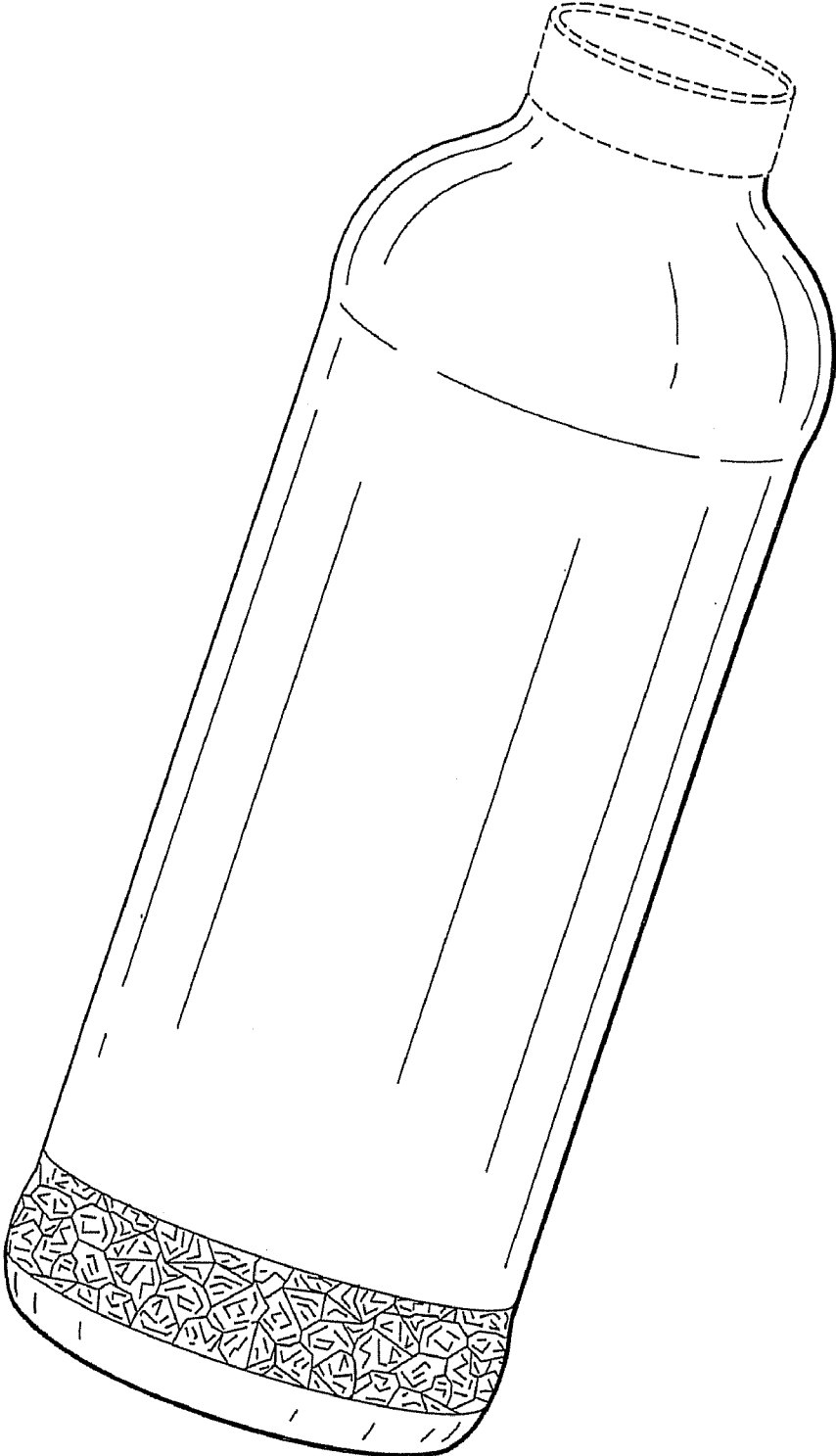

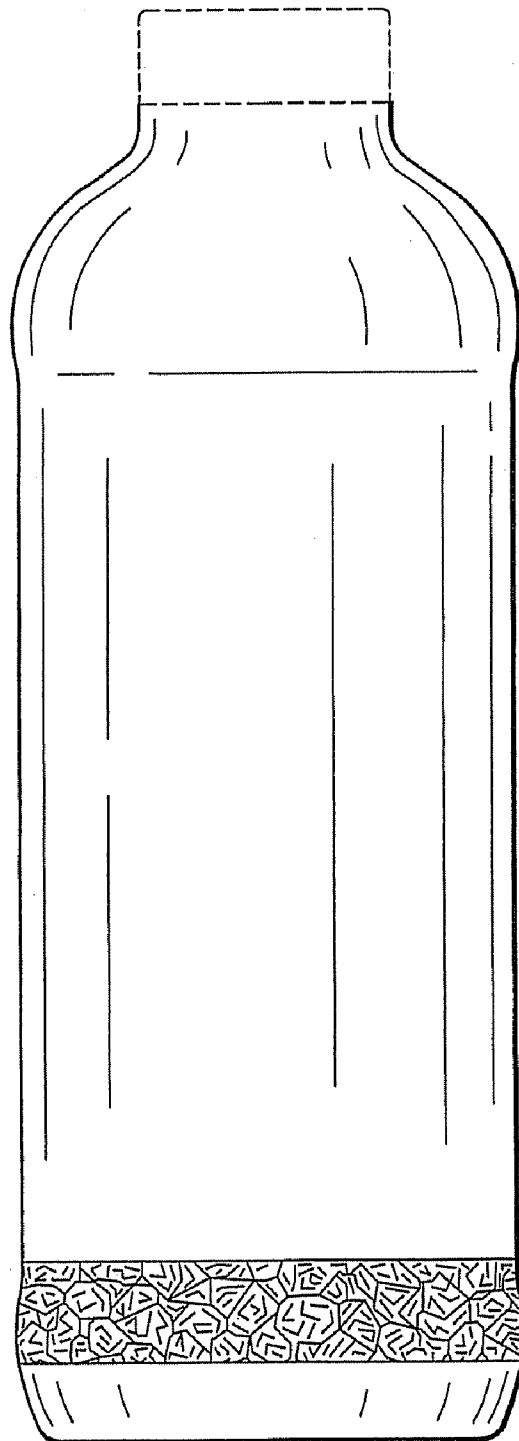

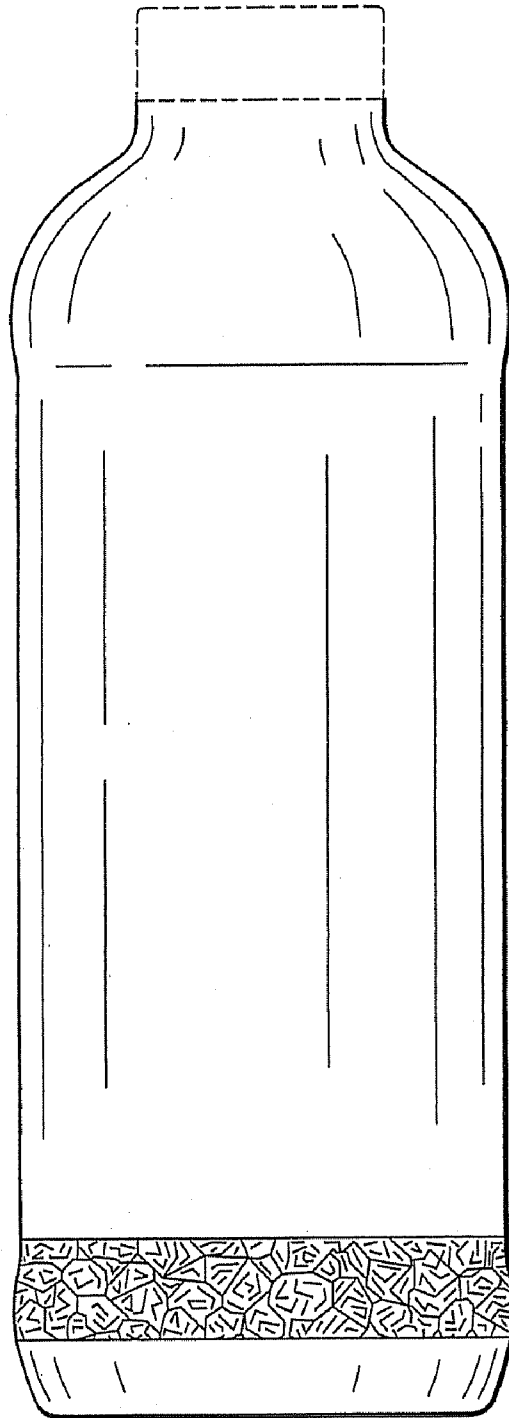

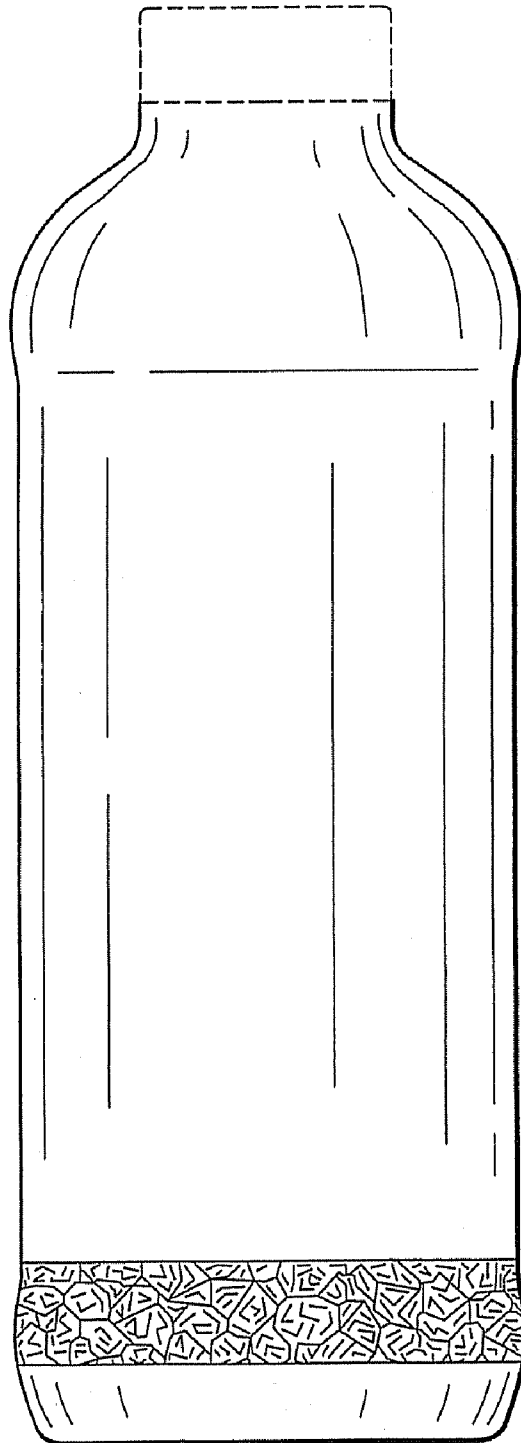

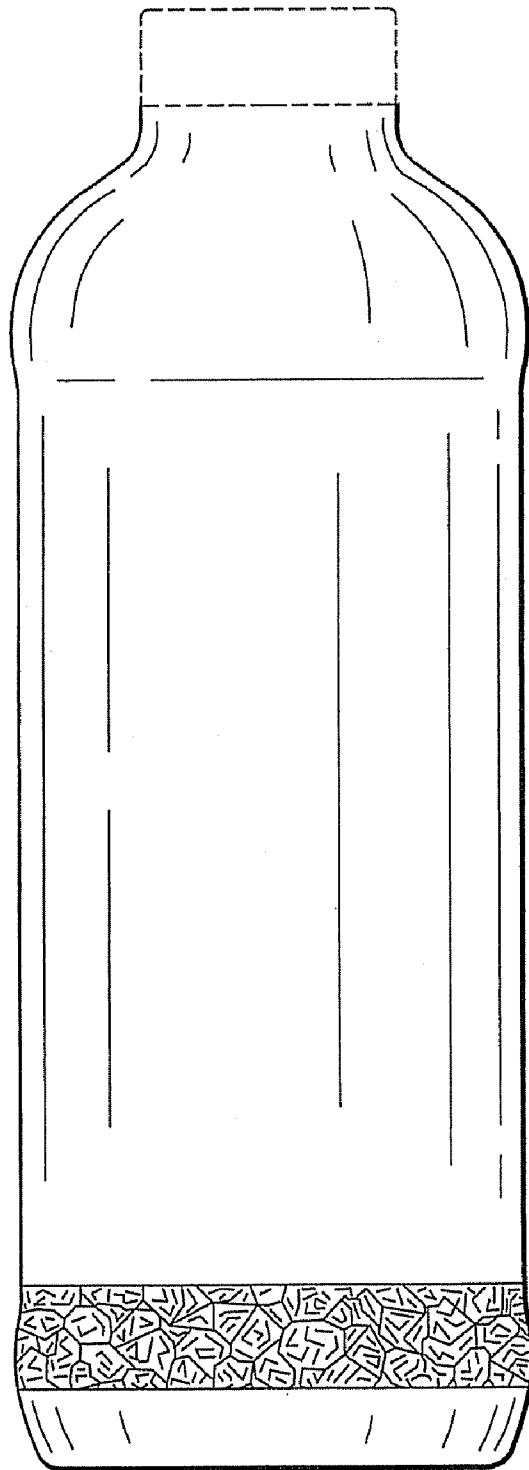
