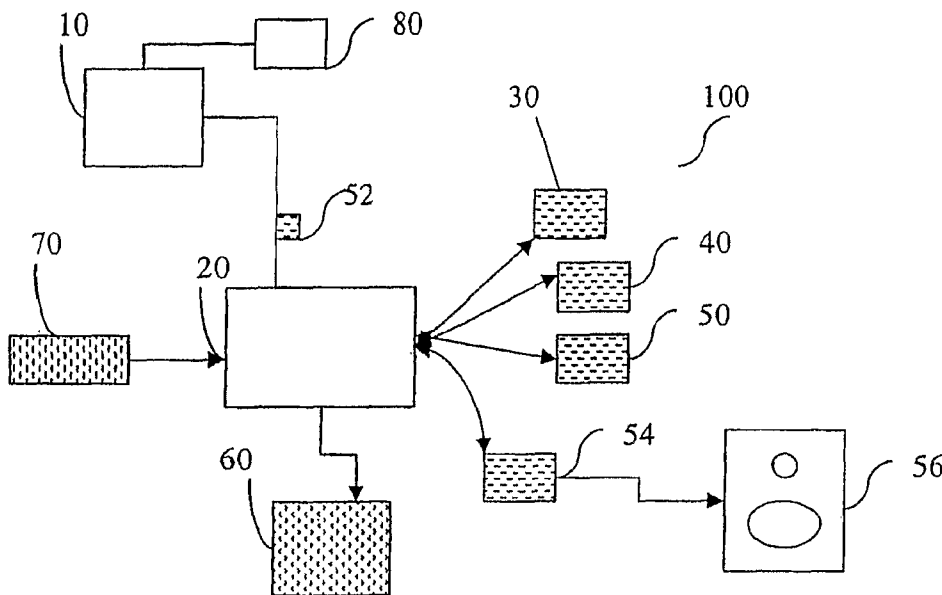

(54) Title: SYSTEM AND METHODS FOR UPDATING REGISTRATION INFORMATION FOR A COMPUTER JUKEBOX



(57) Abstract: Systems and methods for updating registration information for a computer jukebox are provided. The registration system and methods provide updated information for registration or authorization of a jukebox to a central computer after the occurrence of a pre-selected event (e.g., changing MAC address, changing the hard drive, memory, or Central Processing Unit (CPU)). The invention reduces or eliminates the need for the owner or operator of a jukebox to contact the owner or operator of the network in order to provide updated registration information following the occurrence of a pre-selected event.
