#### DESCRIPTION

FIG. 9 is an enlarged top right rear perspective view of the area in FIG. 3 indicated by the lines A and B in FIG. 3;

FIG. 10 is a top left front perspective view of a second embodiment of a cover for electronic communications device showing our new design;

FIG. 11 is a front view thereof;

FIG. 12 is a rear view thereof;





FIG.13 FIG.14

FIG. 13 is a left-side elevation view thereof;

FIG. 14 is a right-side elevation view thereof;

FIG. 15 is a top plan view thereof; and,

FIG. 16 is a bottom plan view thereof.



















