 FIG. 7 is a front view thereof.

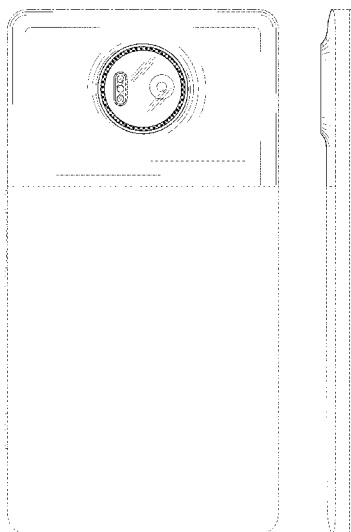

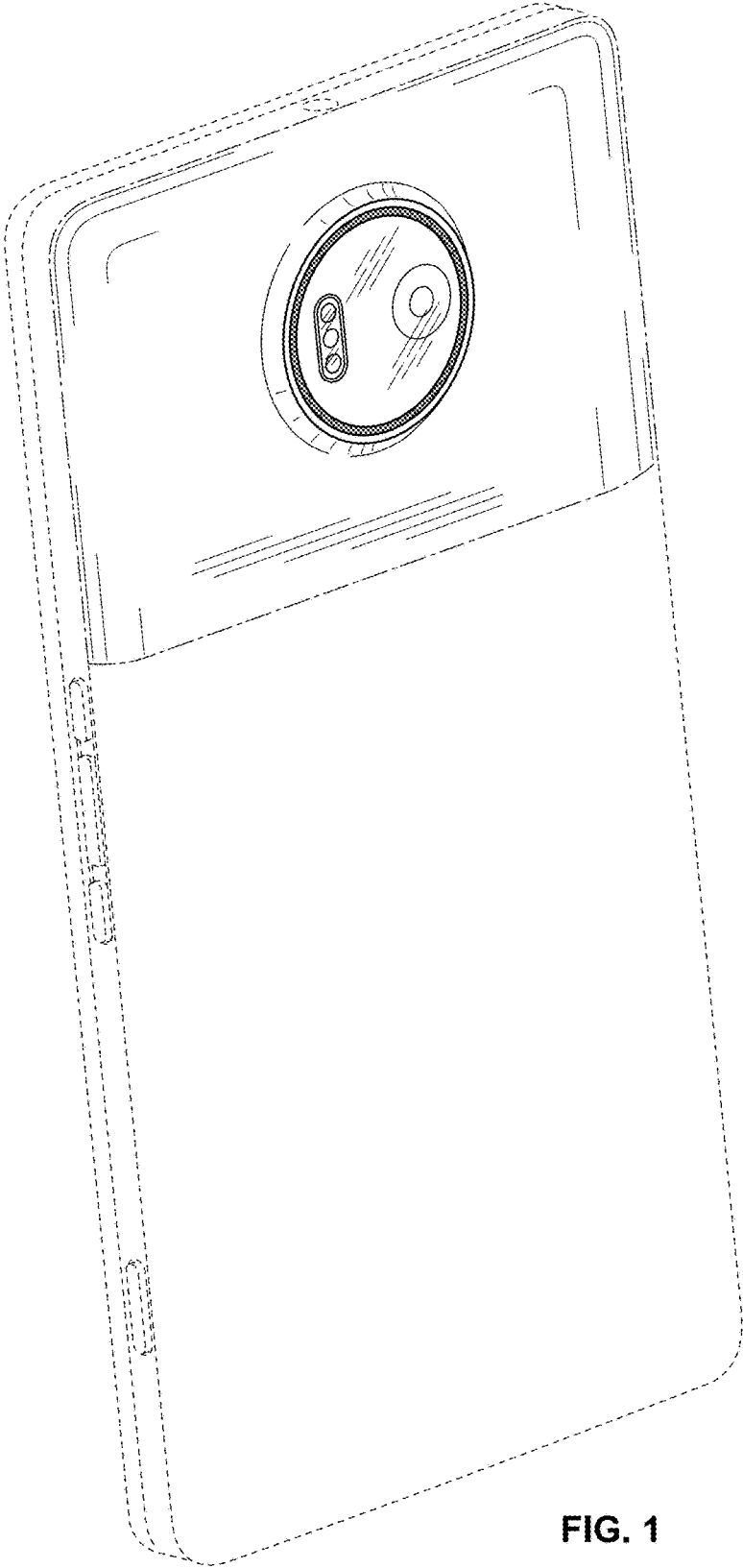

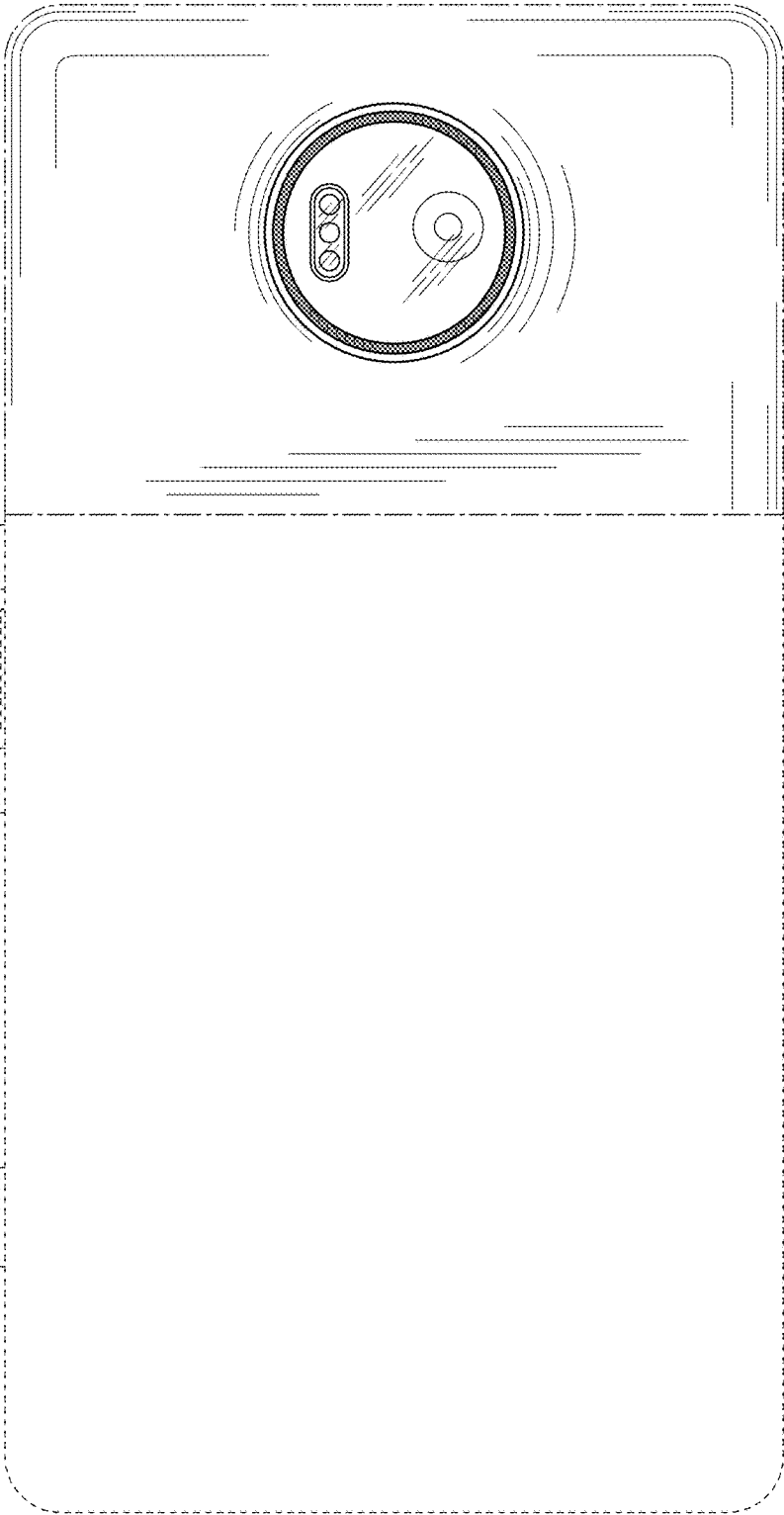

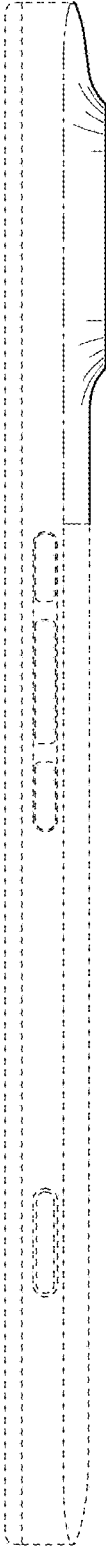

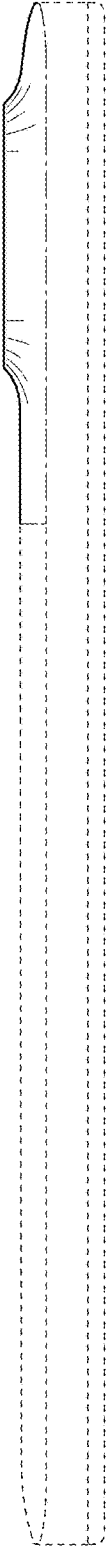

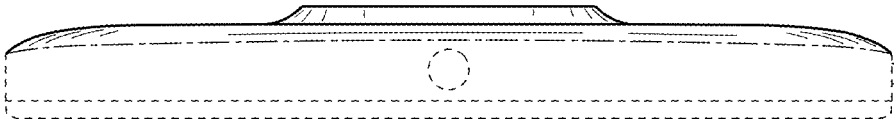

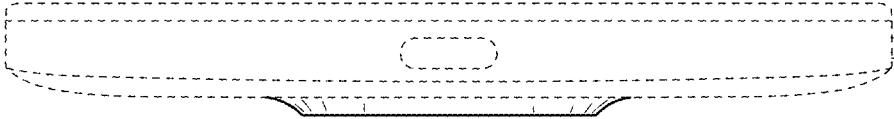

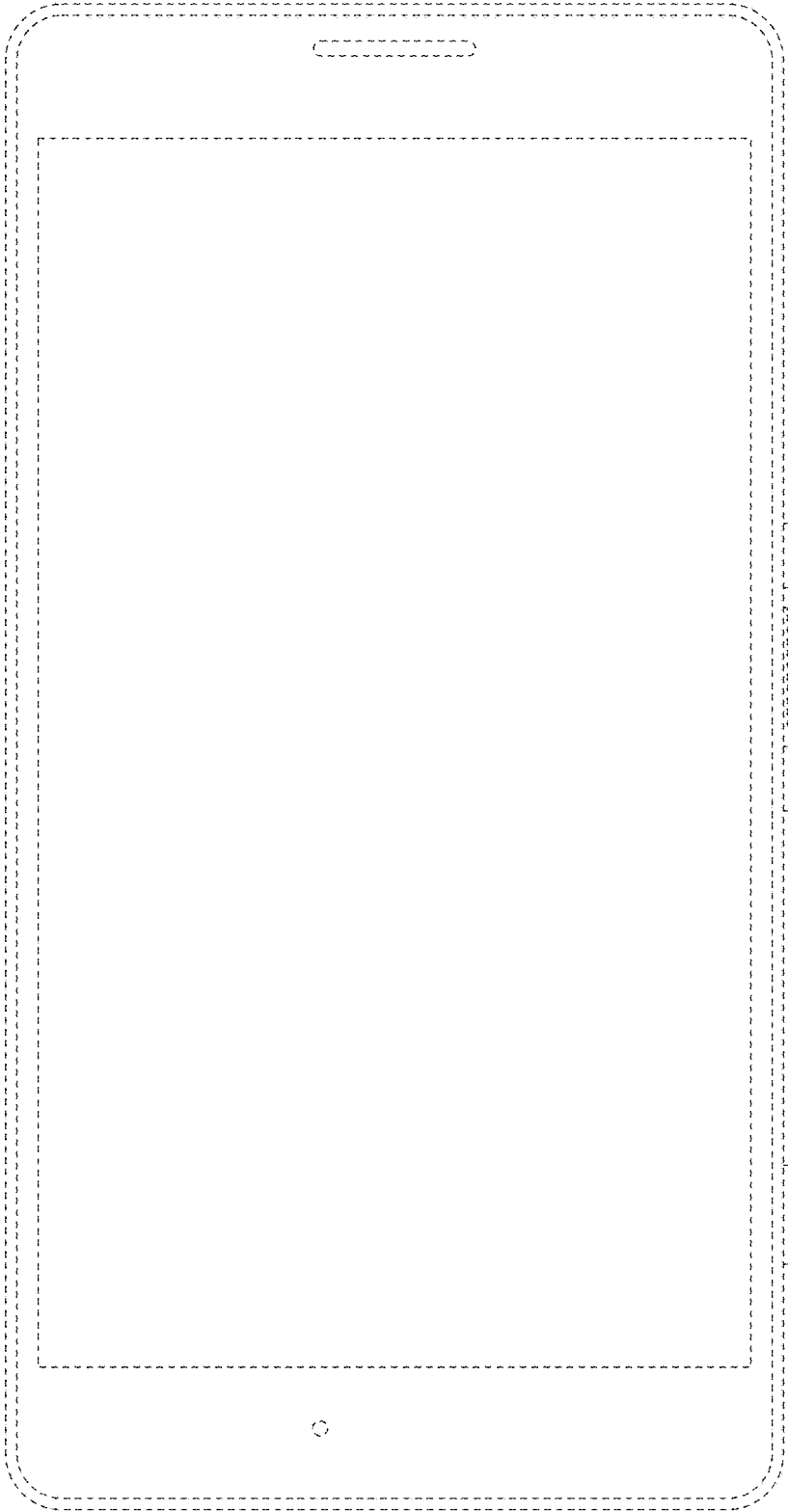
