**DESCRIPTION**

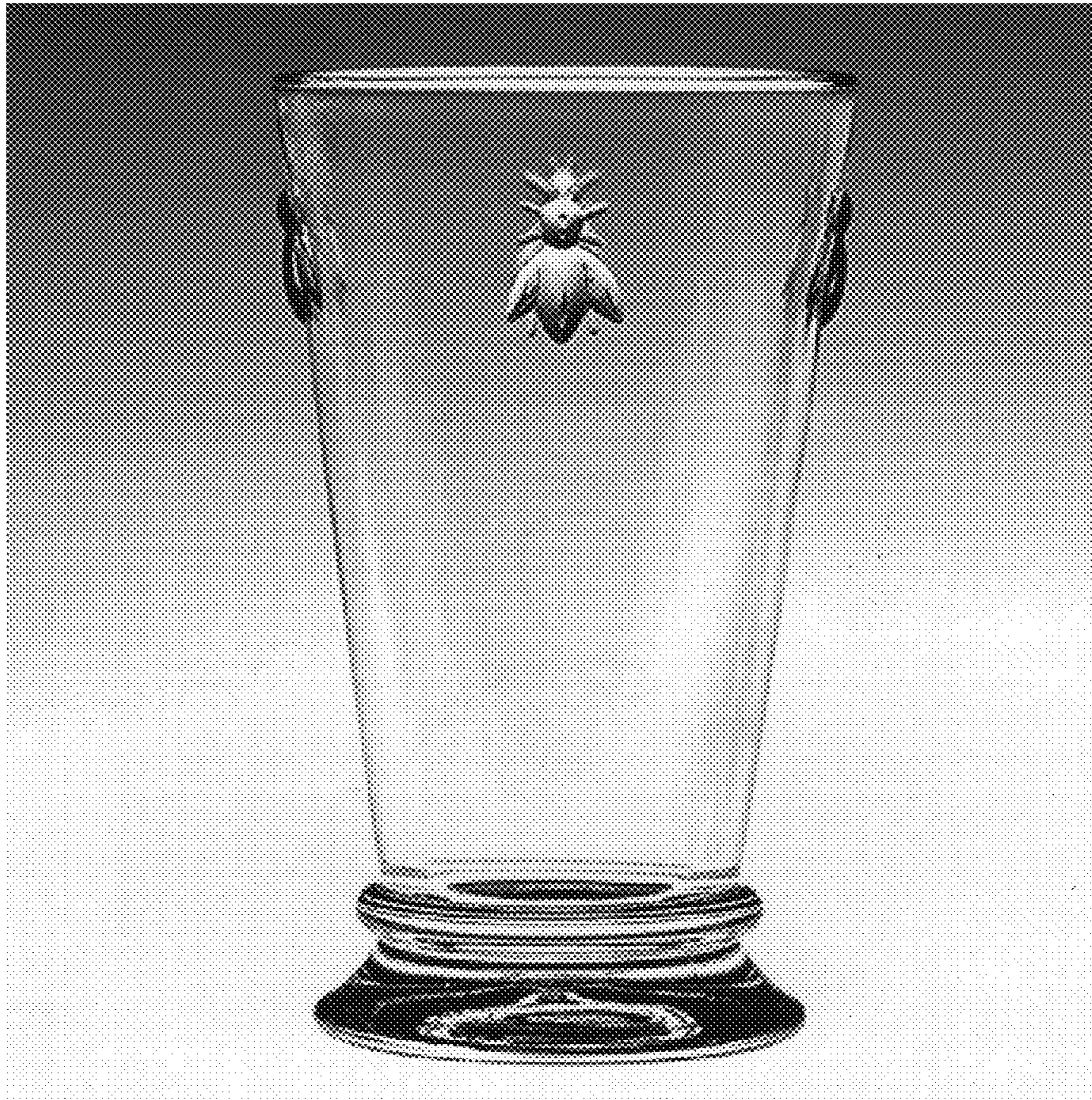
FIG. 1 is a perspective view of a drinking glass showing my new design;
