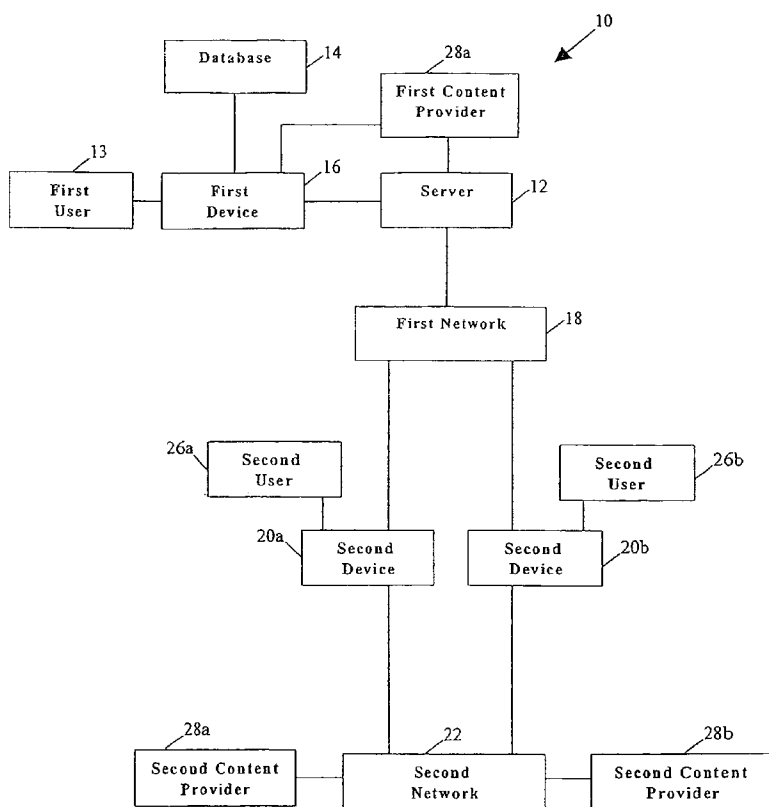

(54) Title: SYSTEM AND METHOD FOR SHARING AN EXPERIENCE WITH MEDIA CONTENT BETWEEN MULTIPLE DEVICES



(57) Abstract: A system and a method share an experience with media content between multiple devices for providing access to electronic program guide information and/or multimedia metadata of the media content. Users share and/or view the electronic program guide information and/or the multimedia metadata associated with the media content by transferring and/or by publishing the electronic program guide information and/or the multimedia metadata via one or more networks. Two or more participating devices establish a connection. via one or more networks for a sending device to transfer the electronic program guide information and/or the multimedia metadata to one or more receiving devices via one or more networks. The electronic program guide information and/or the multimedia metadata has communications and/or comments associated with consumption of the media content. The receiving devices consume the digital multimedia file for users of the receiving- devices to share in an experience of the media content with a user of the sending device.

The users of the sending device and/or

of the receiving devices discuss and/or comment on the experience of the media content through an asynchronous message or a communication channel in real time.
