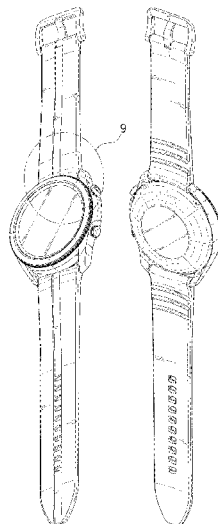
(57) **CLAIM**

I claim the ornamental design for a smart watch, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a smart watch showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a rear perspective view thereof;
FIG. 9 is an enlarged view of the encircled portion in FIG. 1;
FIG. 10 is an enlarged view of the encircled portion in FIG. 4;
FIG. 11 is an enlarged view of the encircled portion in FIG. 5;
FIG. 12 is an enlarged view of FIG. 6; and,
FIG. 13 is an enlarged view of FIG. 7.
The evenly-dashed broken lines in the drawings depict portions of the smart watch that form no part of the claimed design.
The dot-dot-dash broken lines encircling portions of the claimed design in FIGS. 1, 4, 5 and 9-11 are included to show a partially enlarged view only and form no part of the claimed design.

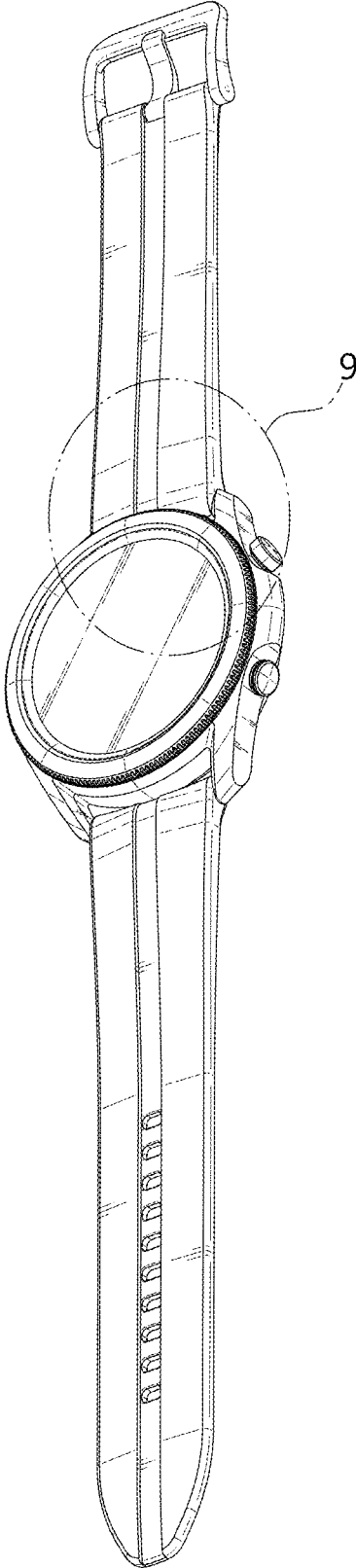

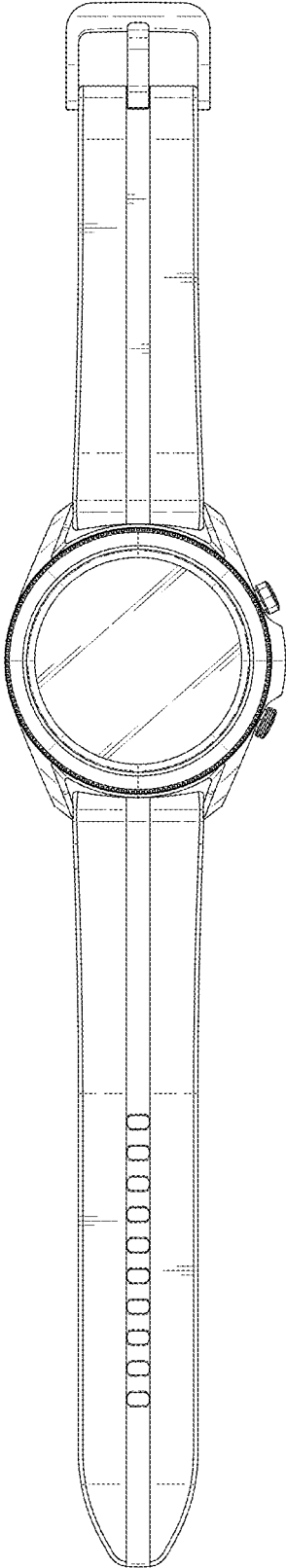

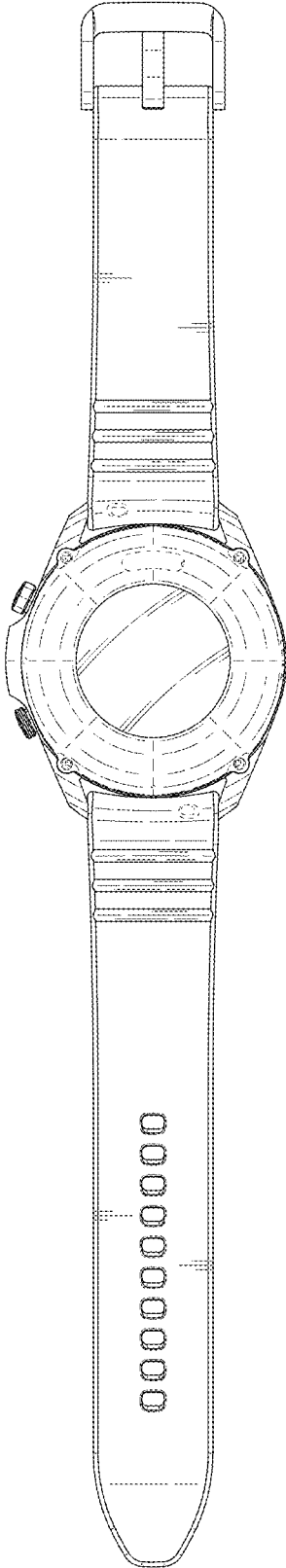

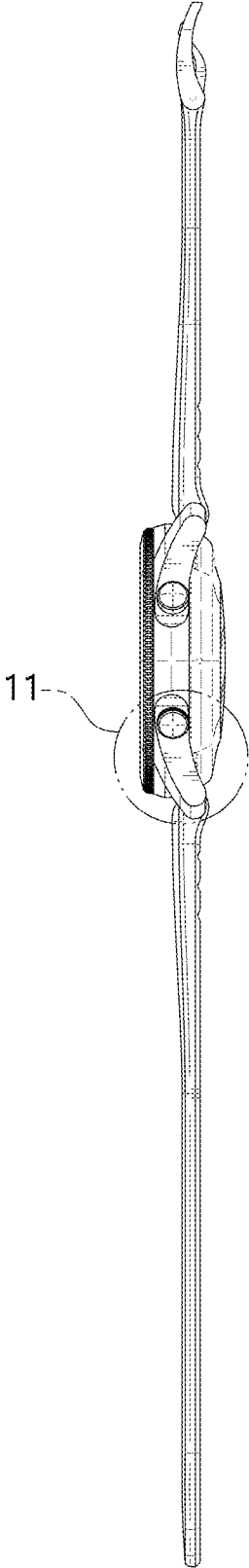
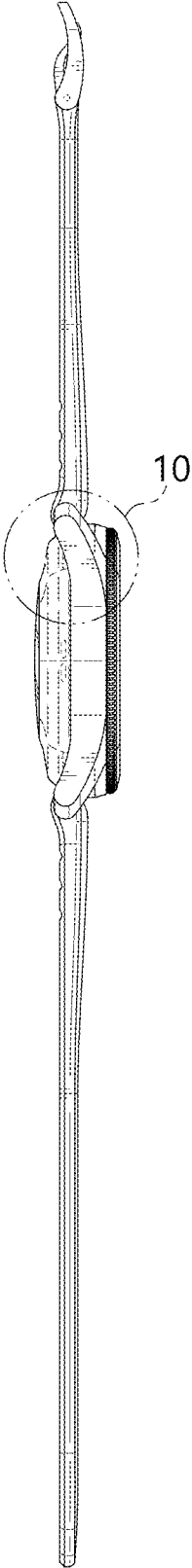

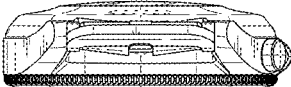

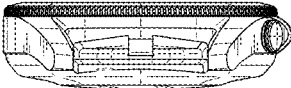

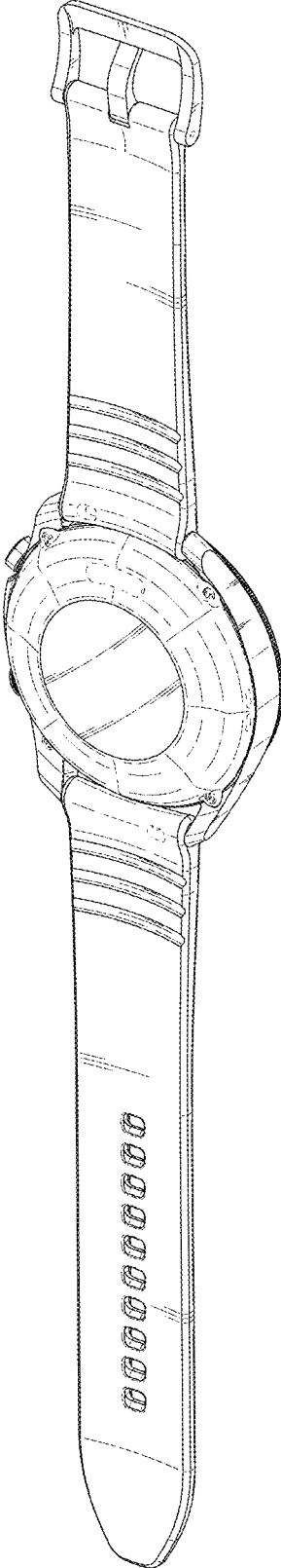

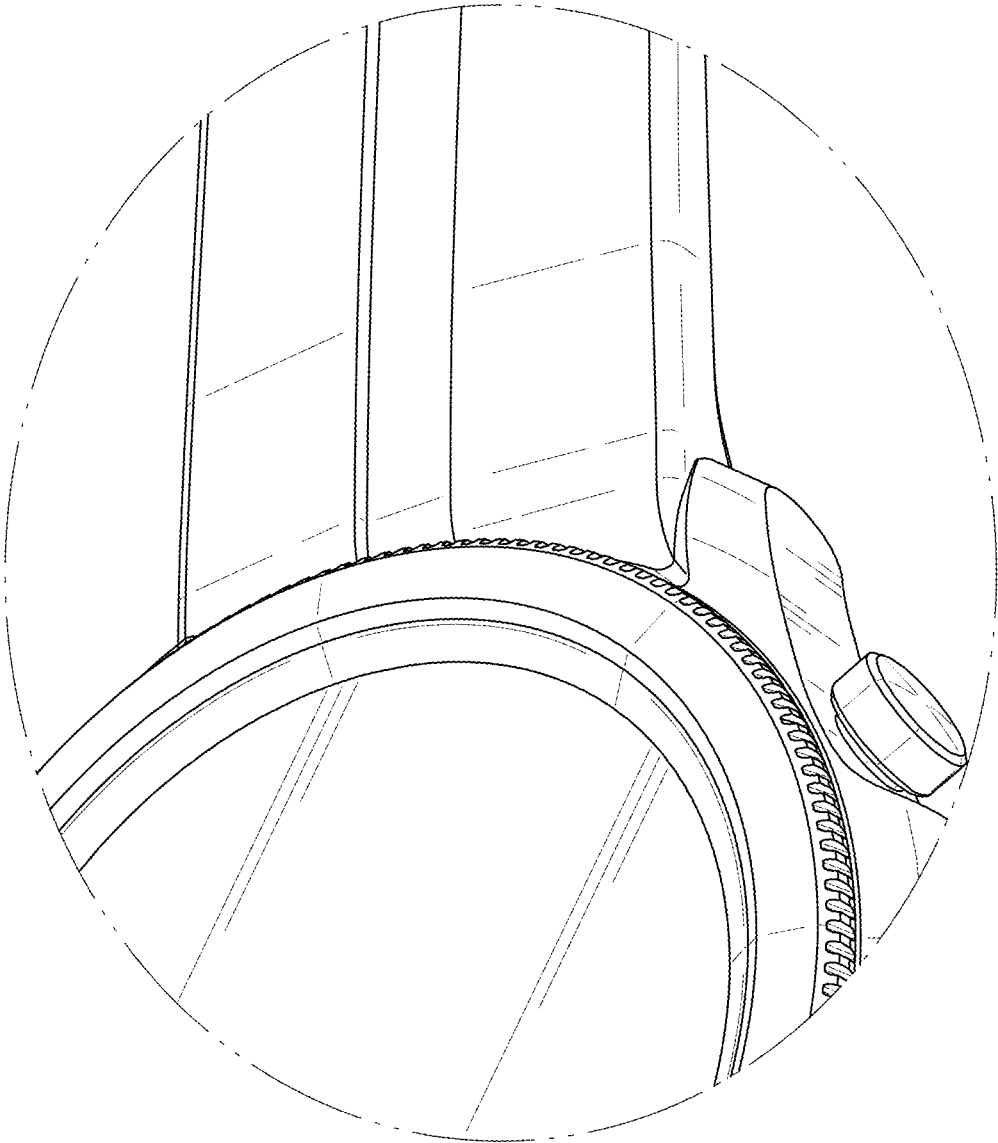

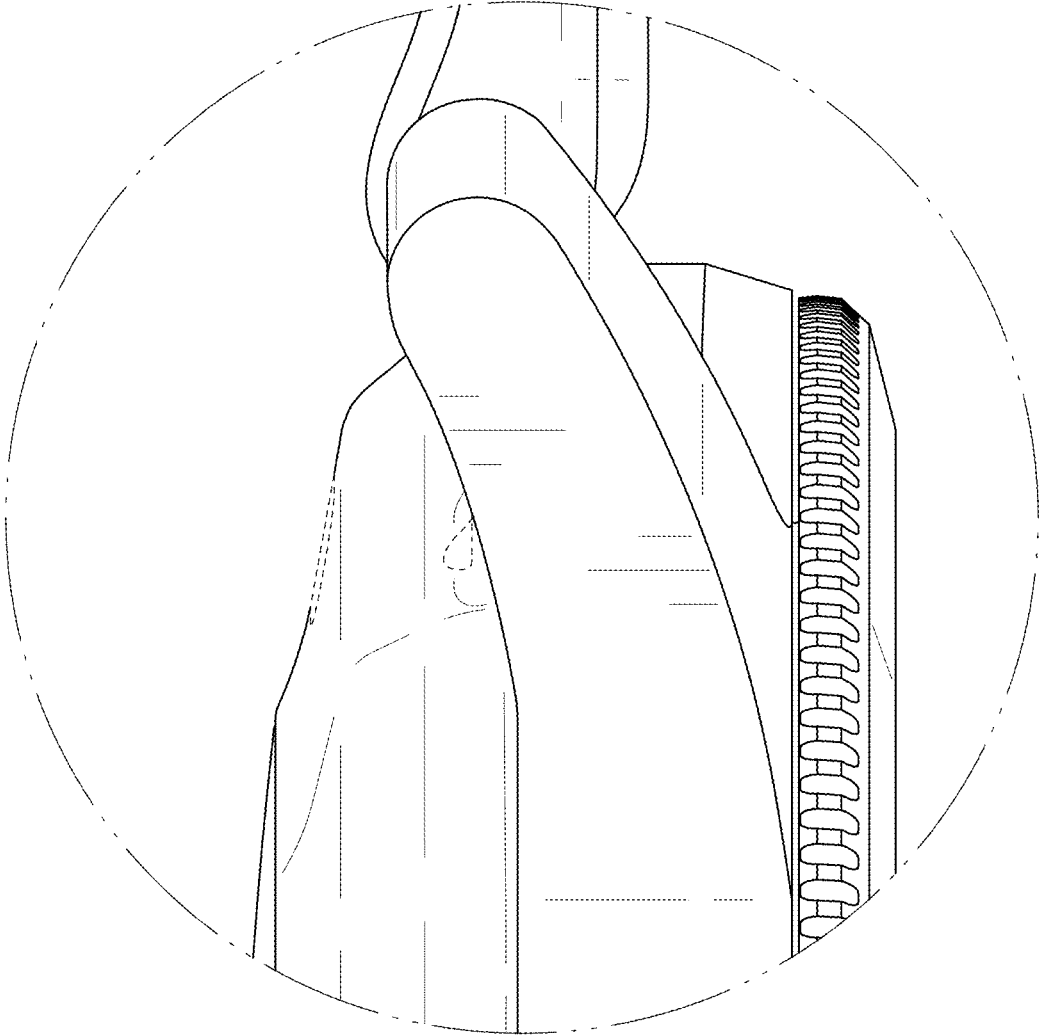

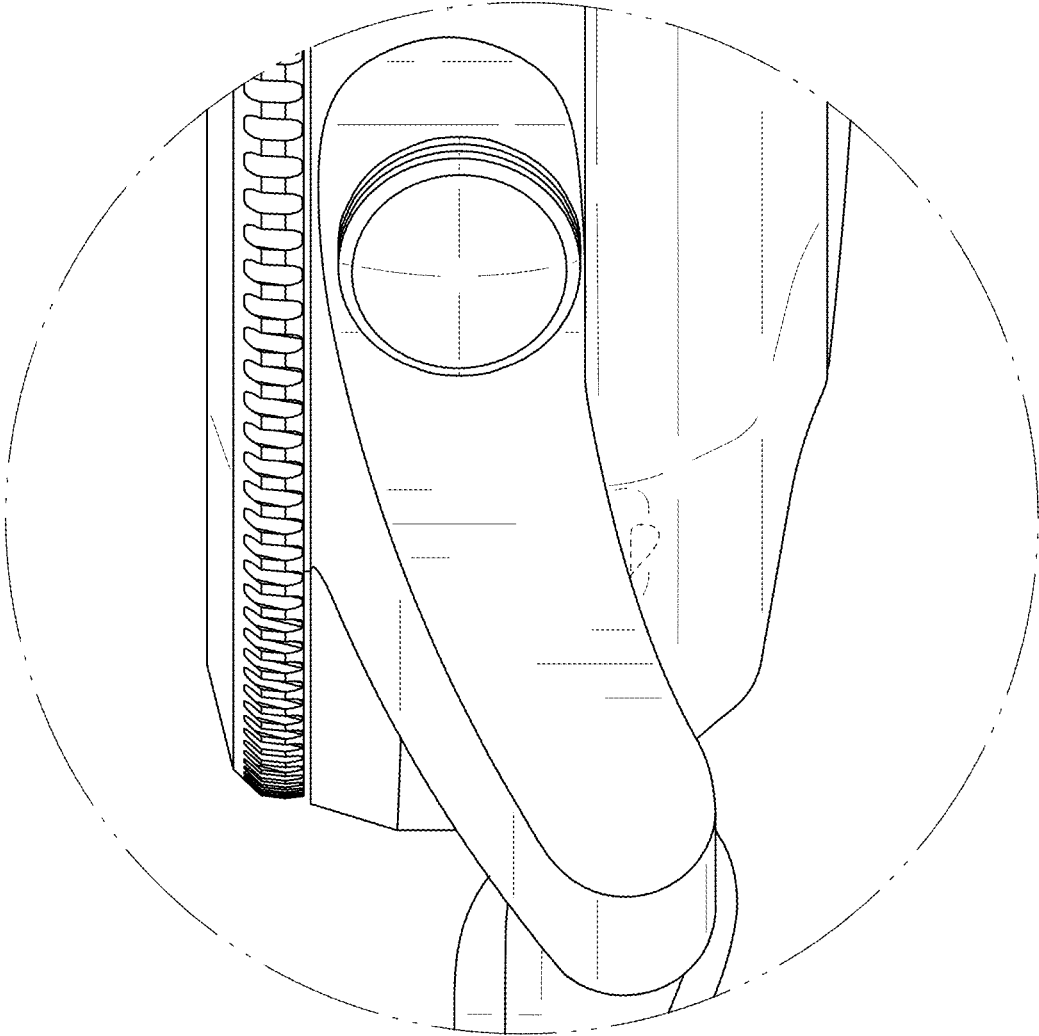

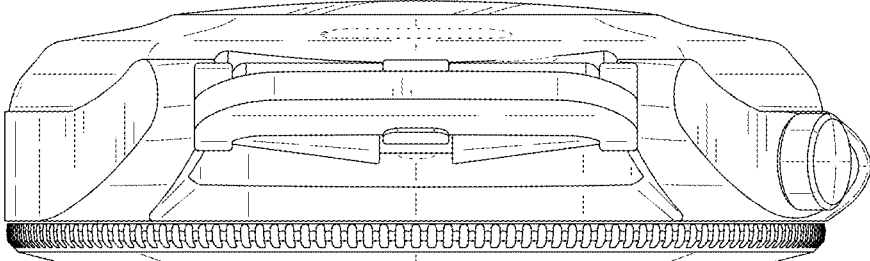
