(57) **CLAIM**

The ornamental design for a radiation irradiator for particle beam treatment equipment, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and left side perspective view of a radiation irradiator for particle beam treatment equipment, showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a left side view thereof; and,

FIG. 7 is a right side view thereof.

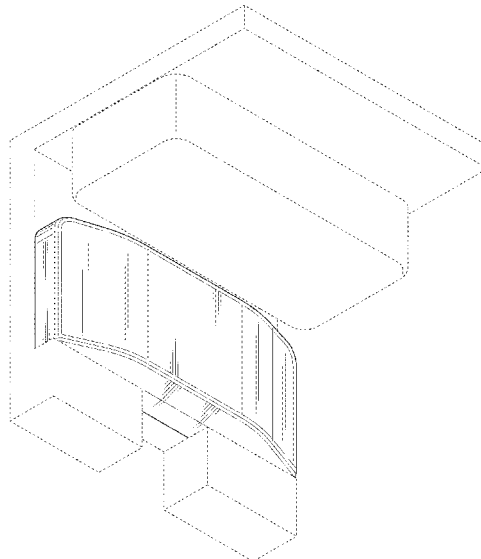

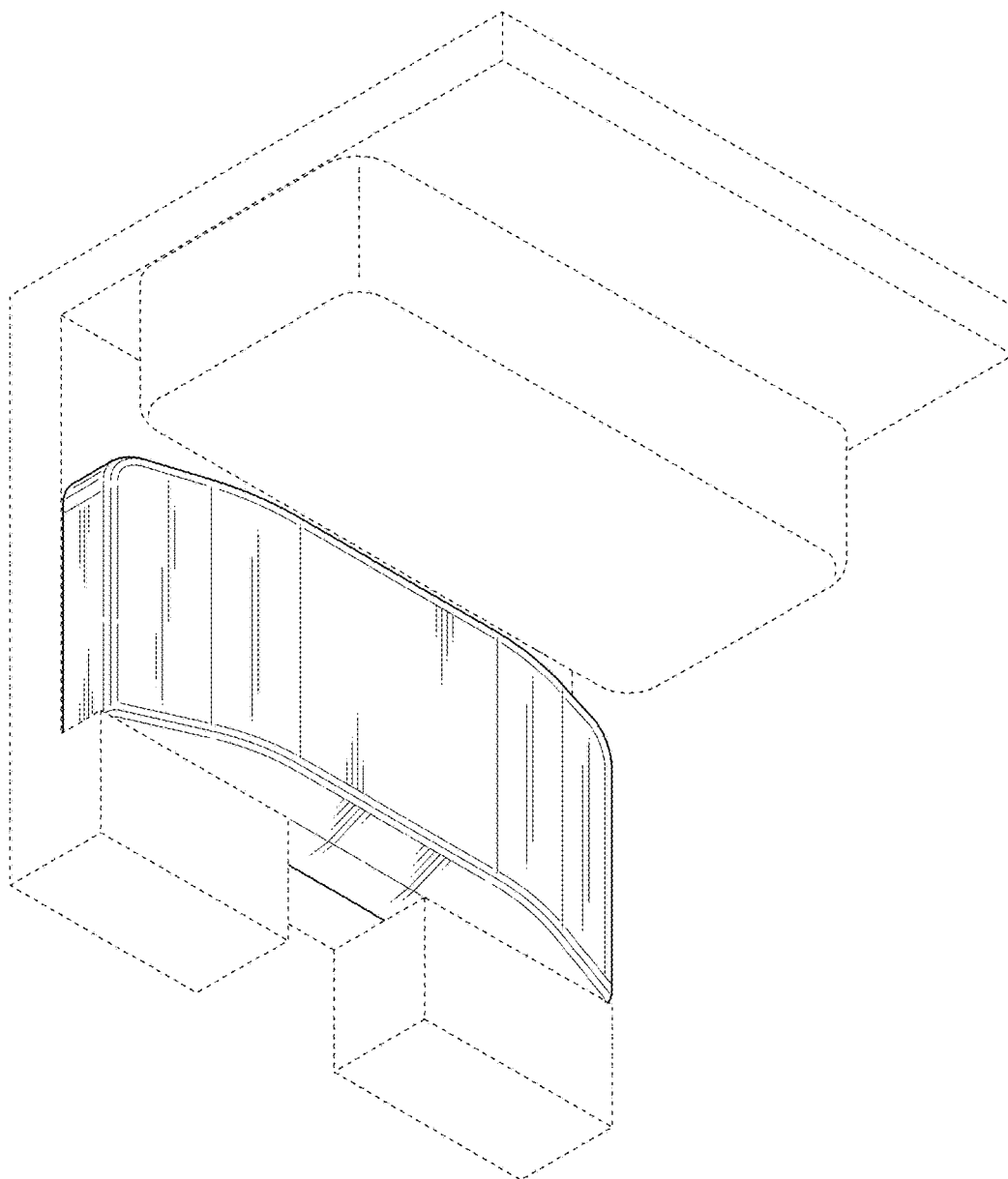

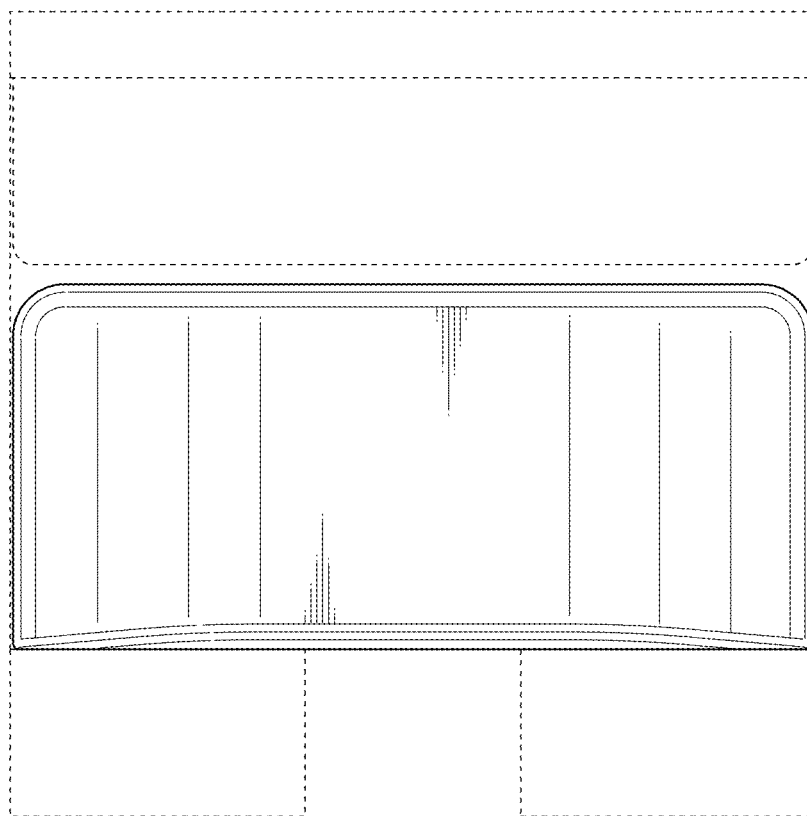

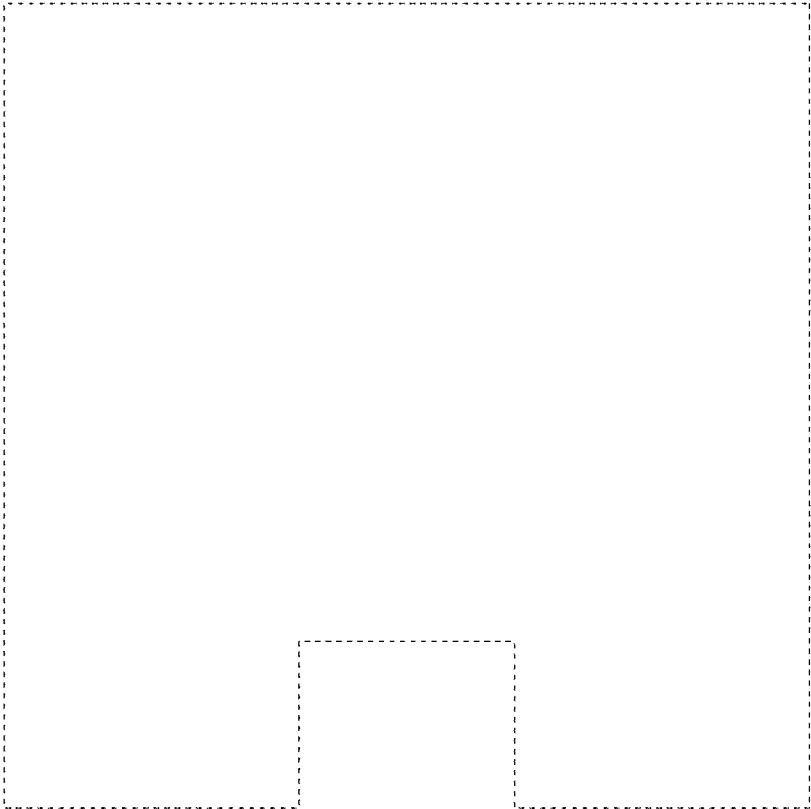

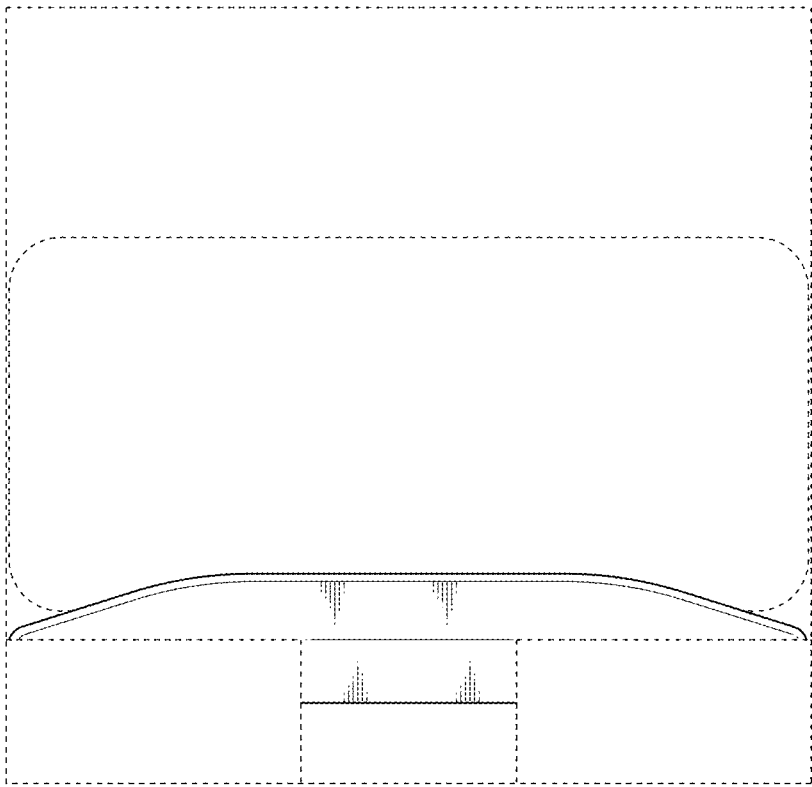

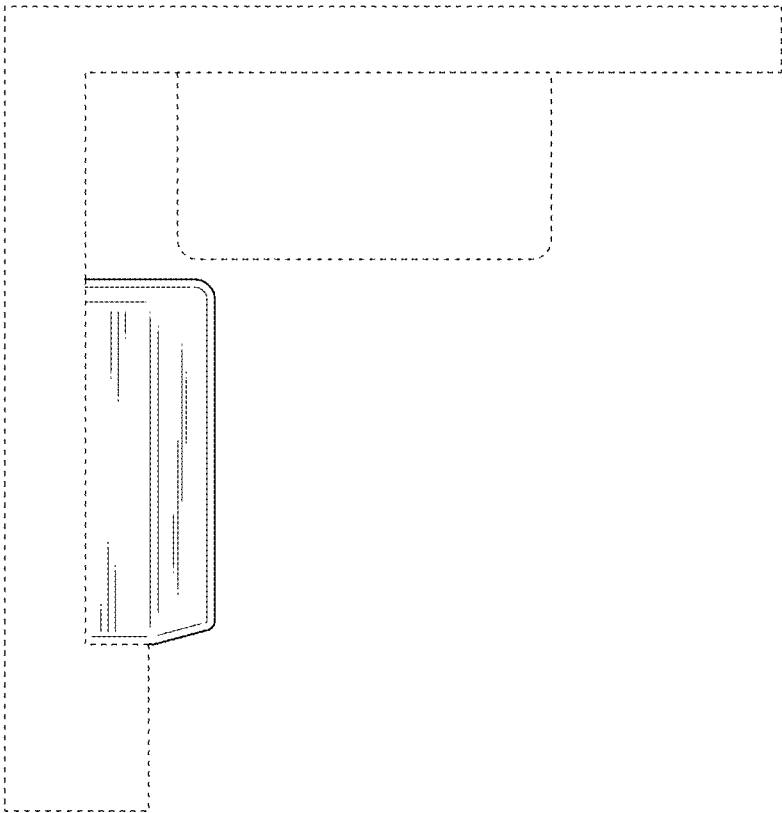
