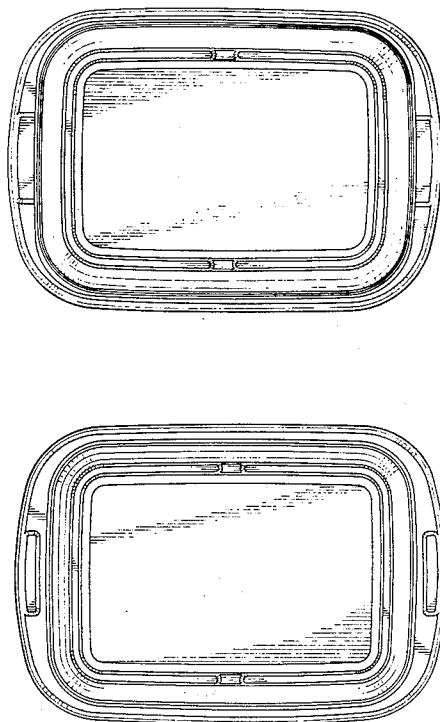
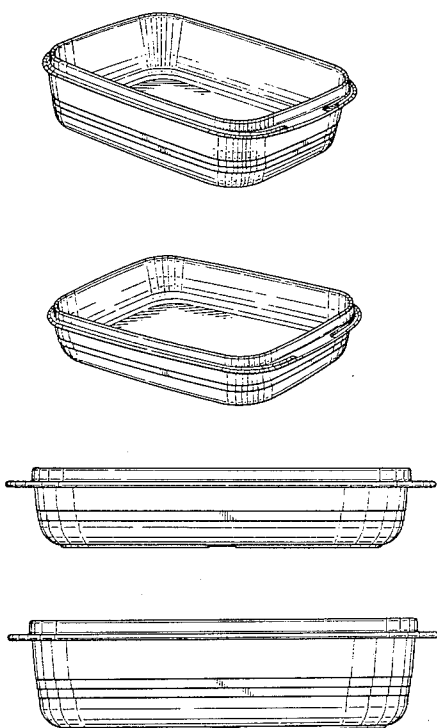

[57] CLAIM

The ornamental design for a casserole dish or the like, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a casserole dish or the like showing our new design;  
FIG. 2 is a side elevation of FIG. 1, the opposite side being identical thereto;  
FIG. 3 is an end elevation of FIG. 1, the opposite end being identical thereto;  
FIG. 4 is a top plan view of FIG. 1, it being understood that the size and proportions of the top plan view of FIG. 6 are identical hereto;  
FIG. 5 is a bottom plan view of FIG. 1;  
FIG. 6 is a top perspective view of a modification of the casserole dish of FIG. 1;  
FIG. 7 is a side elevation of FIG. 6, the opposite side being identical thereto;  
FIG. 8 is an end elevation of FIG. 6, the opposite end being identical thereto;  
FIG. 9 is a bottom plan view of FIG. 6;  
FIG. 10 is a cross-sectional view taken along line 10—10 of FIG. 4.



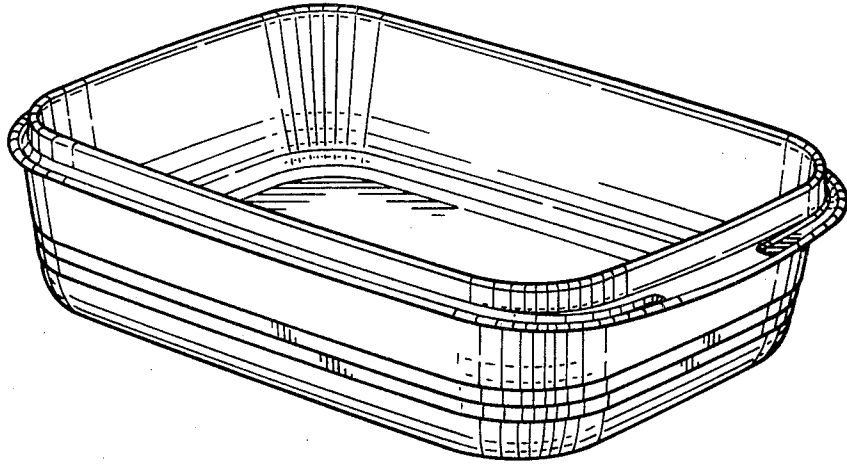

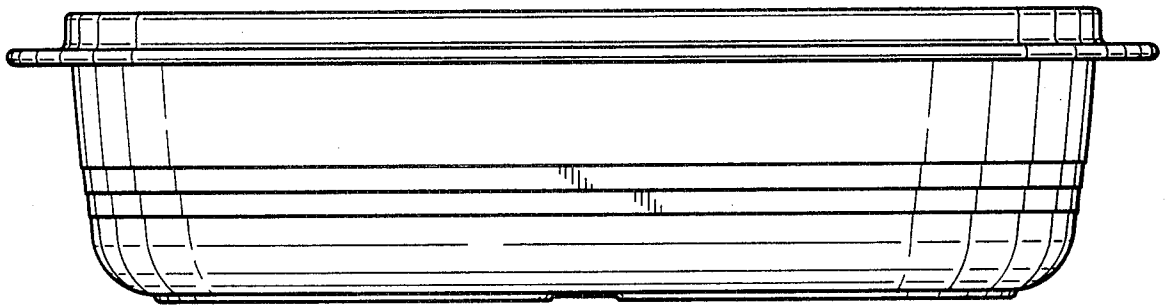

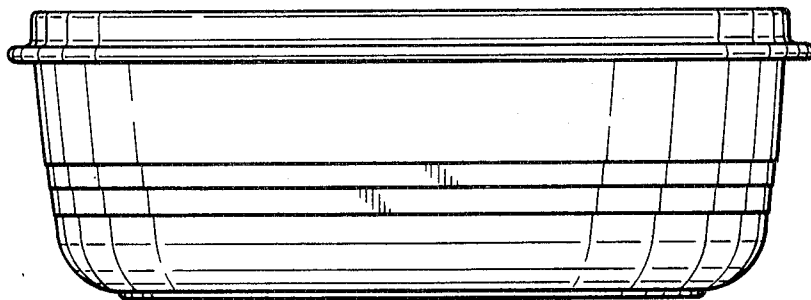

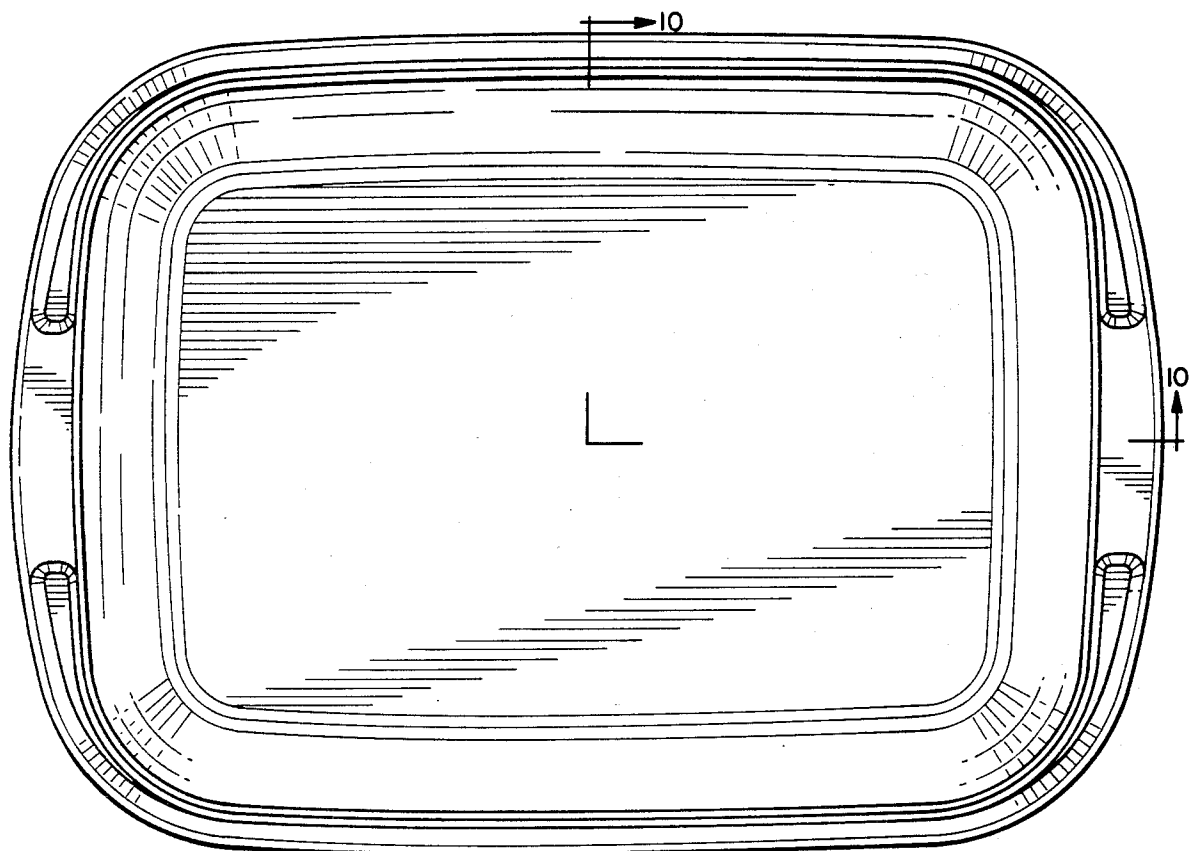

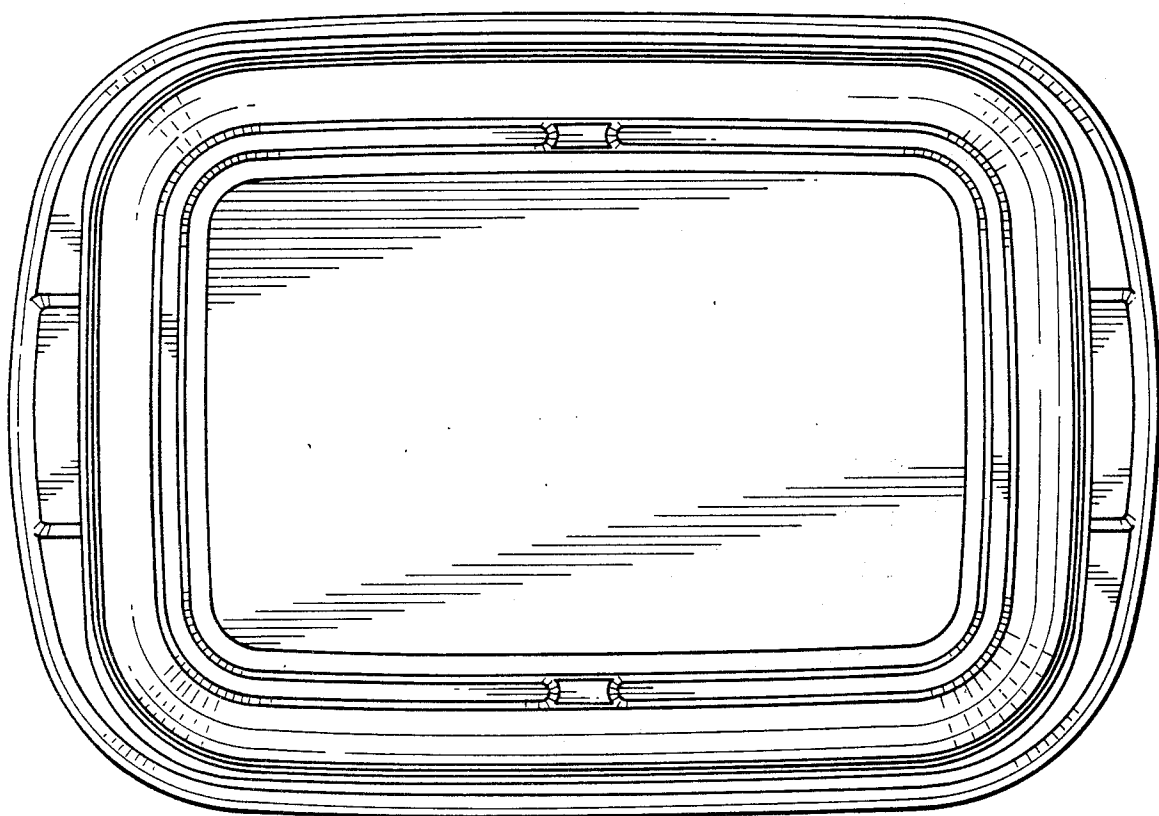

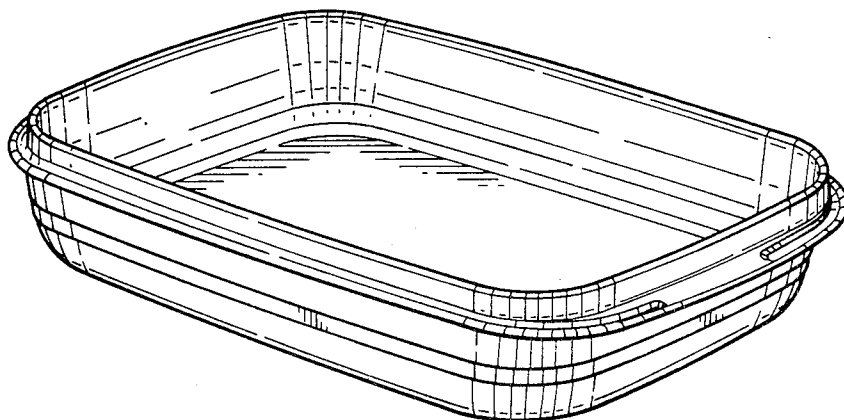

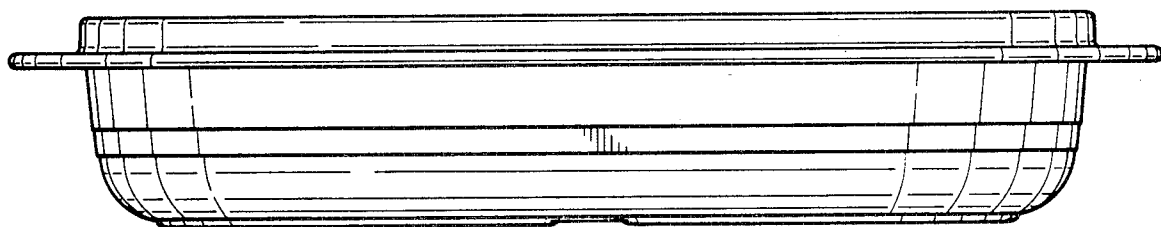

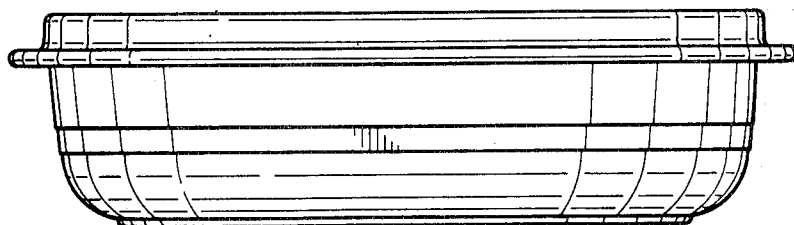

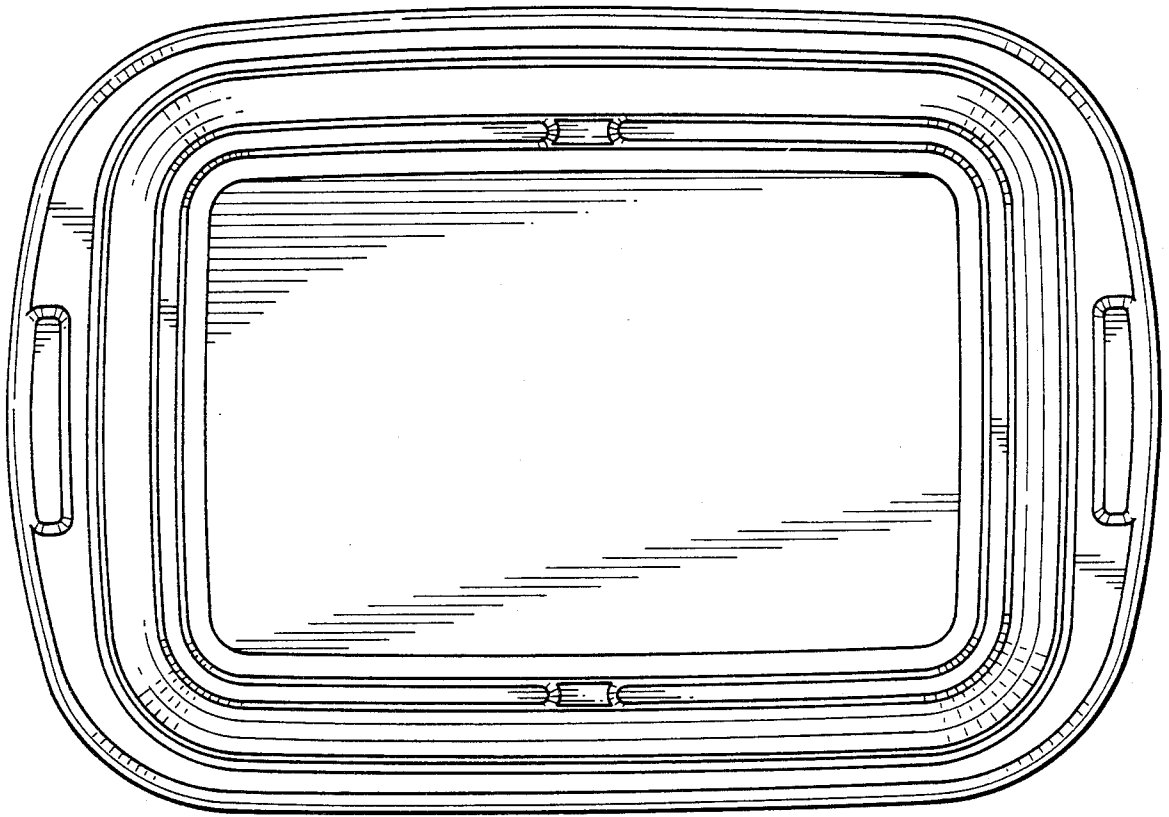

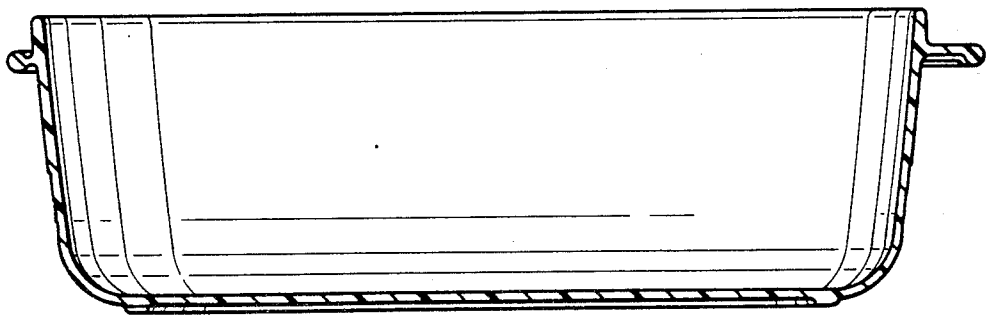
