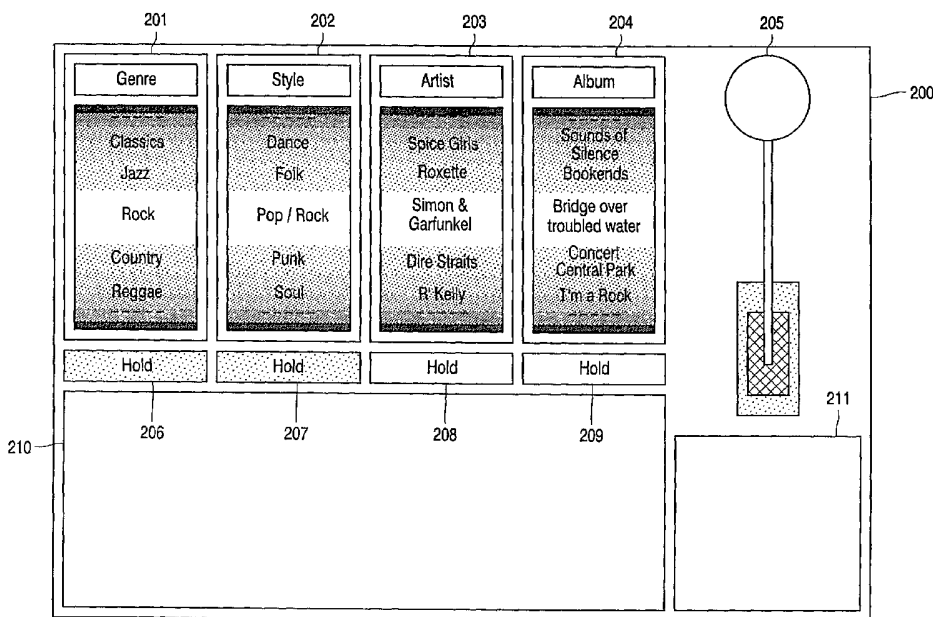

(54) Title: SYSTEM FOR BROWSING A COLLECTION OF INFORMATION UNITS



(57) Abstract: The invention relates to a system for browsing a collection of information units, such as audio or video files, comprising presentation means for presenting an information unit from said collection, and attribute means for associating a respective information unit with an attribute value for at least a first attribute. The system according to the invention randomly selects information units which meet certain criteria for said first attribute.
