(57) **CLAIM**

The ornamental design for a lite for entry systems, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation of a first embodiment of a lite for entry systems, the opposite side being a mirror image; FIG. 2 is a front elevation of a second embodiment of a lite for entry systems, the opposite side being a mirror image; FIG. 3 is a front elevation of a third embodiment of a lite for entry systems, the opposite side being a mirror image; and, FIG. 4 is a front elevation of a fourth embodiment of a lite for entry systems, the opposite side being a mirror image. The broken lines which define the bounds of the claimed design form no part of the claimed design.








