FIG. 1 is a front view of a portable electric dryer showing my new design; the rear view being identical to the front view thereof;

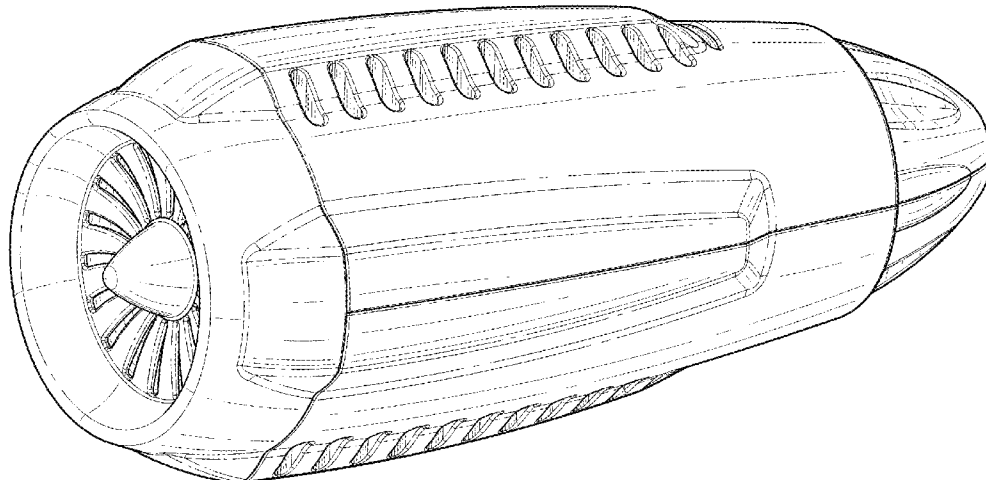
FIG. 2 is a top plan view thereof; the bottom plan view being identical to the top plan view thereof;

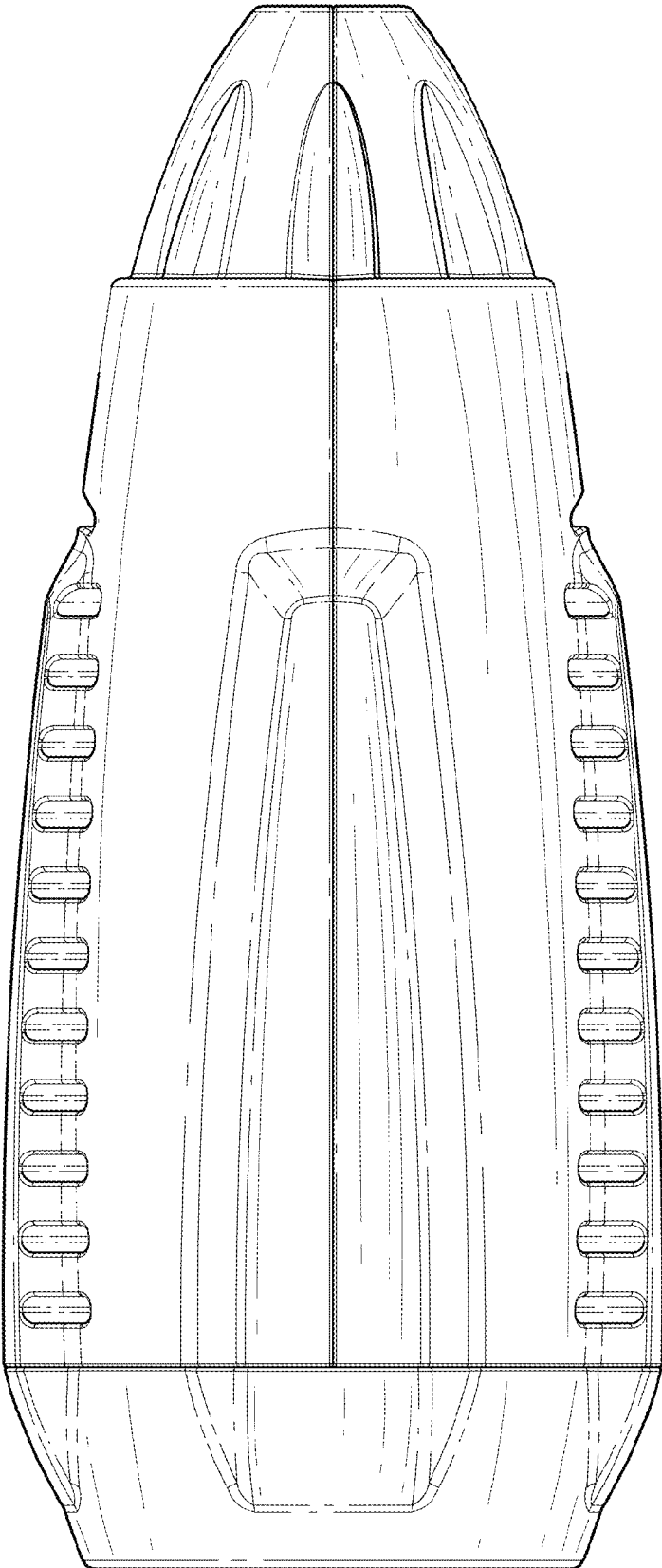
FIG. 3 is a left side view thereof;

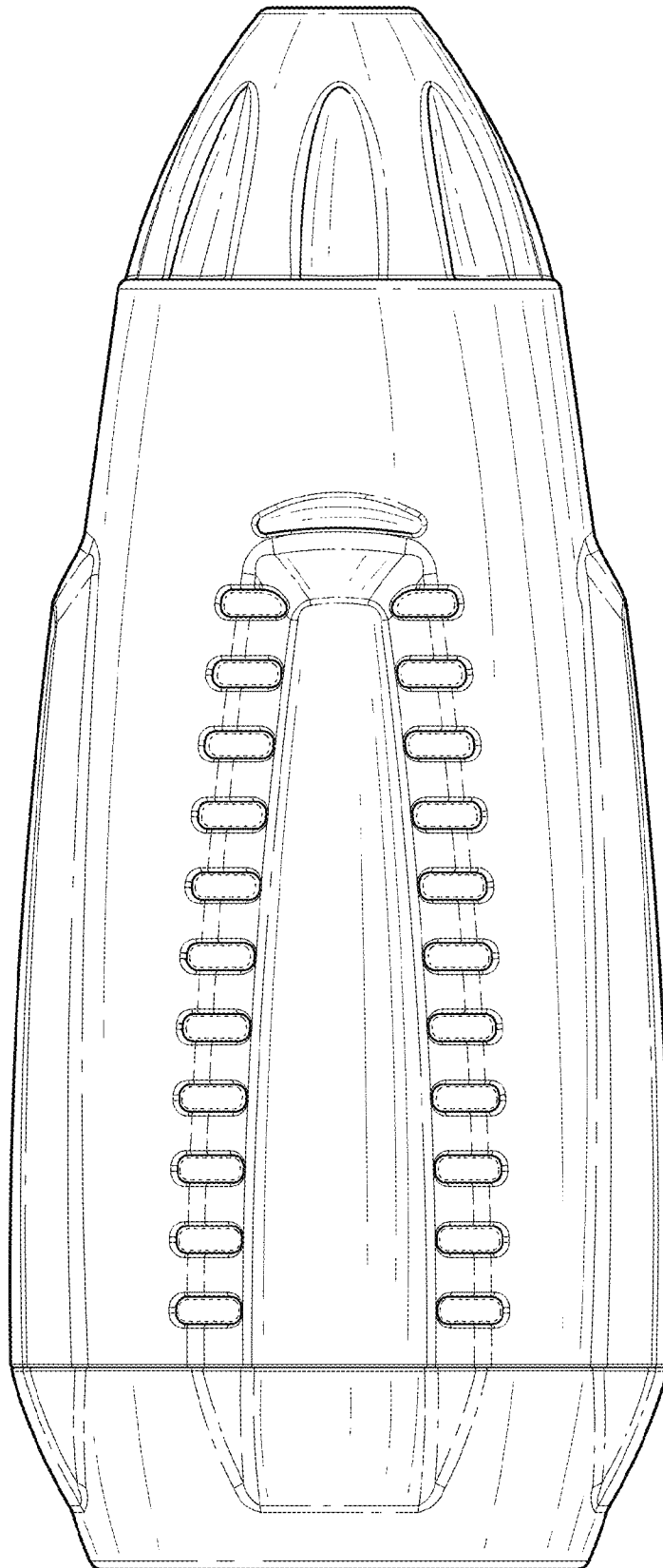

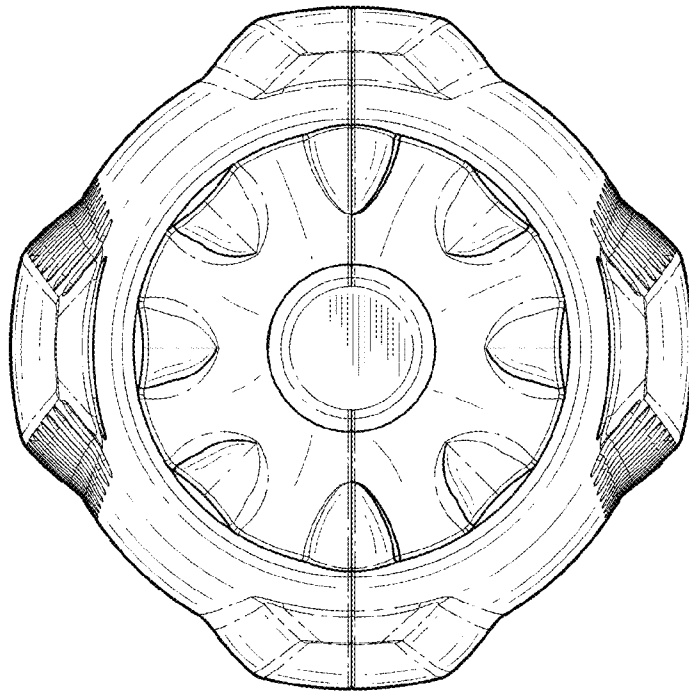

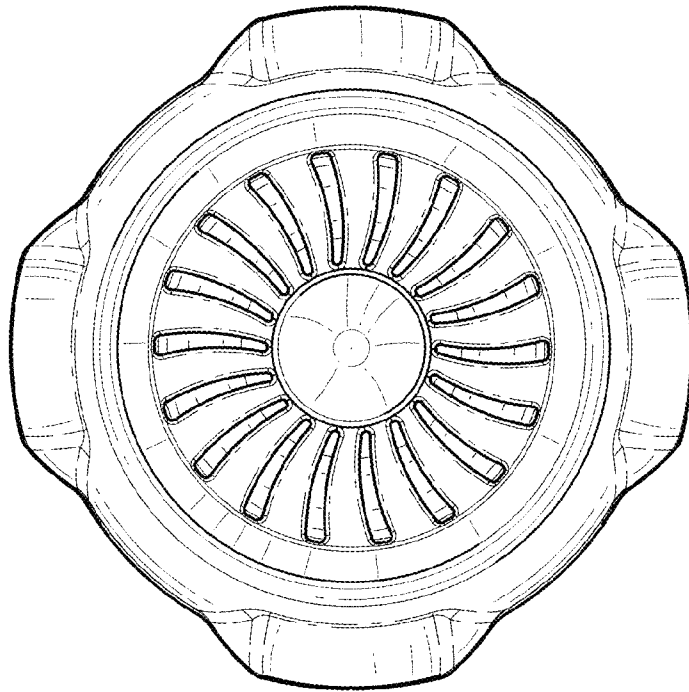

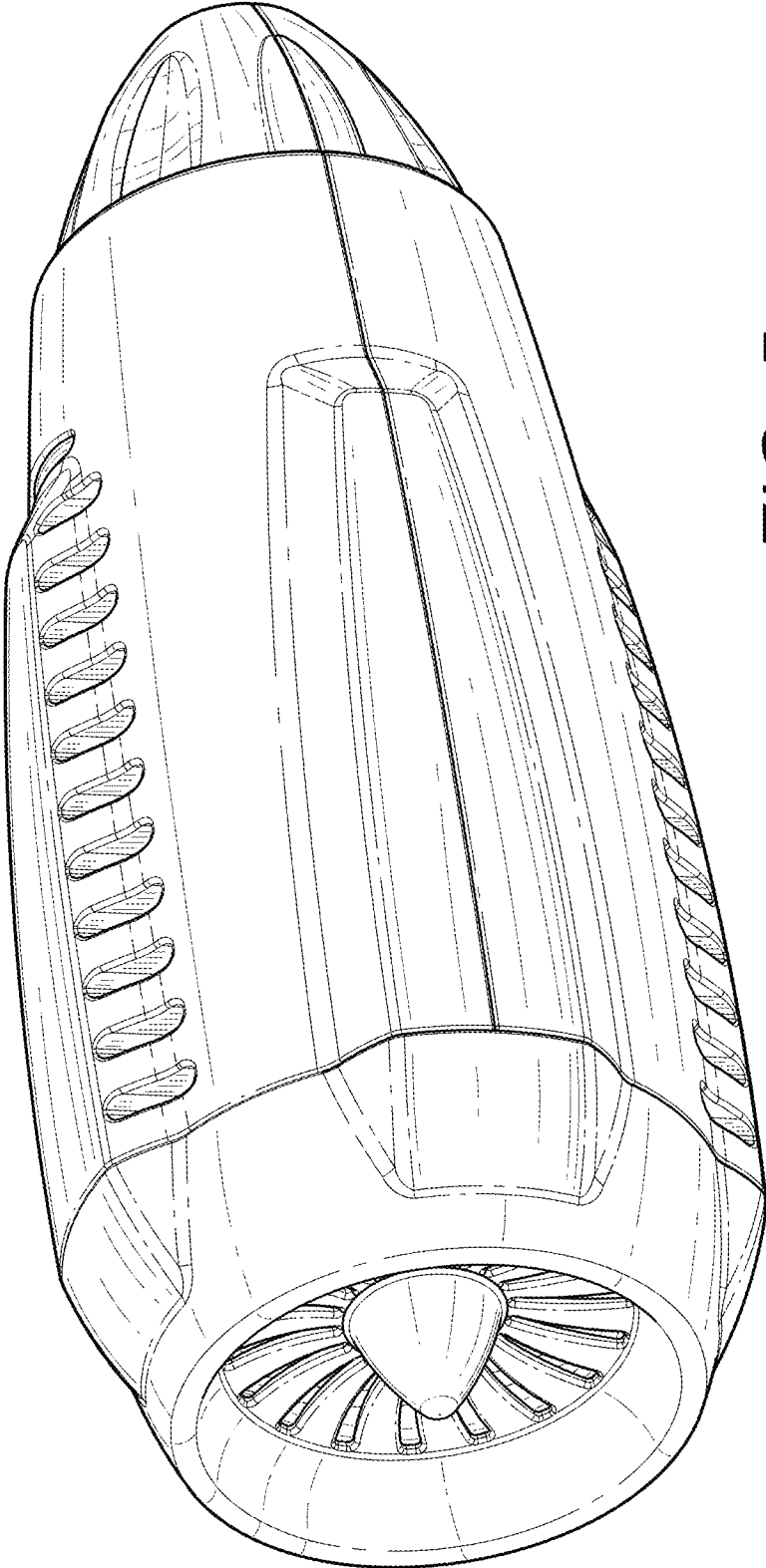
