(57) **CLAIM**

The ornamental design for a molded casket dish, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a molded casket dish shown partially broken away for purposes of illustration, showing my new design;

FIG. 2 is a rear elevational view shown partially broken away for purposes of illustration; and,

FIG. 3 is a fragmentary front perspective view shown for ease of illustration.

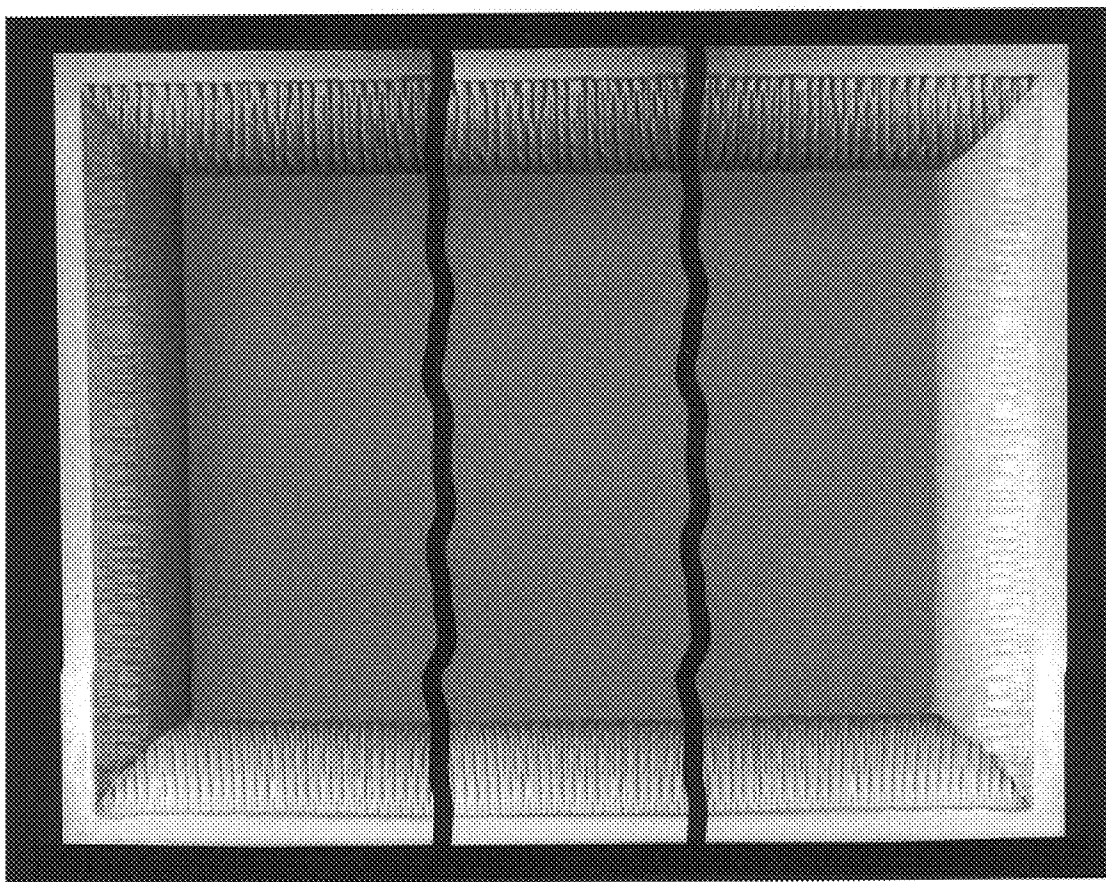

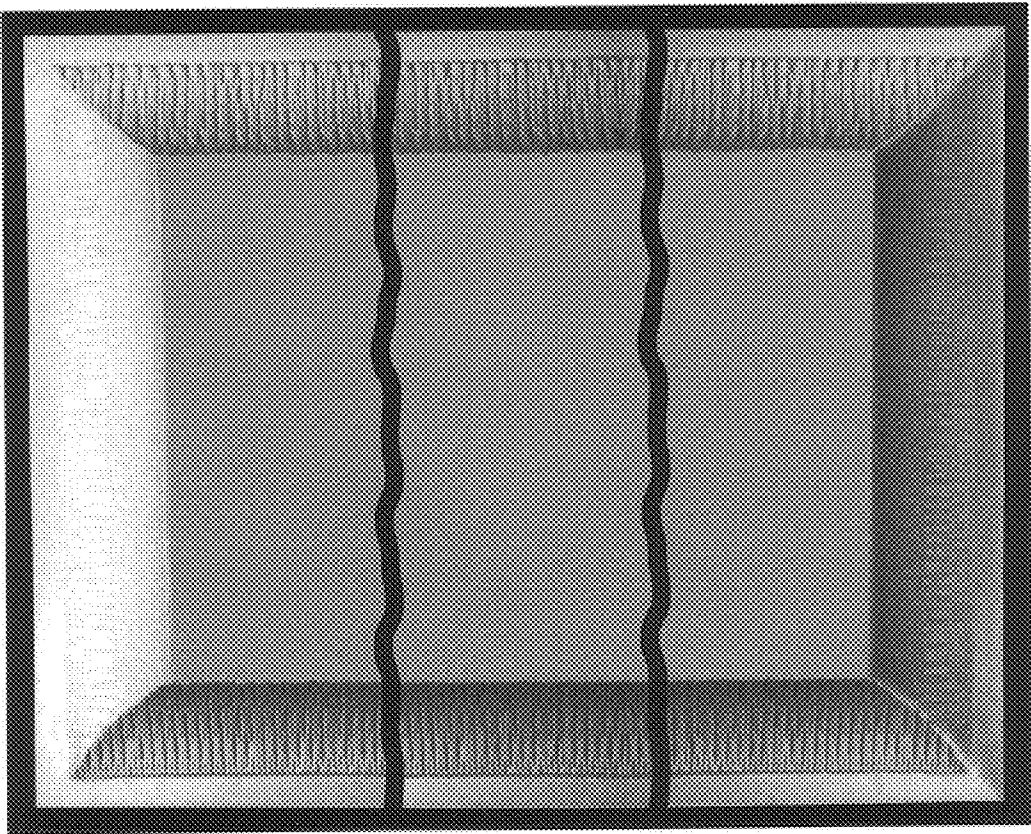

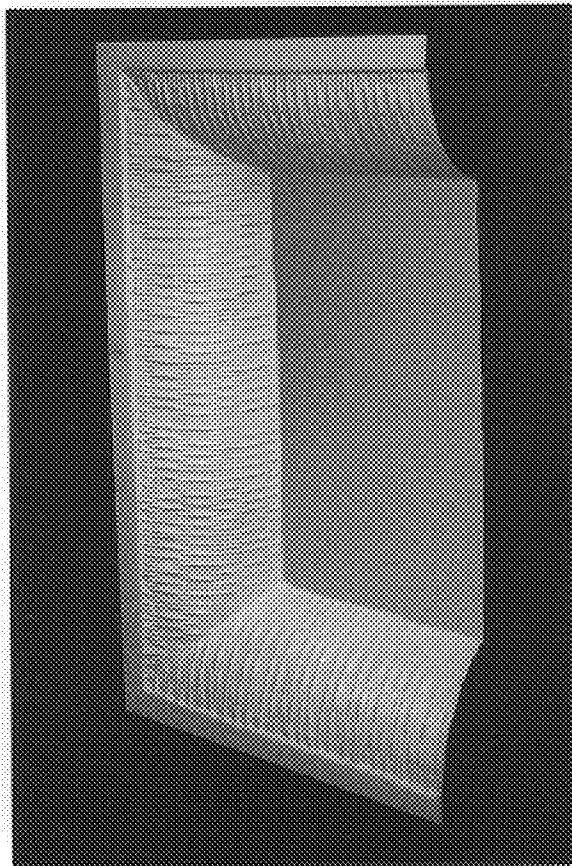
