[57] CLAIM

The ornamental design for an extendible basket carrier for vehicle roof rack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first embodiment of an extendible basket carrier for vehicle roof rack, showing our new design;

FIG. 2 is an enlarged top plan view thereof;

FIG. 3 is an enlarged front elevation view thereof;

FIG. 4 is an enlarged bottom plan view thereof;

FIG. 5 is an enlarged left side view thereof, it being understood that the right side is a mirror image thereof;

FIG. 6 is an enlarged end view thereof taken along line 6—6 of FIG. 12, it being understood that the opposite end is a mirror image thereof;

FIG. 7 is a perspective view of the center portion of the carrier of FIGS. 12-17 shown separately for ease of illustration;

FIG. 8 is an enlarged top plan view thereof;

FIG. 9 is an enlarged bottom plan view thereof;

FIG. 10 is an enlarged front view thereof;

FIG. 11 is an enlarged left side view thereof, it being understood that the right side is a mirror image thereof;

FIG. 12 is an exploded perspective view of the second embodiment of an extendible basket carrier for vehicle roof rack, showing our new design;

FIG. 13 is a perspective view of the second embodiment;


FIG. 14 is an enlarged left side view of FIG. 13, it being understood that the right side is a mirror image thereof;

FIG. 15 is an enlarged top plan view of FIG. 13;

FIG. 16 is an enlarged bottom plan view of FIG. 13; and, FIG. 17 is a reduced perspective view of the carrier of FIG. 13 shown in its position of use.





























