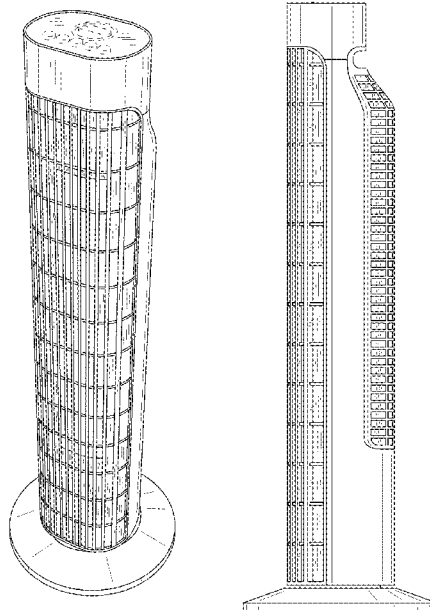
The ornamental design for a tower air movement device, as

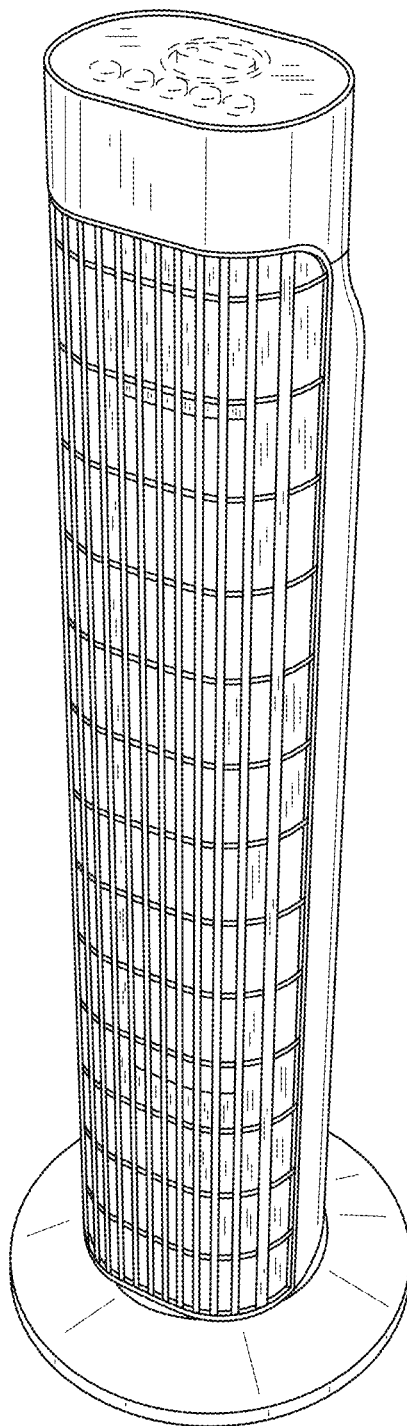

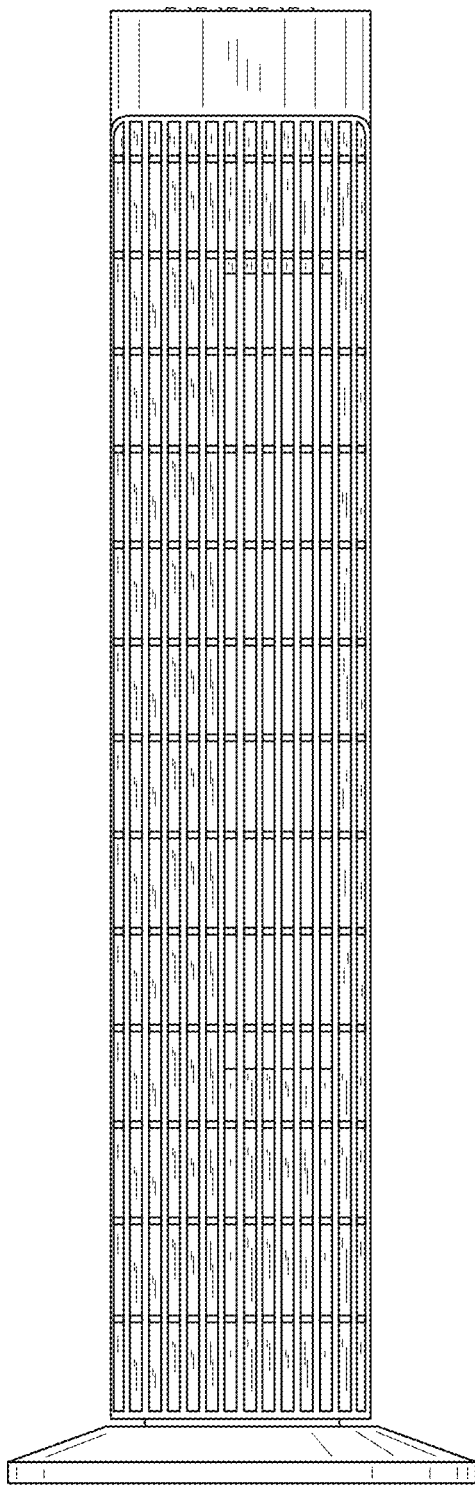

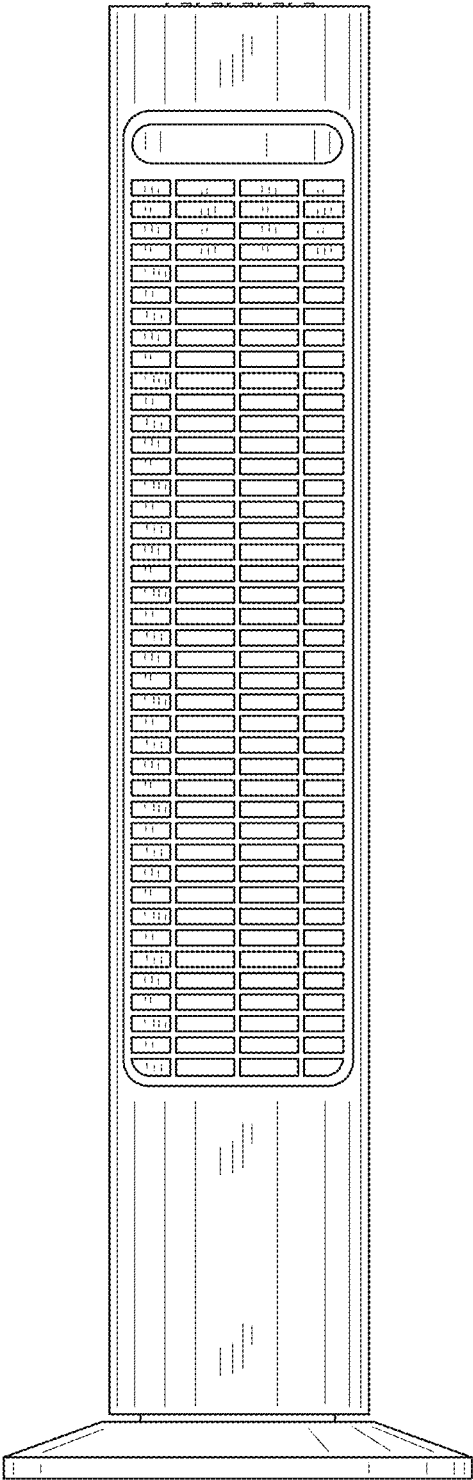

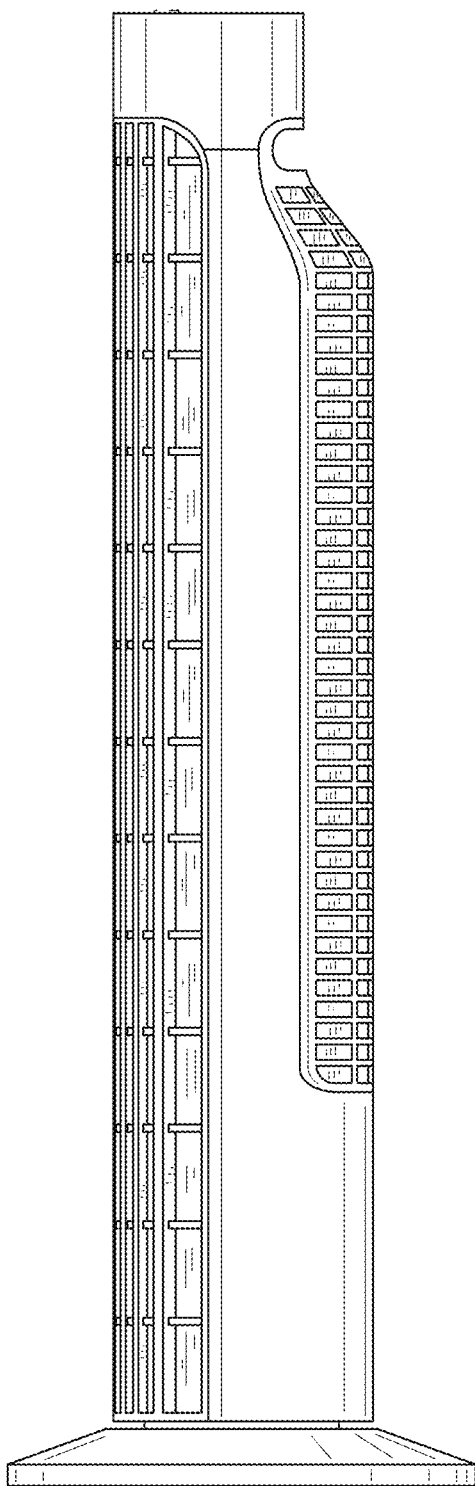

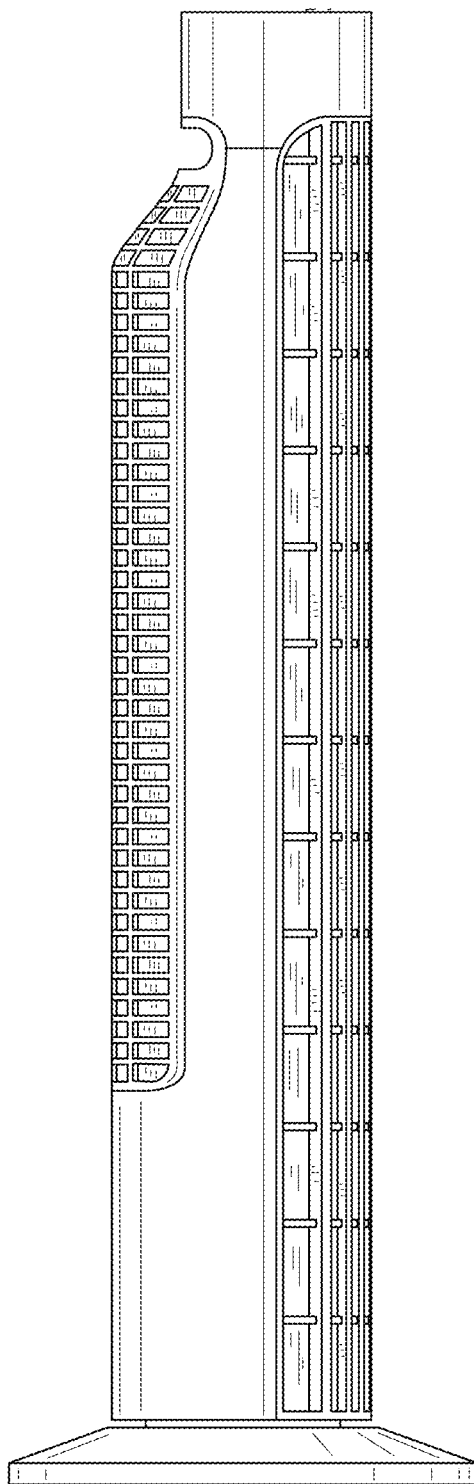

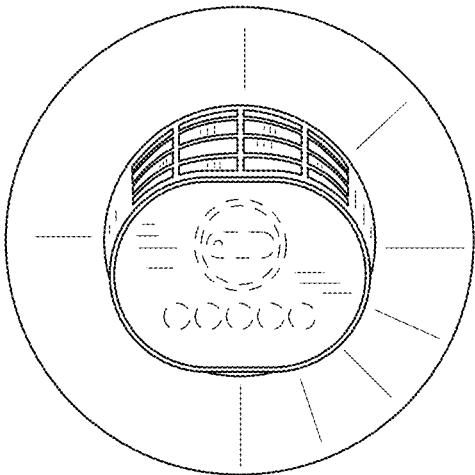

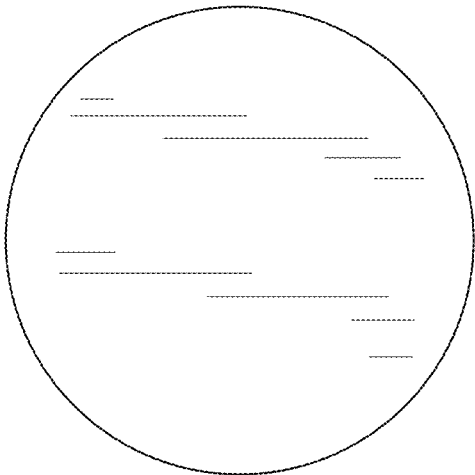
