
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front side view of a connector, showing my new design;
FIG. 2 is a right side view thereof with the front side down;
FIG. 3 is a rear side view thereof;
FIG. 4 is a left side view thereof with the front side up;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof; and,














