
(57) **CLAIM**

The ornamental design for a power bank with kickstand, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a power bank with kickstand in a retracted position;
 FIG. 2 is a front perspective view of the power bank with kickstand in the retracted position;
 FIG. 3 is a rear elevational view of the power bank with kickstand in the retracted position;
 FIG. 4 is a front elevational view of the power bank;
 FIG. 5 is a bottom plan view of the power bank with kickstand in the retracted position;
 FIG. 6 is a top plan view of the power bank with kickstand in the retracted position;
 FIG. 7 is a right elevational view of the power bank with kickstand in the retracted position;
 FIG. 8 is a left elevational of the power bank with kickstand in the retracted position;
 FIG. 9 is a rear perspective view of the power bank with kickstand in an extended position, while the power bank is in a first position; and,
 FIG. 10 is a rear perspective view of the power bank with kickstand in the extended position, while the power bank is in a second position.


















