(57) **CLAIM**

The ornamental design for a razor travel cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the razor travel cover the present invention in its closed configuration.

FIG. 2 is a top plan view of the razor travel cover of FIG. 1.

FIG. 3 is a bottom plan view of the razor travel cover of FIG. 1.

FIG. 4 is a right side elevation of the razor travel cover of FIG. 1.

FIG. 5 is a left side elevation of the razor travel cover of FIG. 1.


FIG. 6 is a rear elevation of the razor travel cover of FIG. 1.
















