(57) **CLAIM**

The ornamental design for a lap desk with wrist pad, as shown and described.

DESCRIPTION

FIG. 1 is a front, left, elevated, quartering perspective view of a new design for a lap desk with wrist pad;

FIG. 2 is a section view, as indicated in FIG. 3, of the new design of FIG. 1 showing the interior shape of a device slot in the top surface thereof.

FIG. 3 is a top plan view of the new design of FIG. 1;

FIG. 4 is a bottom plan view of the new design of FIG. 1; FIG. 5 is a front elevational view of the new design of FIG. 1;

FIG. 6 is a rear elevational view of the new design of FIG. 1;


FIG. 7 is a right-side elevational view of the new design of FIG. 1;
















