[57] **CLAIM**

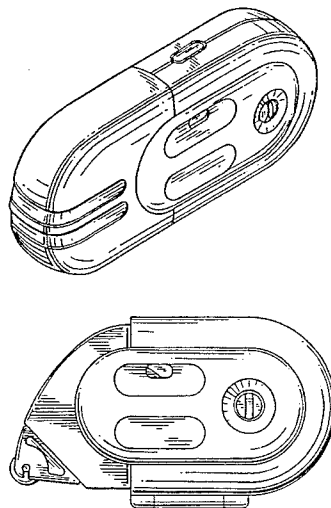
The ornamental design for a transfer tape holder, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a transfer tape holder showing our

new design;

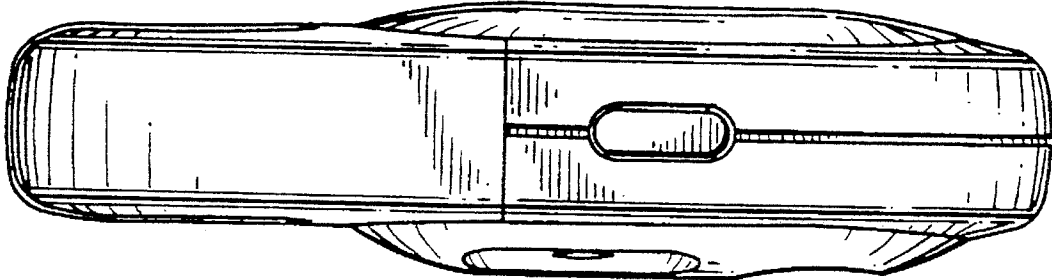

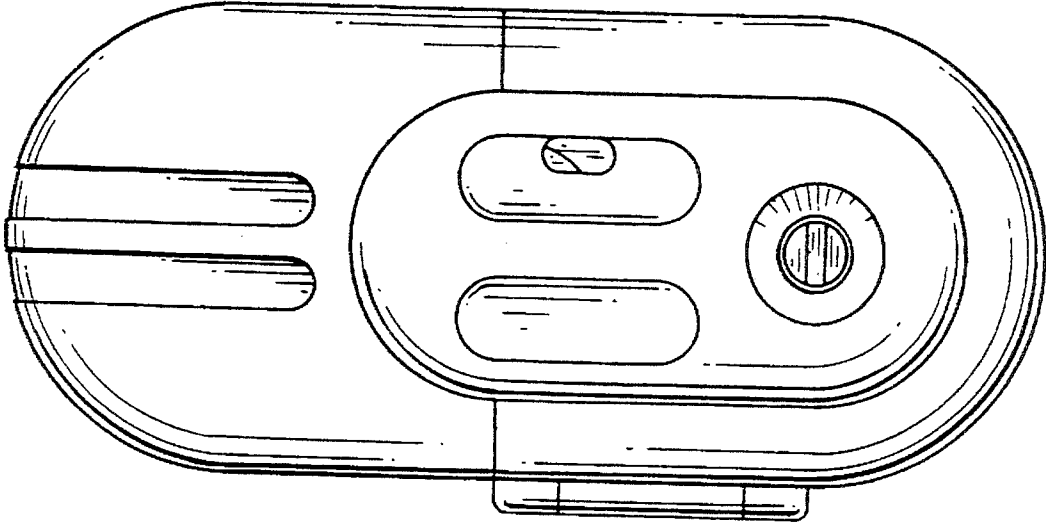

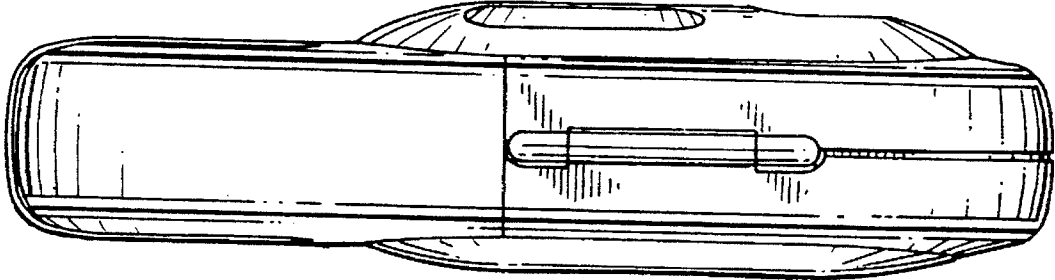

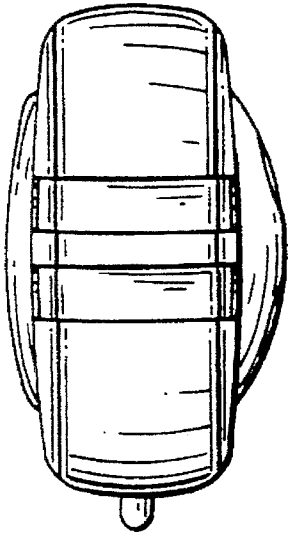

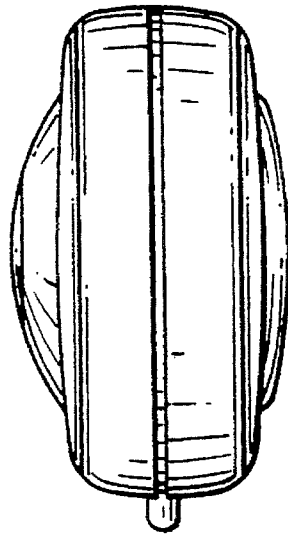

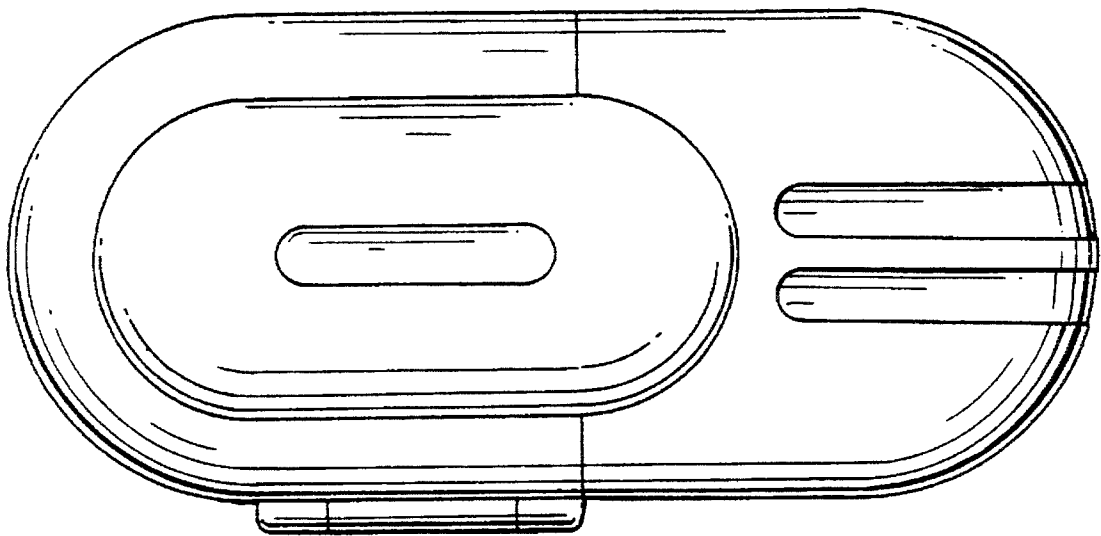

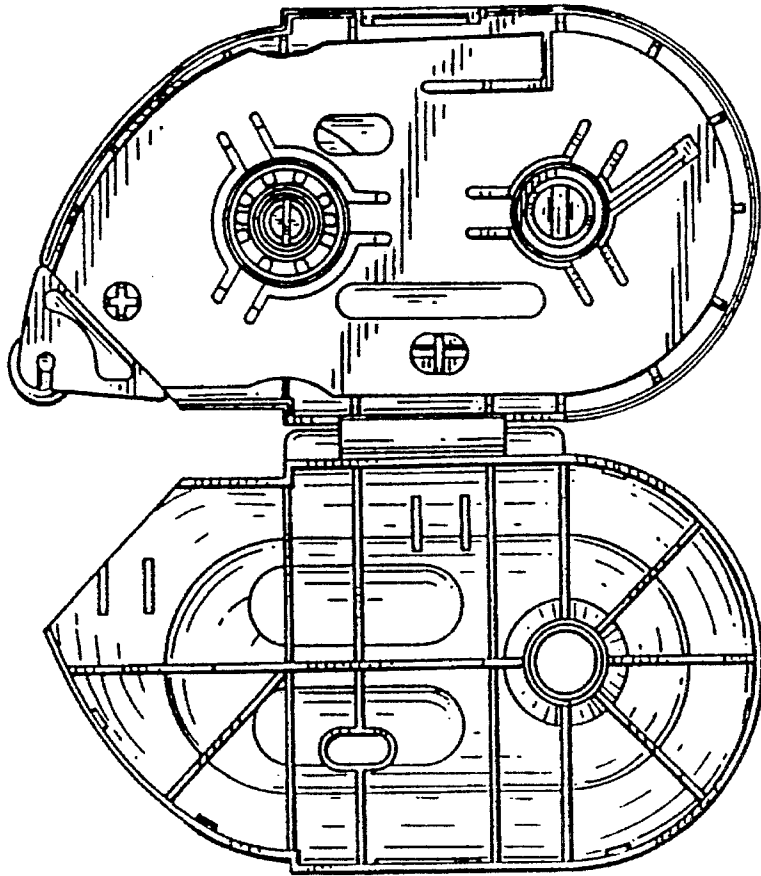

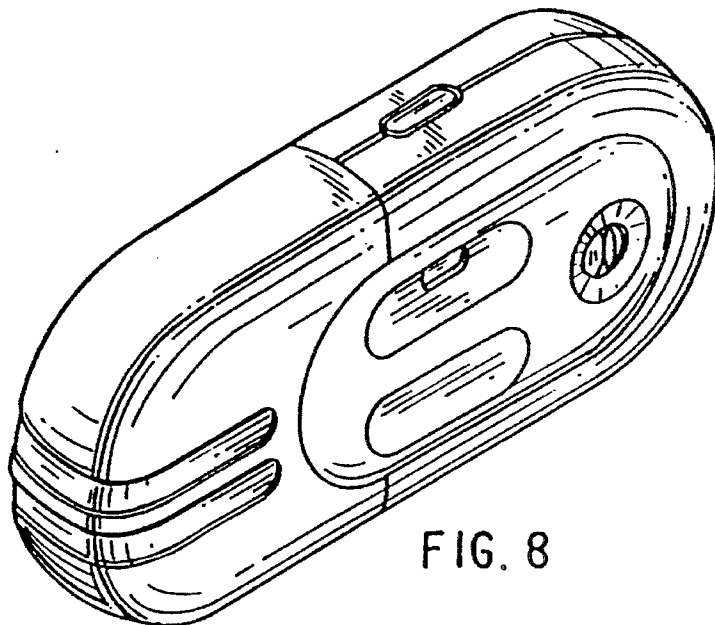

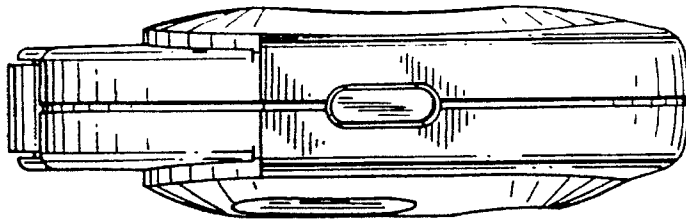

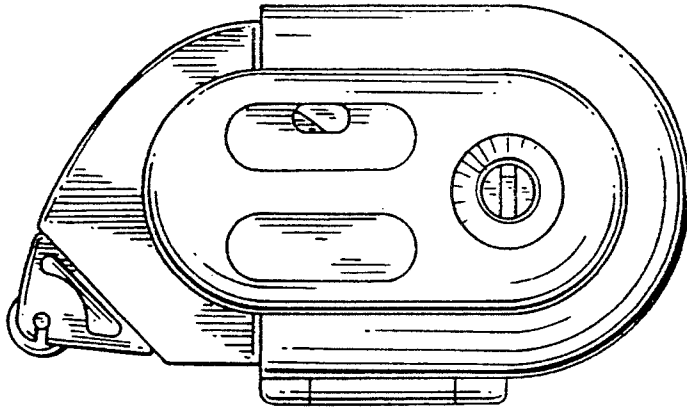

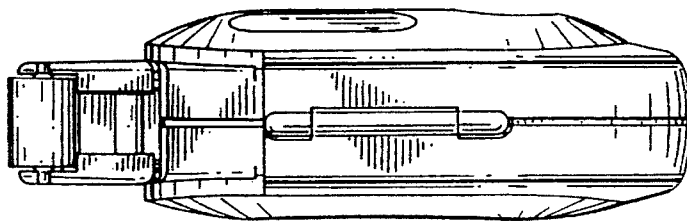

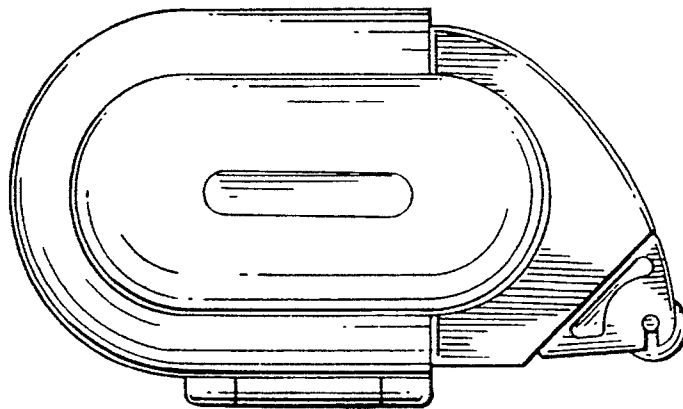

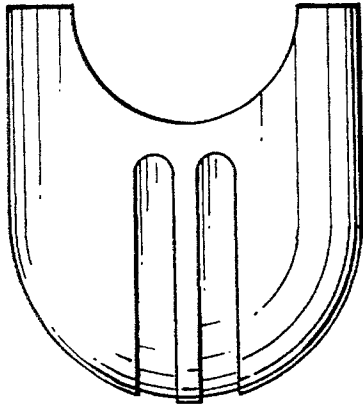

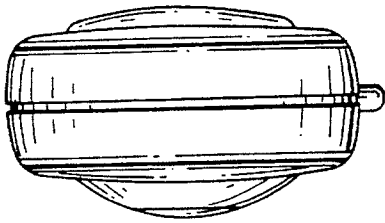

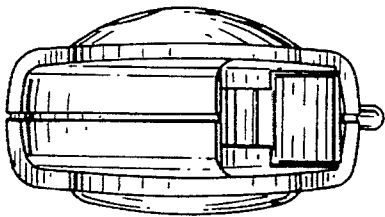

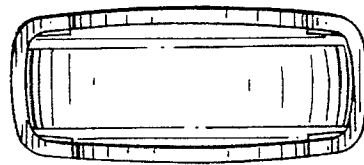

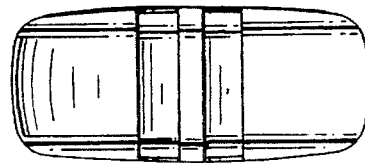
