
(57) **CLAIM**

The ornamental design for an audio device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an audio device, showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a rear perspective view thereof;
FIG. 9 is an enlarged view of the encircled portion 9 of FIG. 4;
FIG. 10 is an enlarged view of the encircled portion 10 of FIG. 6; and,
FIG. 11 is an enlarged view of the encircled portion 11 of FIG. 8.




















