FIG. 4 is a side elevational view thereof;

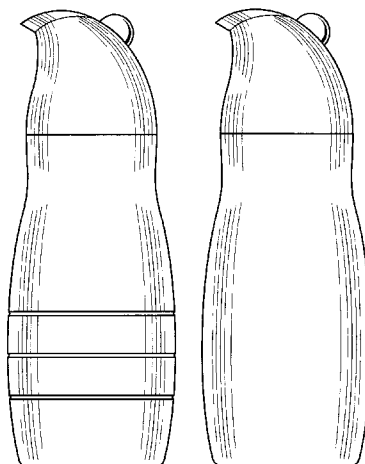
FIG. 5 is a top plan view thereof;

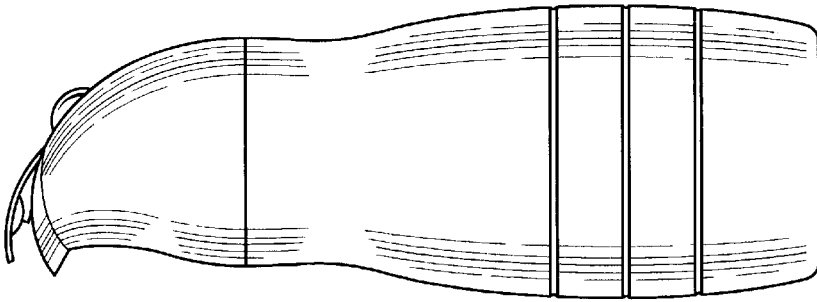
FIG. 6 is a side elevational view of a second embodiment of the fluid container;

FIG. 7 is a rear elevational view thereof; and,

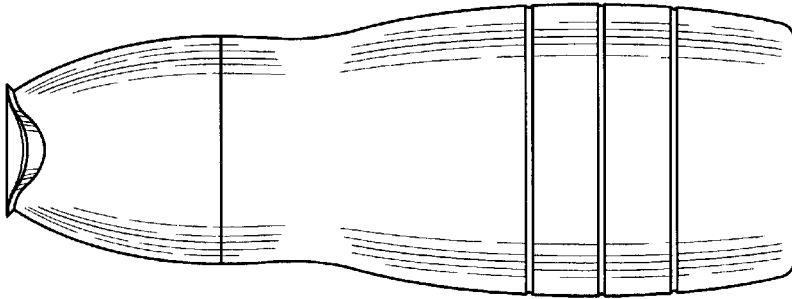
FIG. 8 is a front elevational view thereof.

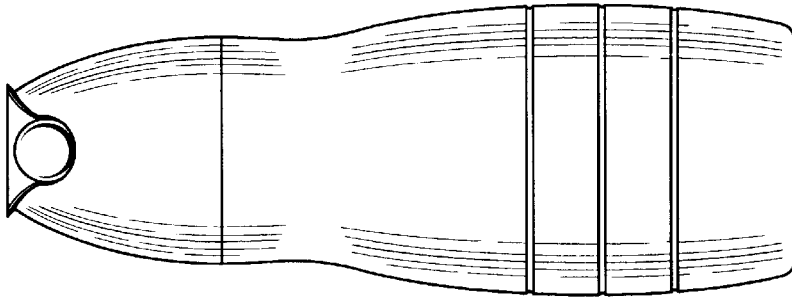




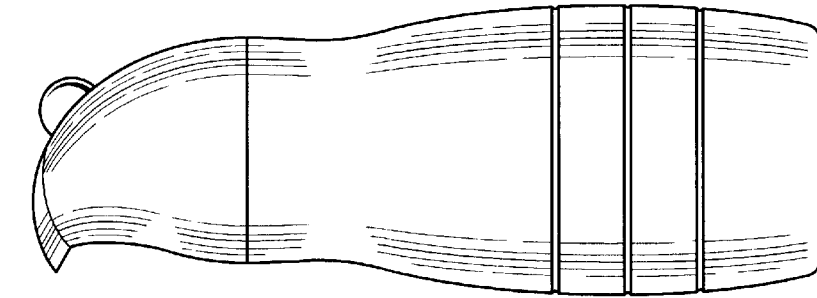

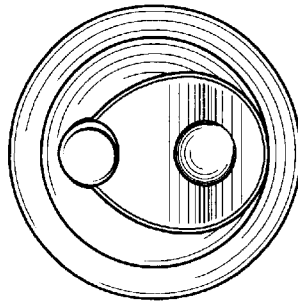

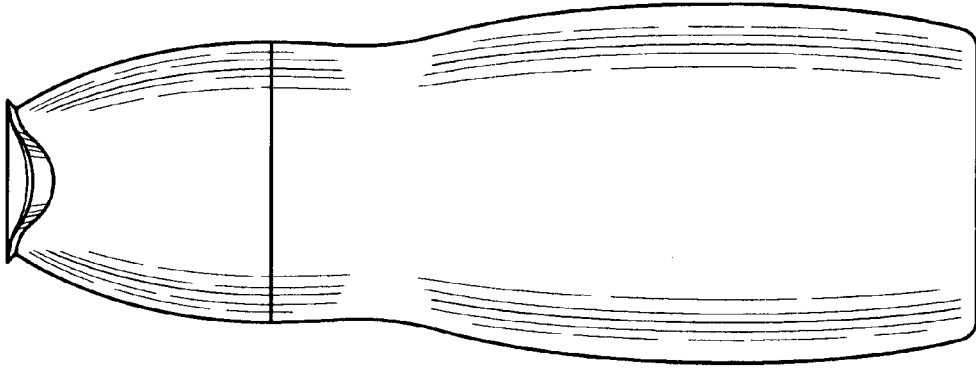

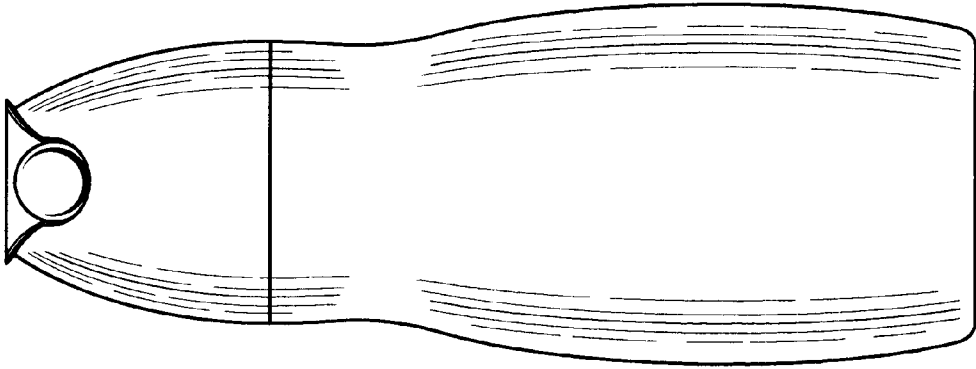

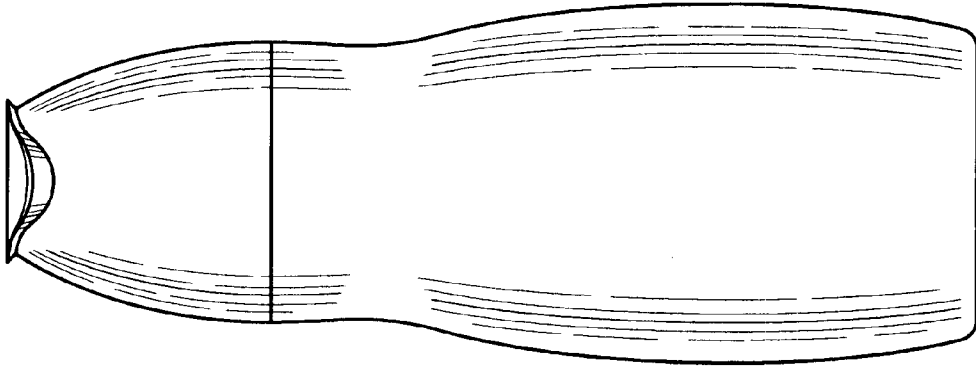
