(57) **CLAIM**

The ornamental design for a clothing hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a clothing hanger showing our new design;

FIG. 2 is a left side elevational view of the clothes hanger of FIG. 1 of the present invention.

FIG. 3 is a front elevational view of the clothes hanger of FIG. 1 of the present invention. The rear elevational view is a mirror image of the front elevational view.

FIG. 4 is a right side elevational view of the clothes hanger of FIG. 1 of the present invention.

FIG. 5 is a bottom plan view of the clothes hanger of FIG. 1 of the present invention; and,

FIG. 6 is a perspective view of the clothes hanger of FIG. 1 of the present invention.






