(57) **CLAIM**

The ornamental design for a golf putter grip, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of the golf putter grip; FIG. 2 is a top rear perspective view of the golf putter grip; FIG. 3 is a frontal view of the golf putter grip; FIG. 4 is a rear view of the golf putter grip; FIG. 5 is a left side view of the golf putter grip; FIG. 6 is a right side view of the golf putter grip; FIG. 7 is a top view of the golf putter grip; FIG. 8 is a top front perspective view of a second embodiment of the golf putter grip; FIG. 9 is a top rear perspective view of the golf putter grip of FIG. 8; FIG. 10 is a frontal view of the golf putter grip of FIG. 8; FIG. 11 is a rear view of the golf putter grip of FIG. 8; FIG. 12 is a right side view of the golf putter grip of fig.; FIG. 13 is a left side of the golf putter grip of FIG. 8; and, FIG. 14 is a top view of the golf putter grip of FIG. 8.




























