FIG. 3 is a side view of the chair with cross frame chassis of the present invention.

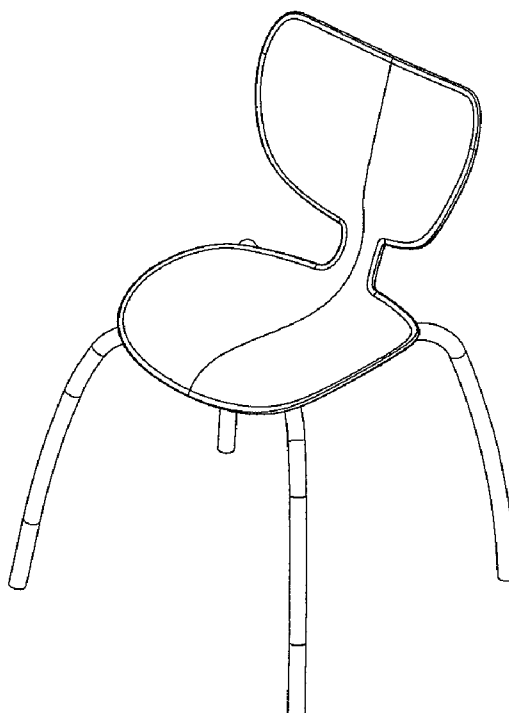
FIG. 4 is a rear view of the chair with cross frame chassis of the present invention.

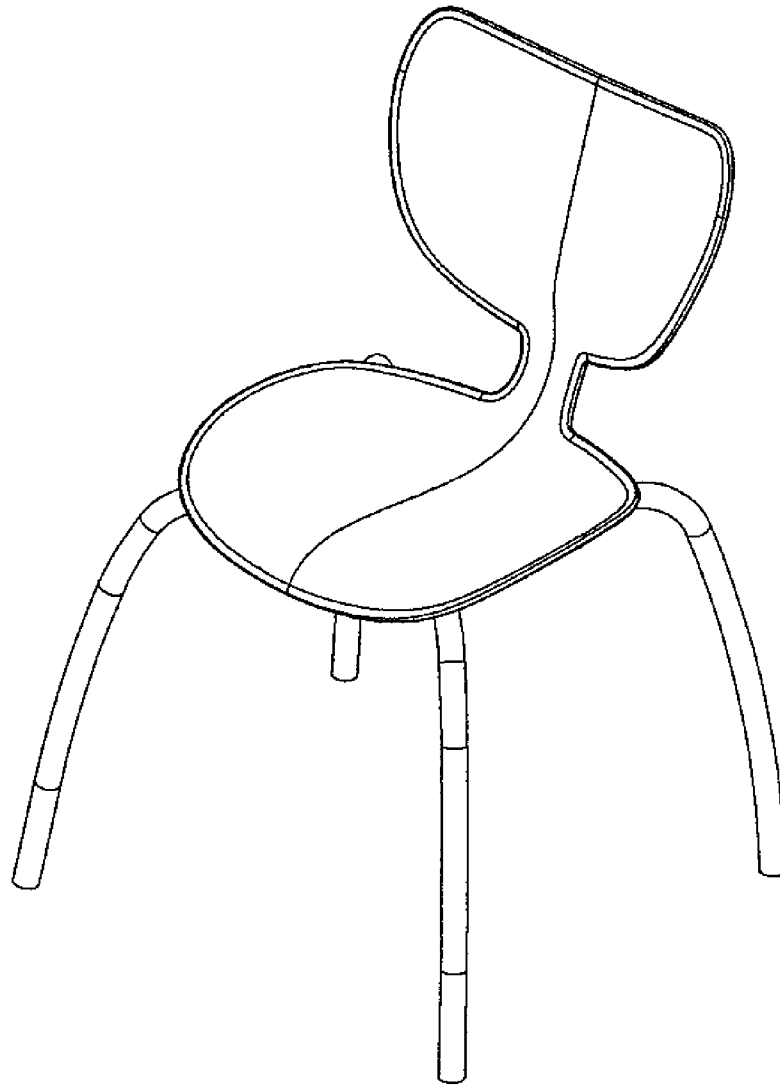

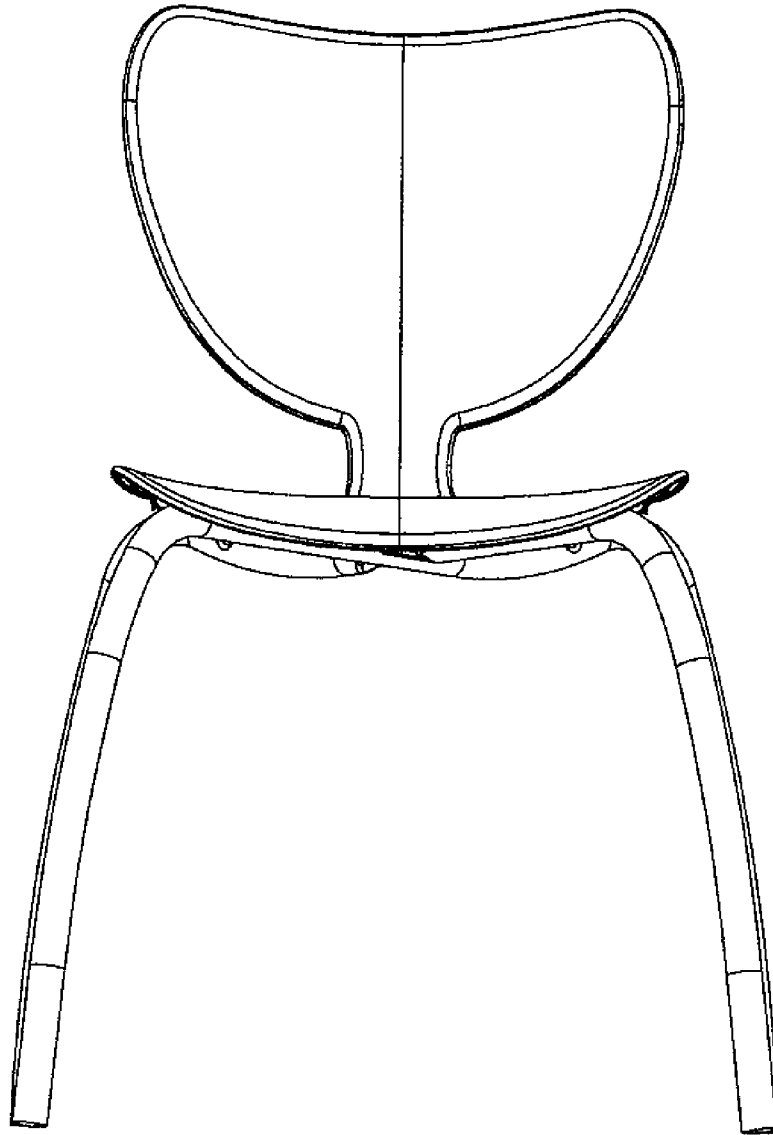

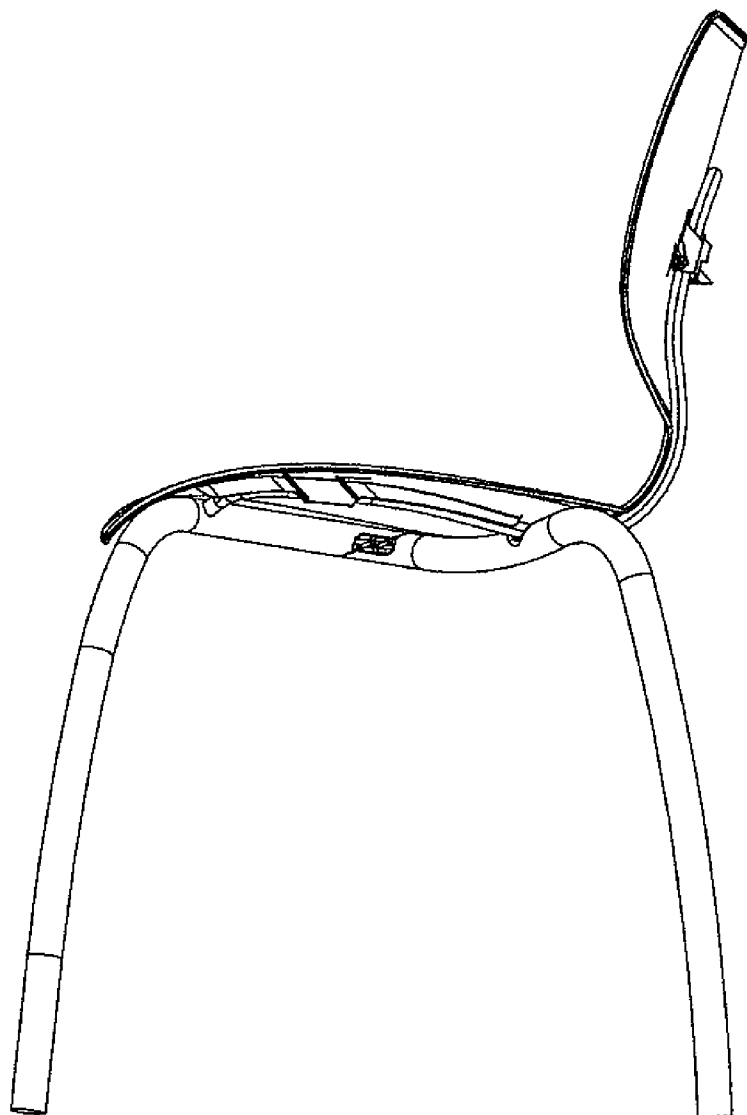

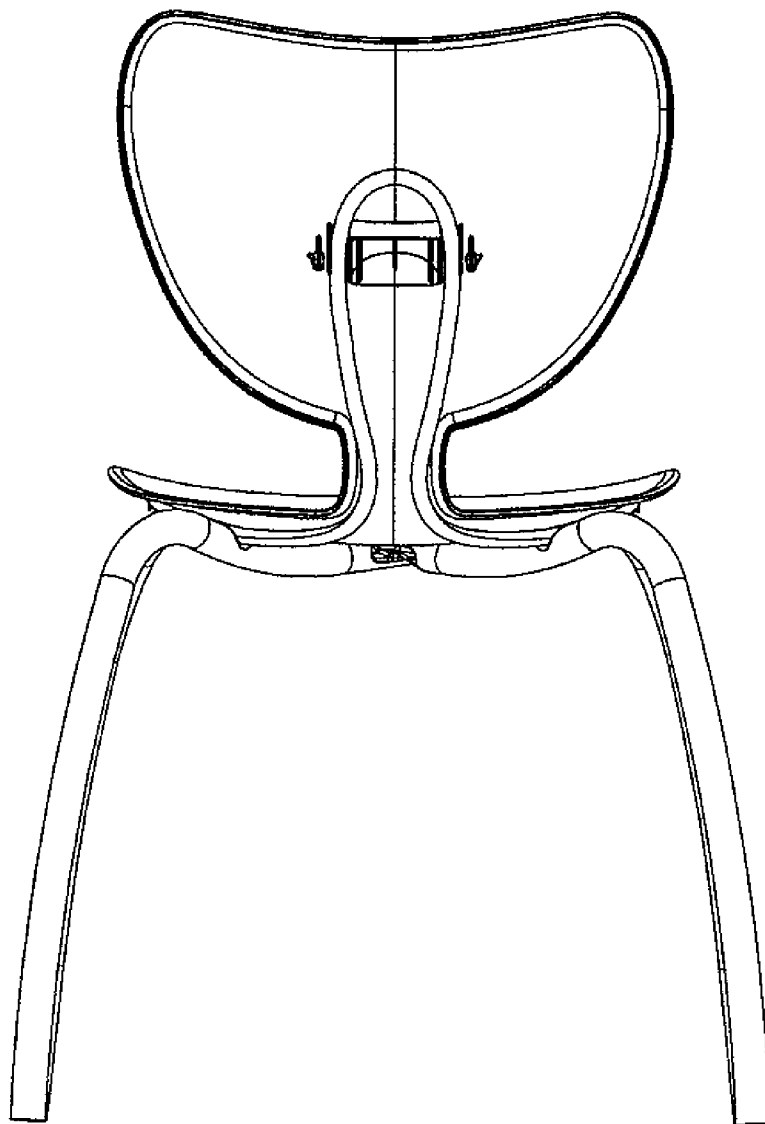

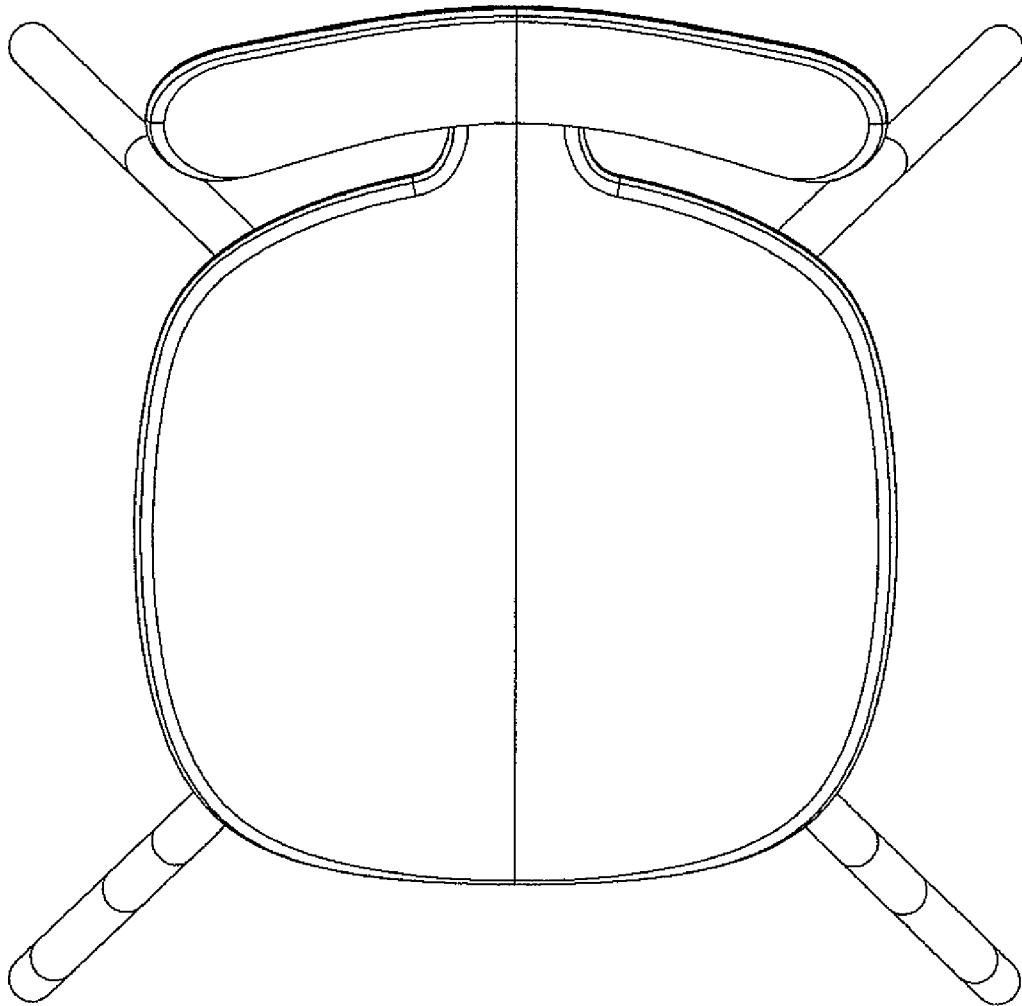

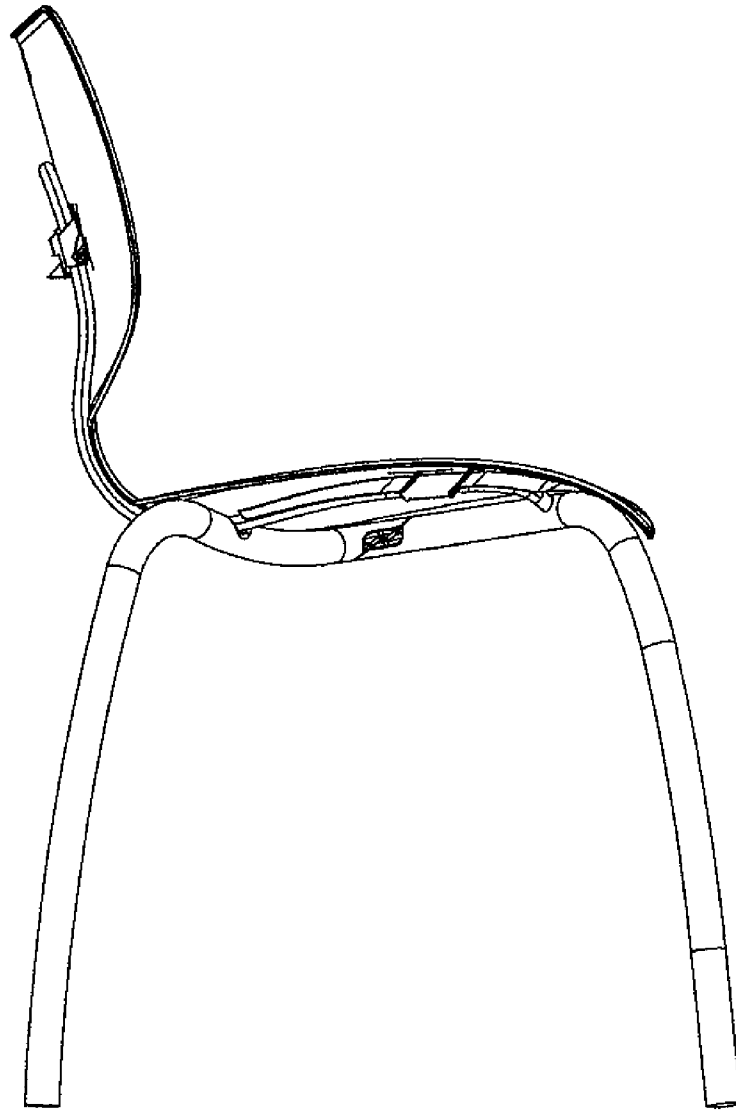

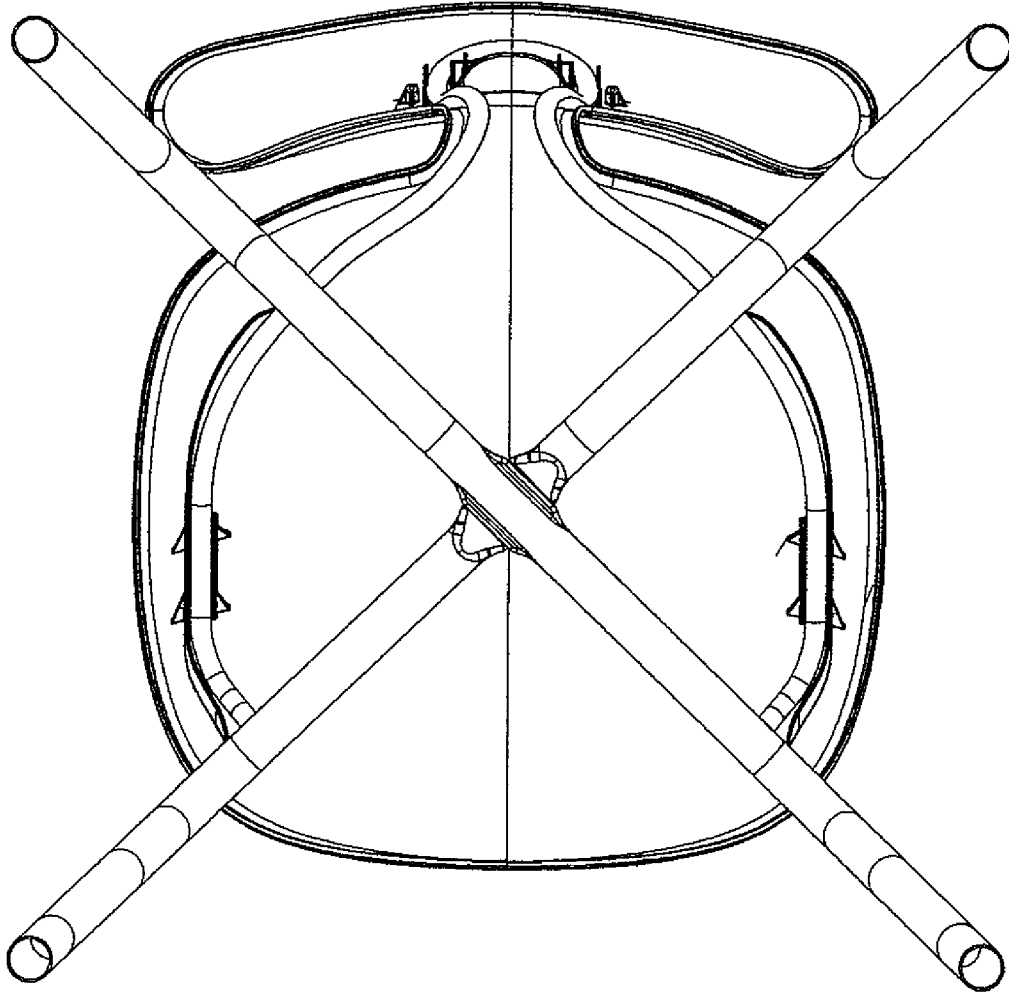
