DESCRIPTION

FIG. 1 is a front view of a touch panel in accordance with the invention;

FIG. 2 is a first side view of the touch panel shown in FIG. 1;

FIG. 3 is a second side view of the touch panel shown in FIG. 1;

FIG. 4 is a top view of the touch panel shown in FIG. 1;

FIG. 8 is a rear perspective of the touch panel shown in FIG. 1;


FIG. 9 is a first rear perspective of the touch panel shown in FIG. 1 depicting an extended support member;
























