(57) **CLAIM**

The ornamental design for a canister for use with anaesthetic apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the left side of a canister for use with an anaesthetic apparatus.

FIG. 2 is a front view of the canister for use with an anaesthetic apparatus shown in FIG. 1.

FIG. 3 is a rear view of the canister for use with an anaesthetic apparatus shown in FIG. 1.

FIG. 4 is a top view of the canister for use with an anaesthetic apparatus shown in FIG. 1.

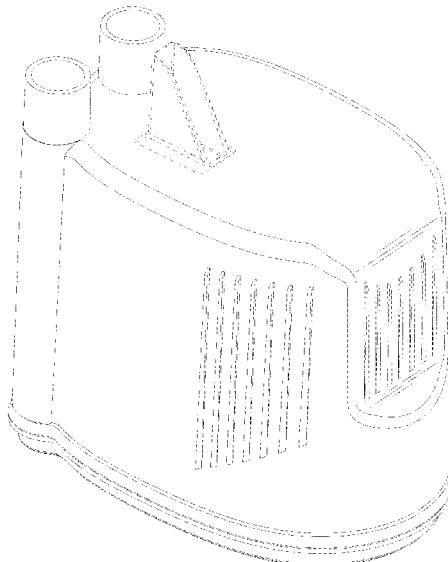
FIG. 5 is a bottom view from the right side of the canister for use with an anaesthetic apparatus shown in FIG. 1.

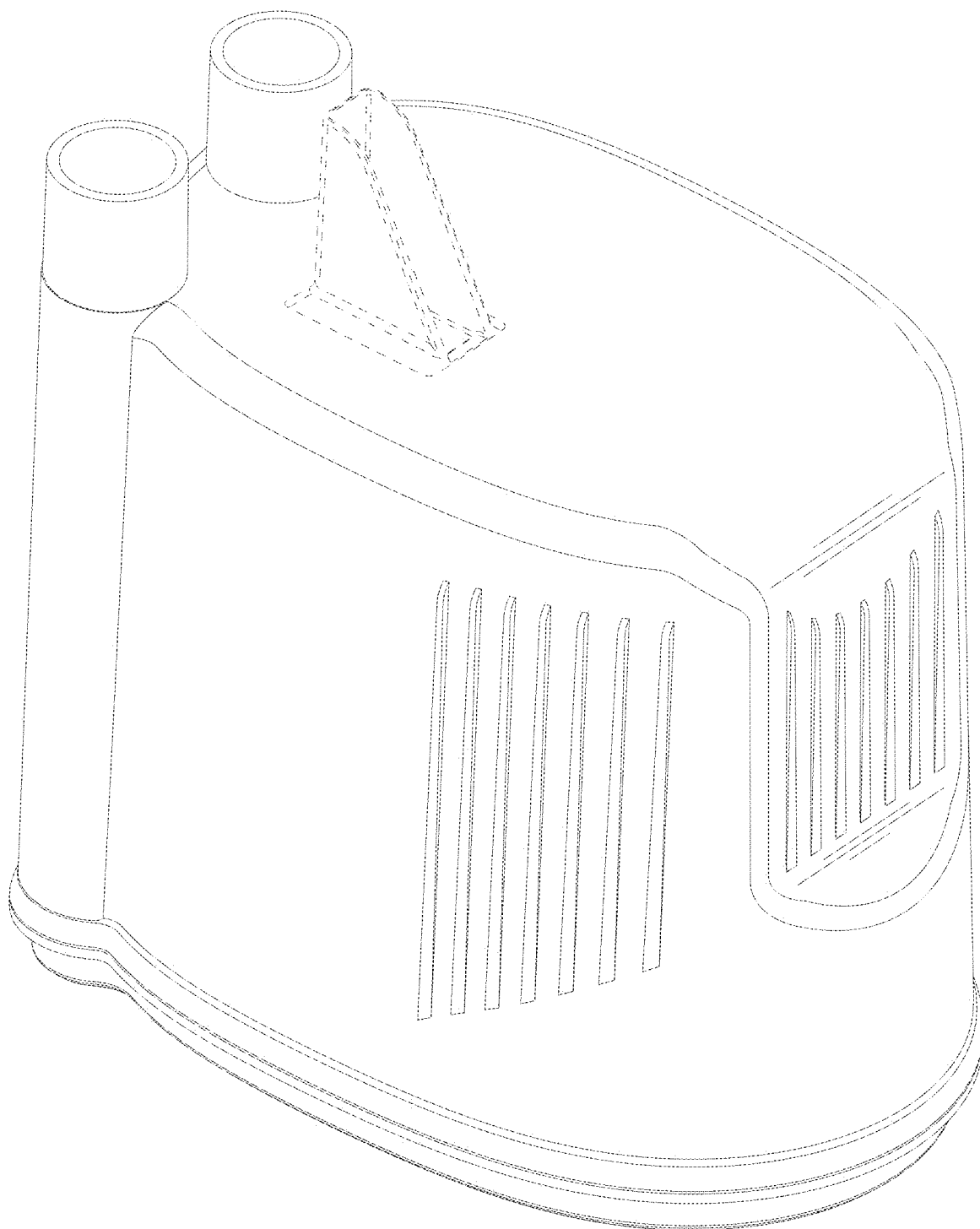

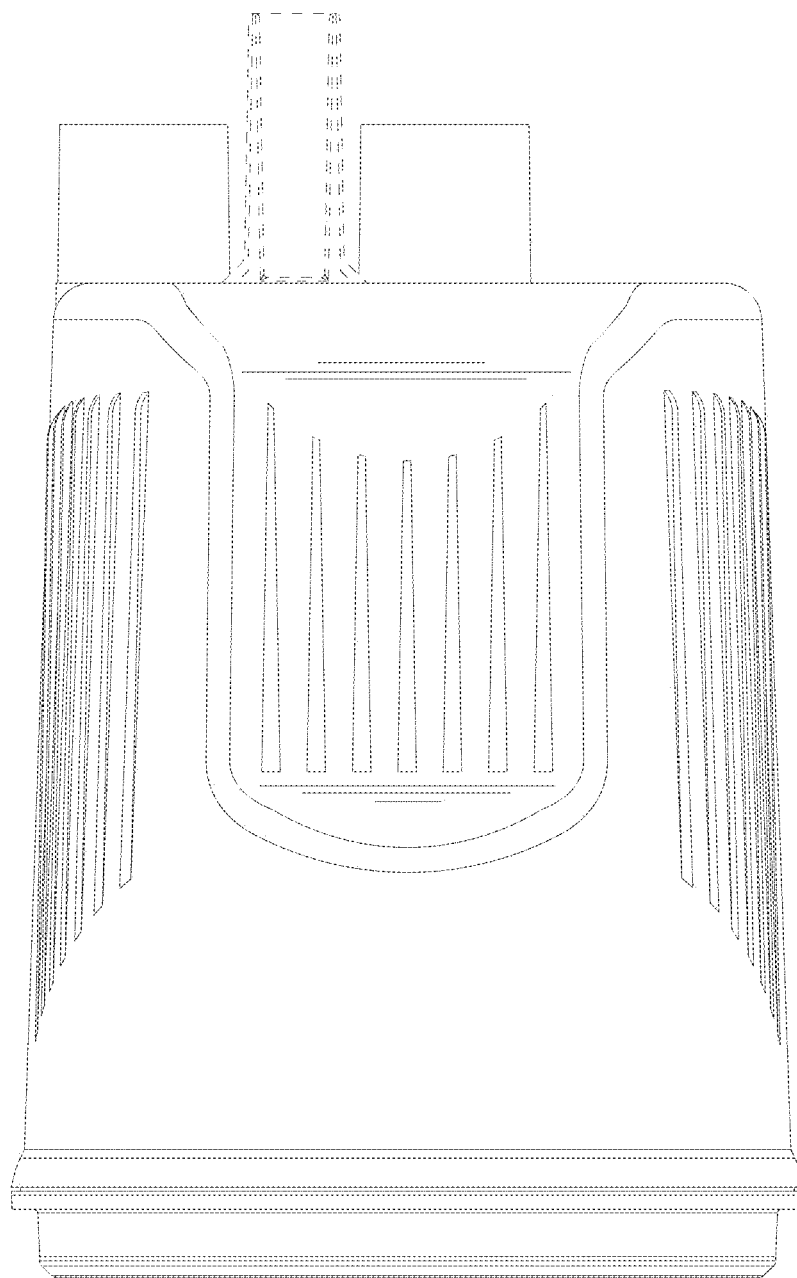

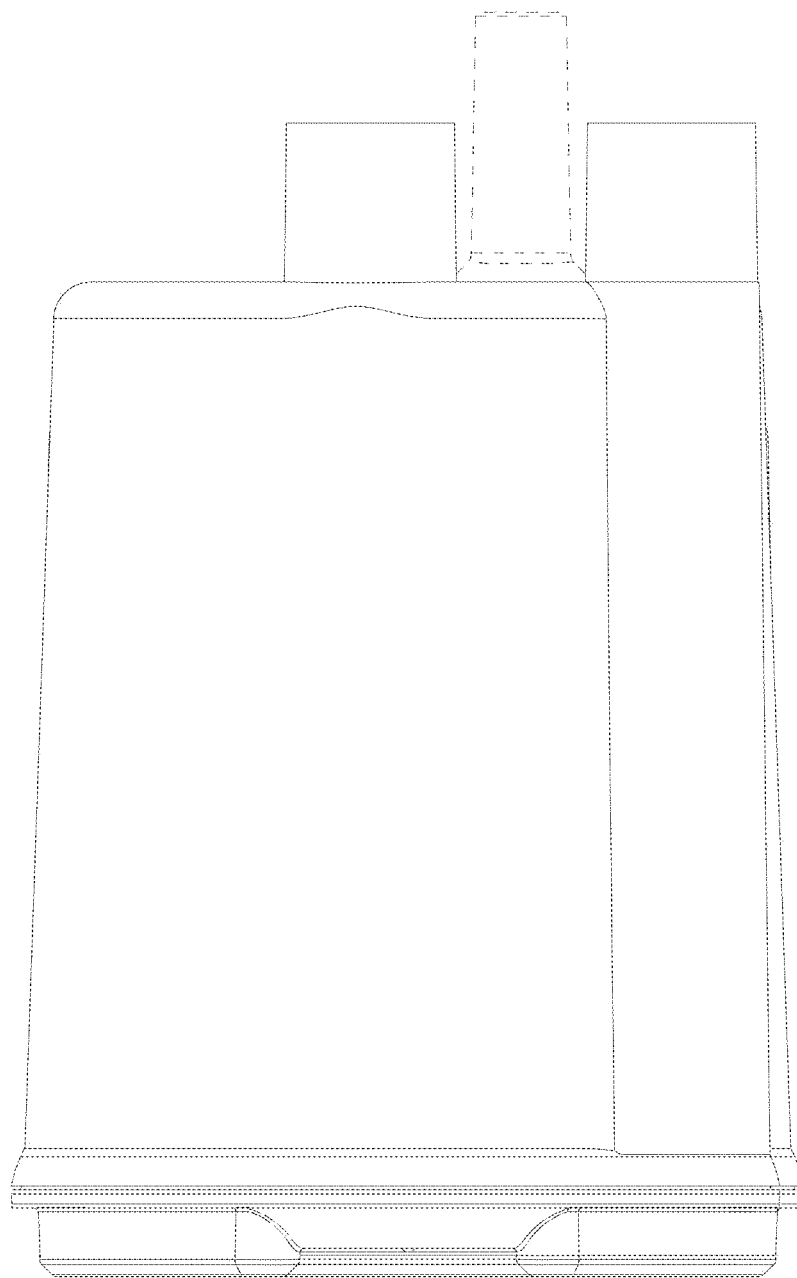

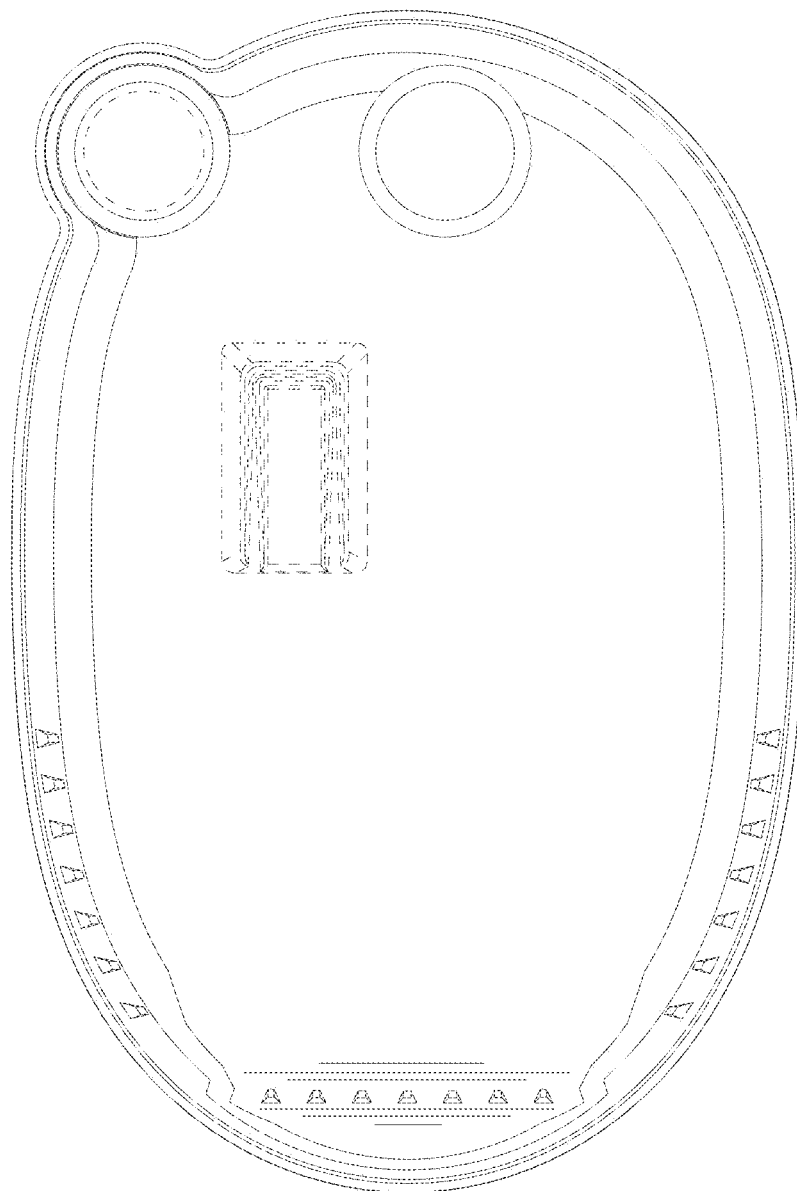

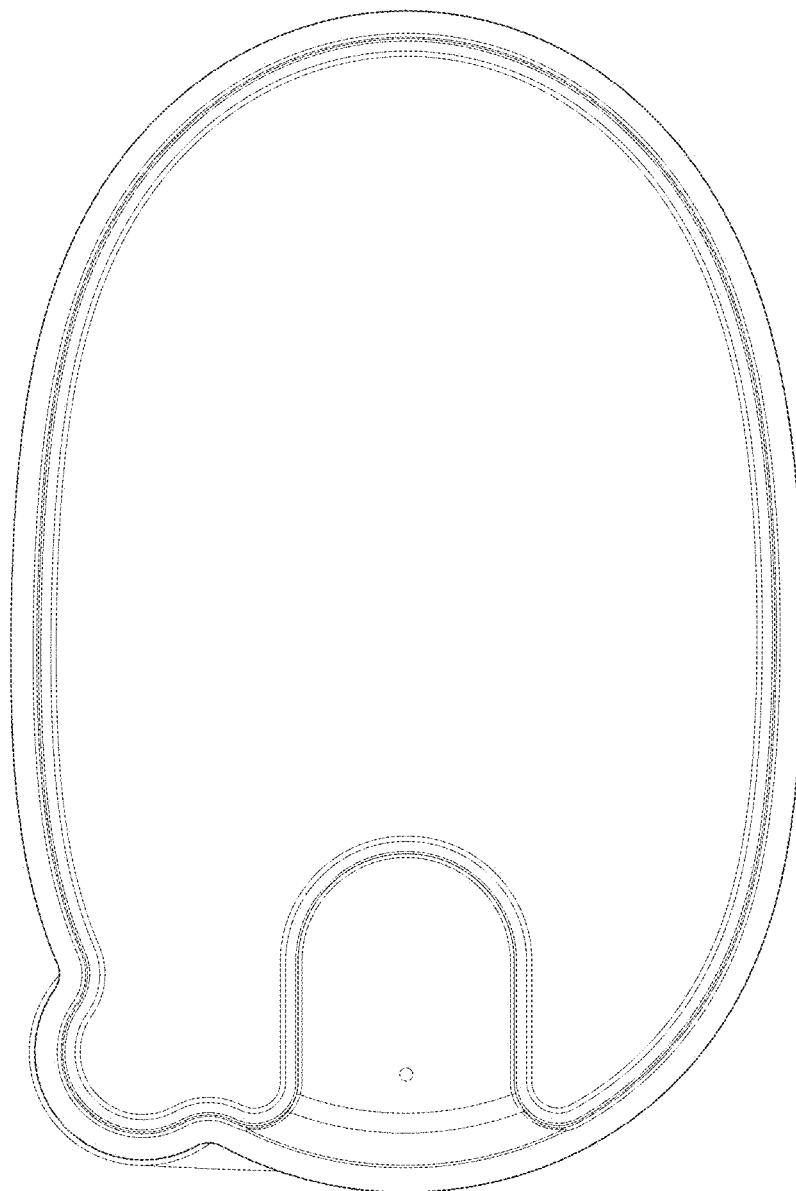

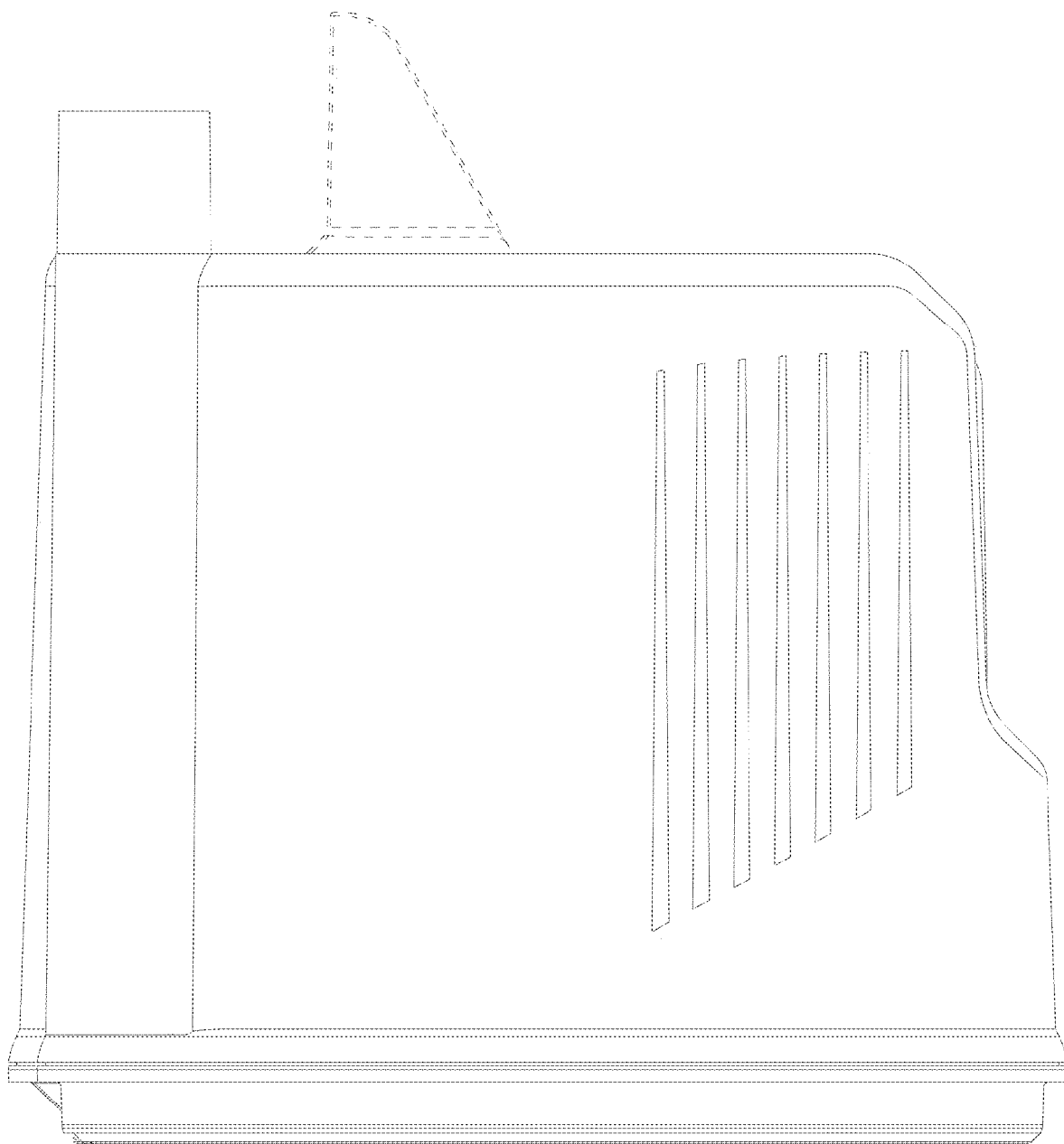

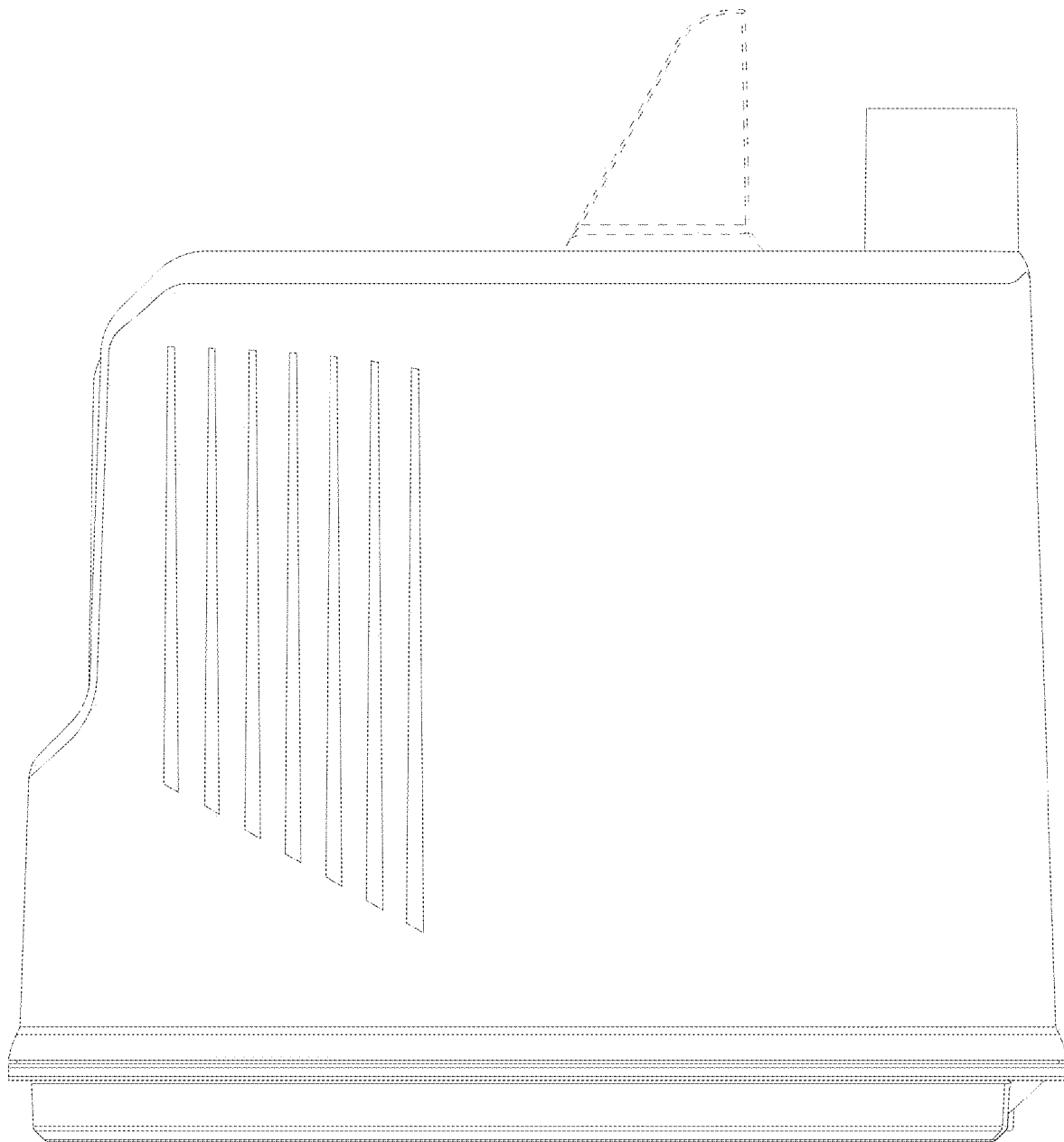
