(57) **CLAIM**

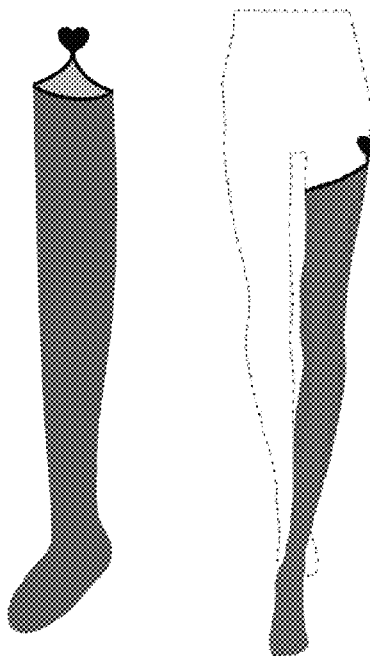
The ornamental design for a thigh-high stocking, as shown

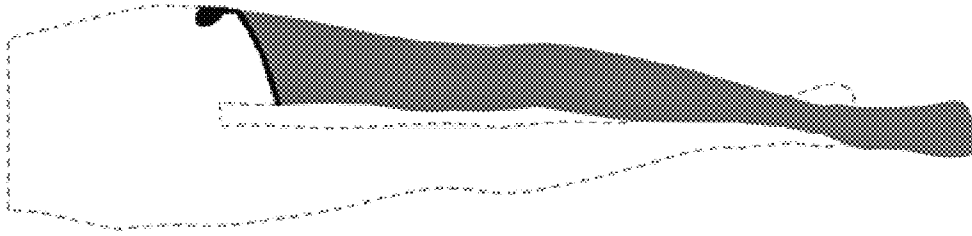

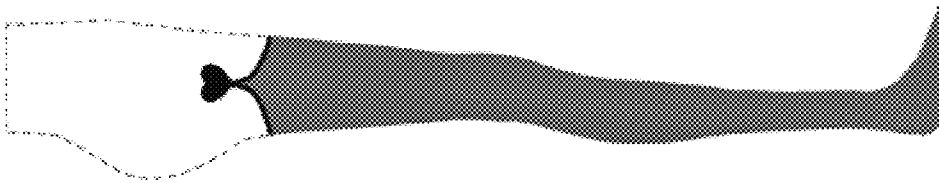
