(57) **CLAIM**

The ornamental design for an extendable and collapsible umbrella case, as shown and described.

DESCRIPTION

FIG. 1 is a front left top perspective view of the extendable and collapsible umbrella case closed and in extended form illustrating the novel design.

FIG. 2 is a front left top perspective view of the extendable and collapsible umbrella case open and in extended form of FIG. 1.

FIG. 3 is a front left top perspective view of the extendable and collapsible umbrella case closed and in resting form of FIG. 1.

FIG. 4 is a front left top perspective view of the extendable and collapsible umbrella case open and in resting form of FIG. 1.

FIG. 5 is a top view of the extendable and collapsible umbrella case closed and in extended form of FIG. 1.

FIG. 6 is a front view of the extendable and collapsible umbrella case closed and in extended form of FIG. 1.

FIG. 7 is a front cross-sectional view shown along line 7-7 of FIG. 5;

FIG. 8 is rear view of the extendable and collapsible umbrella case closed and in extended form of FIG. 1.

FIG. 9 is both a right and left side view with the rear of the case at the top of the figure of the extendable and collapsible umbrella case closed and extended form of FIG. 1.

FIG. 10 is top view of the extendable and collapsible umbrella case closed and in resting form of FIG. 1.

FIG. 11 is a front view of the extendable and collapsible umbrella case closed and in resting form of FIG. 1.

FIG. 12 is a front cross-sectional view shown along line 12-12 of FIG. 10;

FIG. 13 is rear view of the extendable and collapsible umbrella case closed and in resting form of FIG. 1.

FIG. 14 is both a right and left side view with the rear of the case at the top of the figure of the extendable and collapsible umbrella case closed and in resting form of FIG. 1.

FIG. 15 is a front left top perspective view of the extendable and collapsible umbrella case closed and in collapsed form of FIG. 1.

FIG. 16 is a front left top perspective view of the extendable and collapsible umbrella case open and in collapsed form of FIG. 1.

FIG. 17 is top view of the extendable and collapsible umbrella case closed and in collapsed form of FIG. 1.


FIG. 18 is a front view of the extendable and collapsible umbrella case closed and in collapsed form of FIG. 1.




























