
(57) **CLAIM**

The ornamental design for a wipes dispensing container and receptacle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right-side perspective view of a wipes dispensing container and receptacle, showing my new design; FIG. 2 is a left-side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof having a right side of identical design; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.














