(54) Title: METHOD, APPARATUS AND PROGRAM PRODUCT FOR MULTIPLE PLAY BONUS SYSTEM

(57) Abstract: A gaming system (100) provides a secondary game in which the outcome depends on the results from multiple instances of a primary game. The secondary game is associated with a particular structure that includes a number of separate locations (502). Each of the secondary game locations (502) is linked to a particular instance of the primary game so that the results of a particular instance of the primary game determine the condition or state of a respective secondary game location (502). Additionally, each location (502) in the secondary game structure makes up a certain component of a secondary game display. Players receive an award if a certain pattern is displayed in the secondary game structure based on the application of the multiple instances of the primary game to the secondary game structure.
