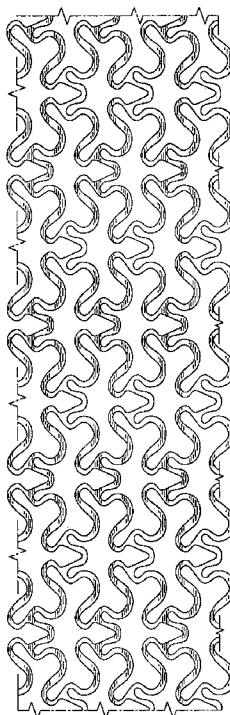
(57) **CLAIM**

The ornamental design for material for an expandable stent, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of material for an expandable stent showing my new design. The material is of no appreciable thickness. The broken lines are used to indicate the boundaries of the repeatable surface pattern and form no part of the claimed design.

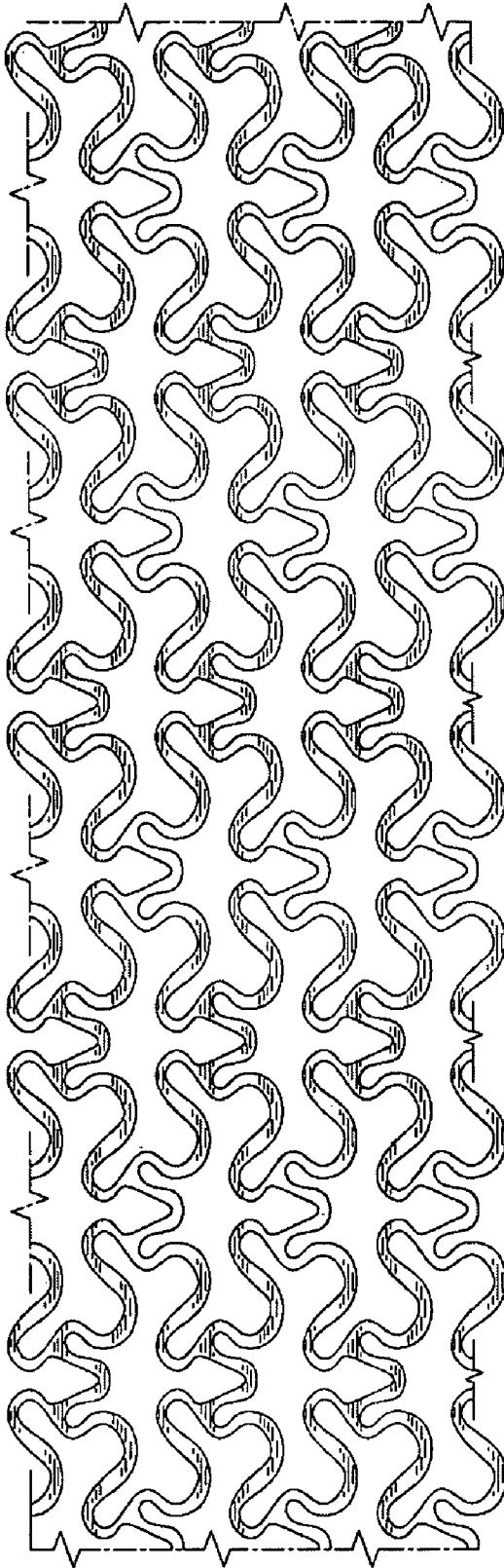
