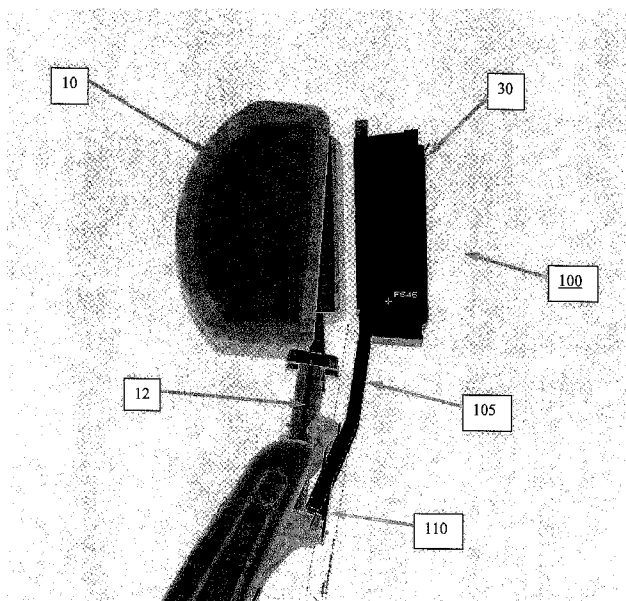

(57) Abstract: An entertainment system for a vehicle seat comprises a support structure mounted to a frame of the vehicle seat, and a media unit mounted to the support structure, wherein the support structure includes a frame positioned behind and spaced apart from a headrest of the vehicle seat. The support structure frame includes a plurality of bends to position the support structure frame away from the headrest.
