DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a portable data collector showing my new design;

FIG. 2 is a top, rear and right side perspective view thereof;

FIG. 3 is a bottom, front and left side perspective view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a left side elevational view thereof;



FIG. 7 is a right side elevational view thereof;

















