DESCRIPTION

FIG. 1 is a top front perspective view of a staircase showing our new design;

FIG. 4 is a left side view thereof;

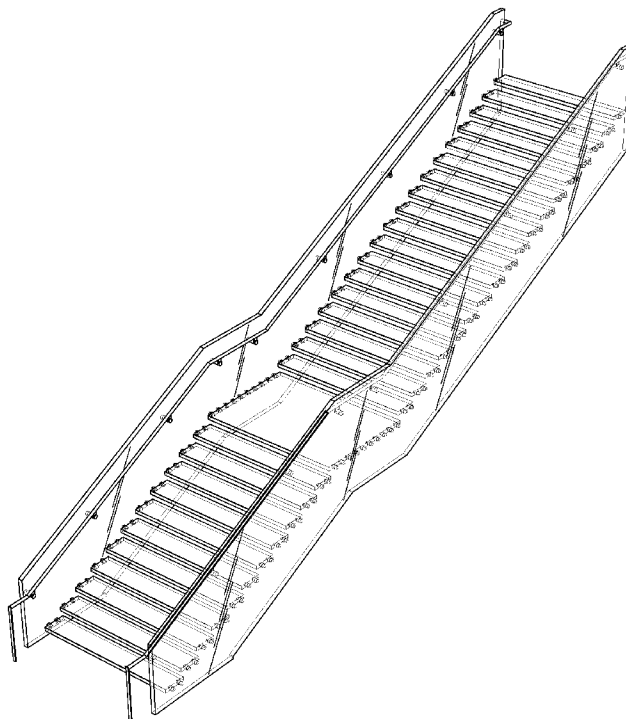
FIG. 5 is a right side view thereof;

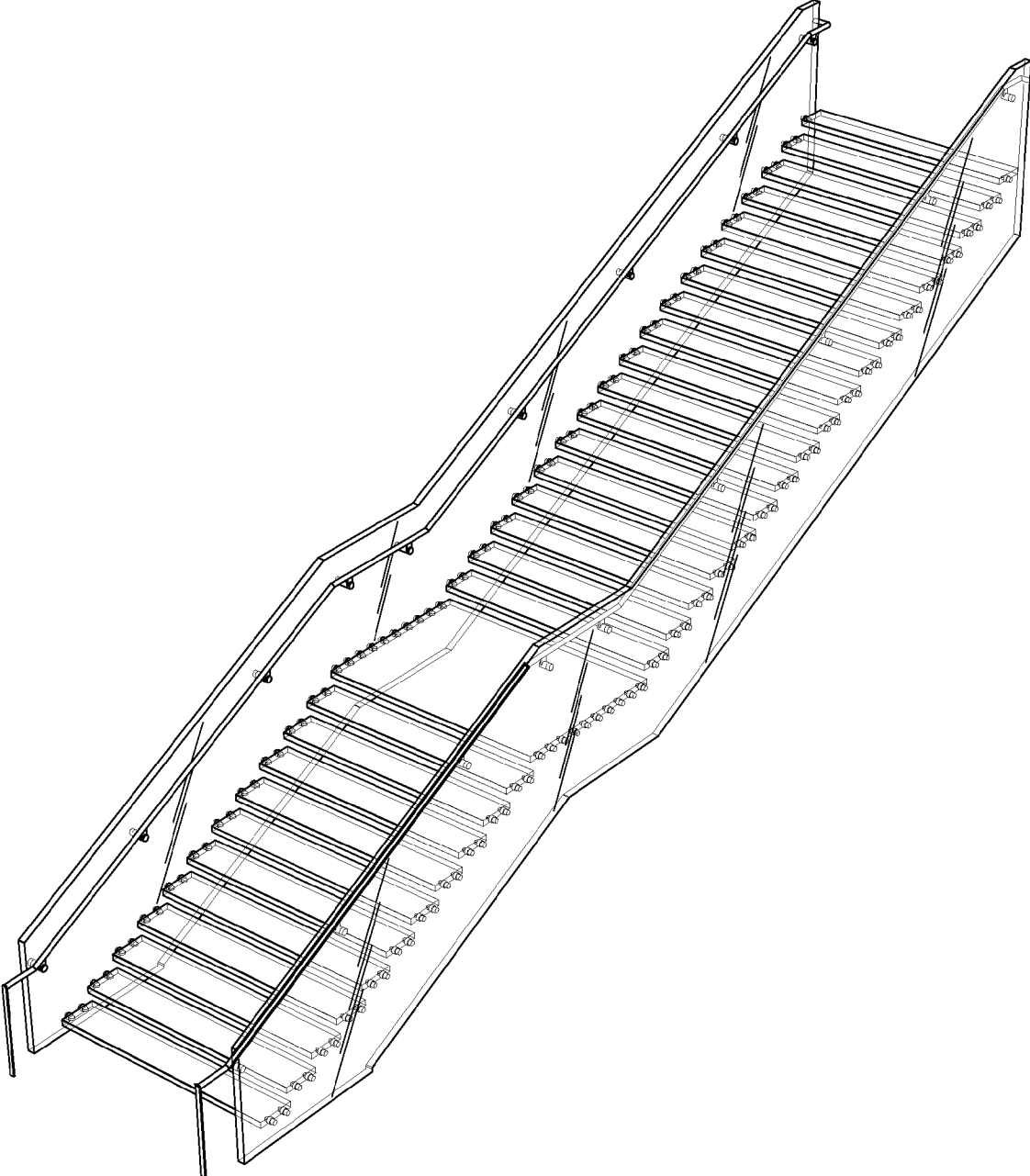

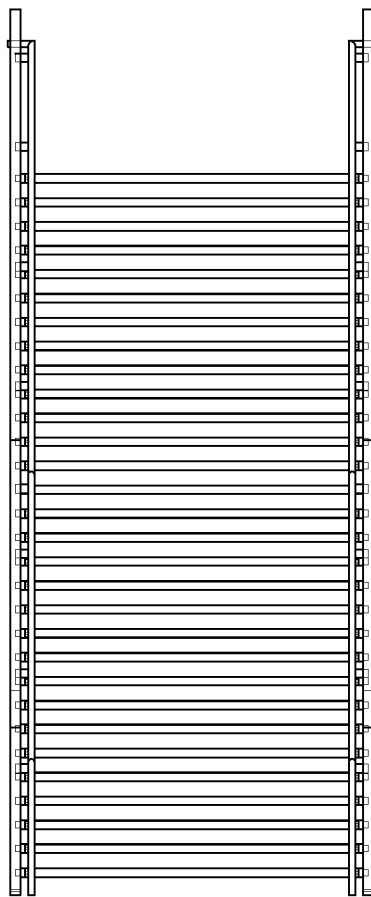

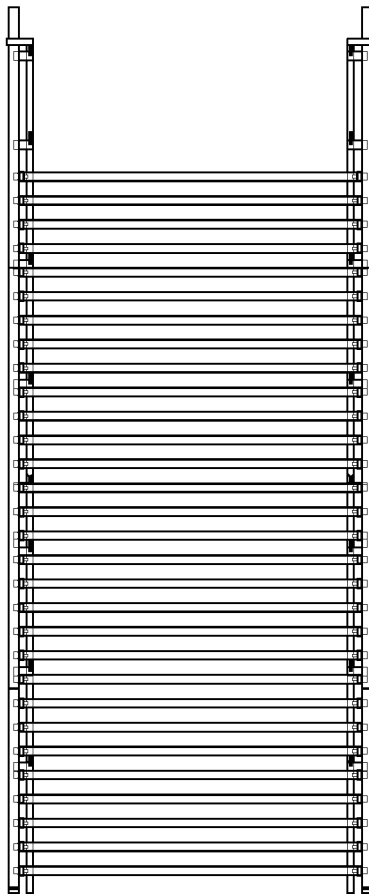

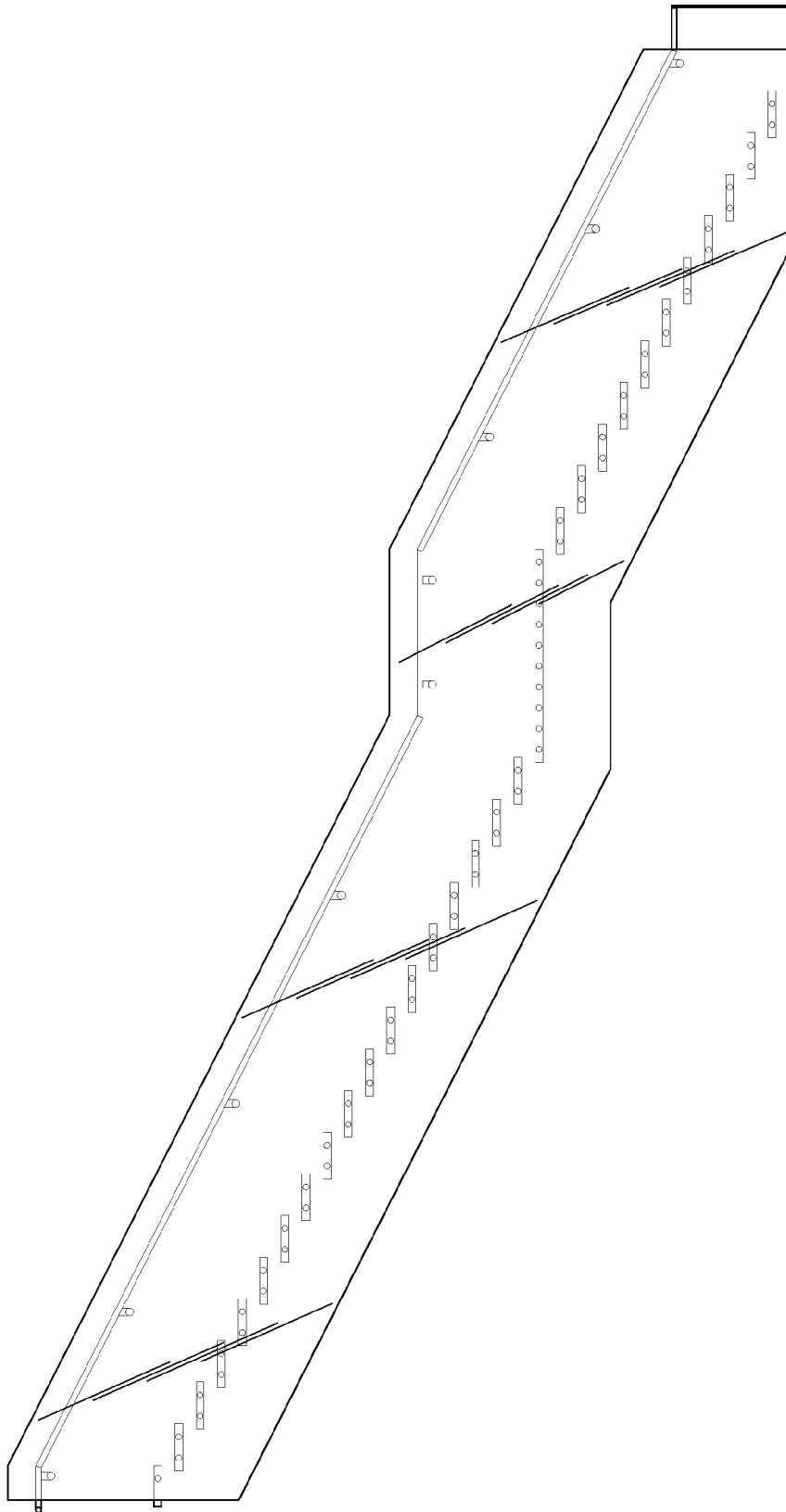

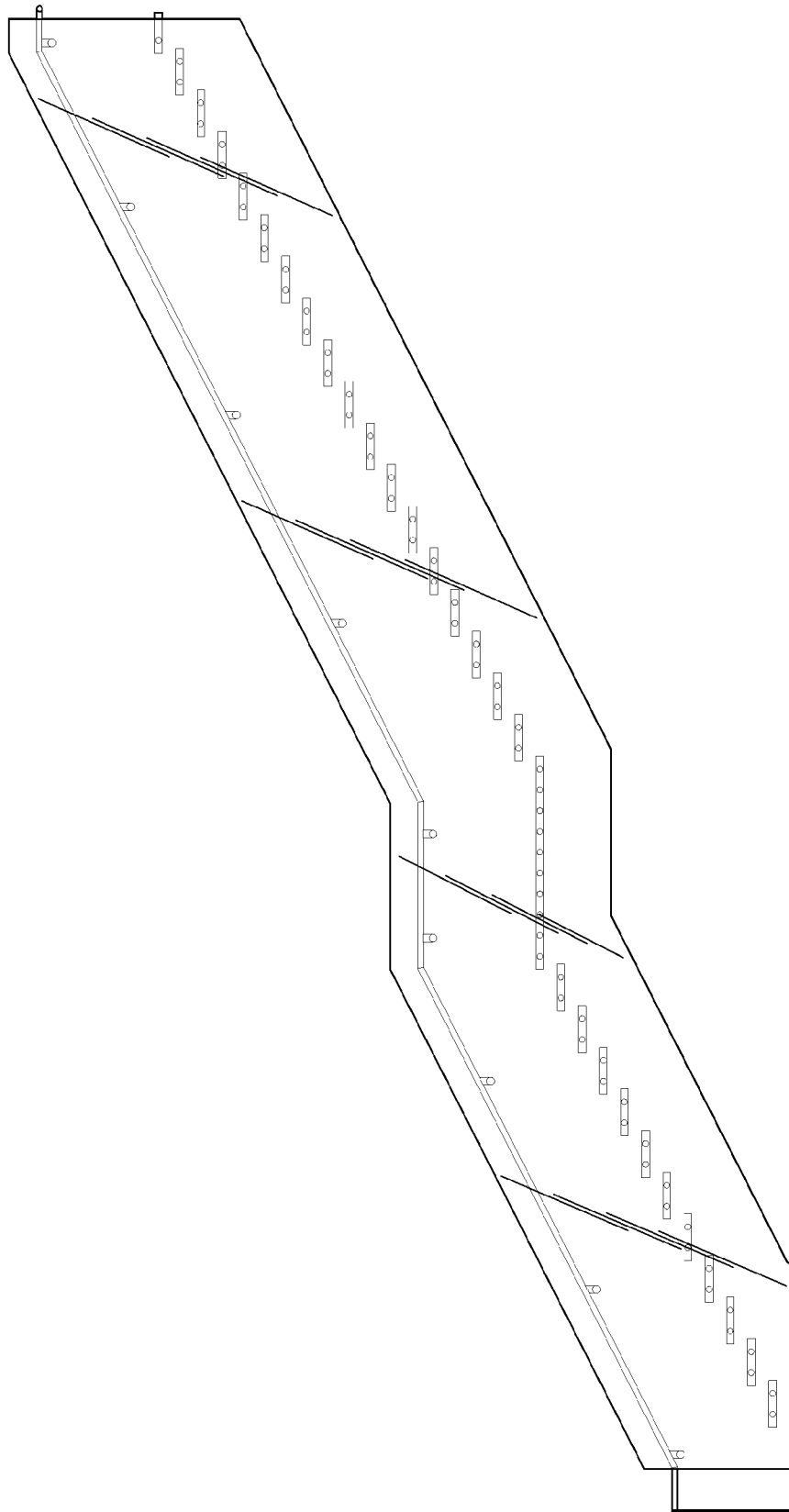

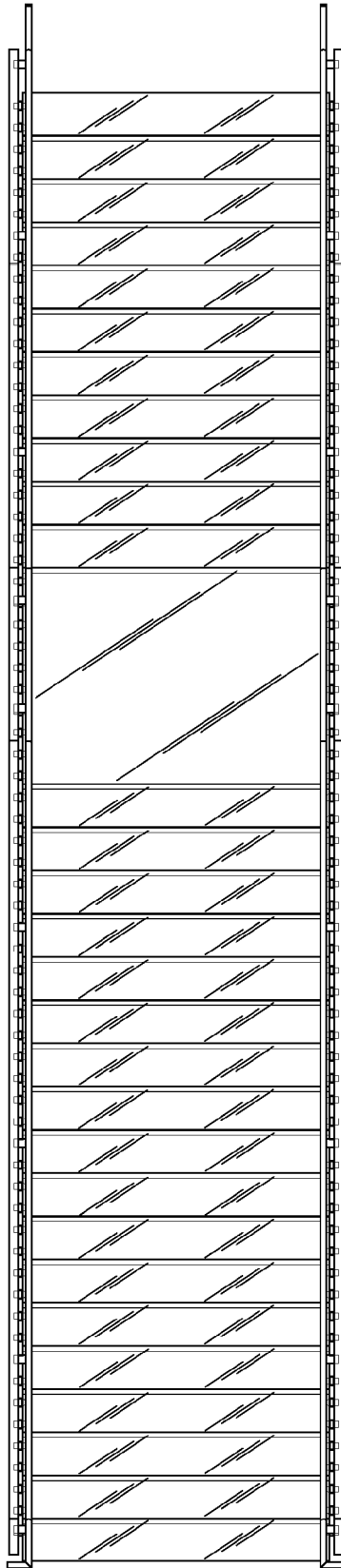

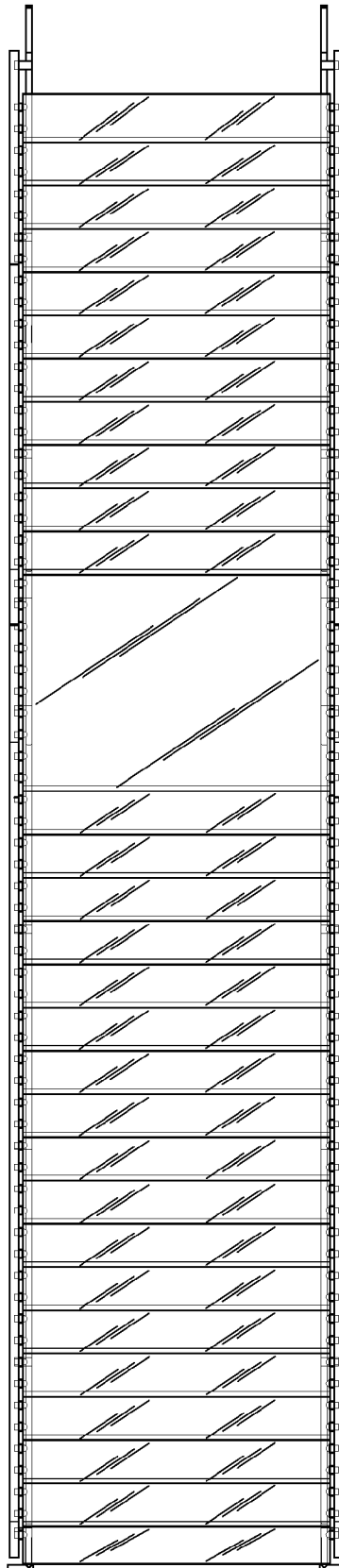
