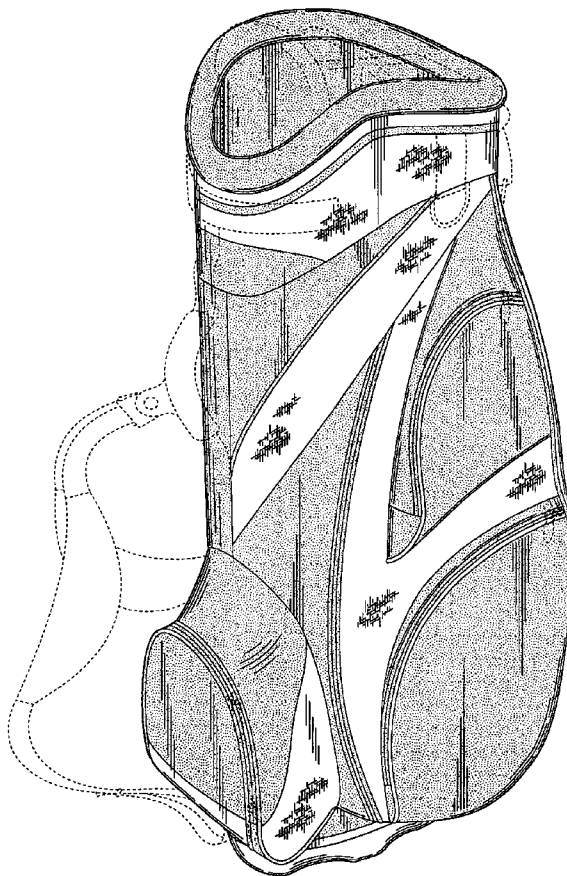

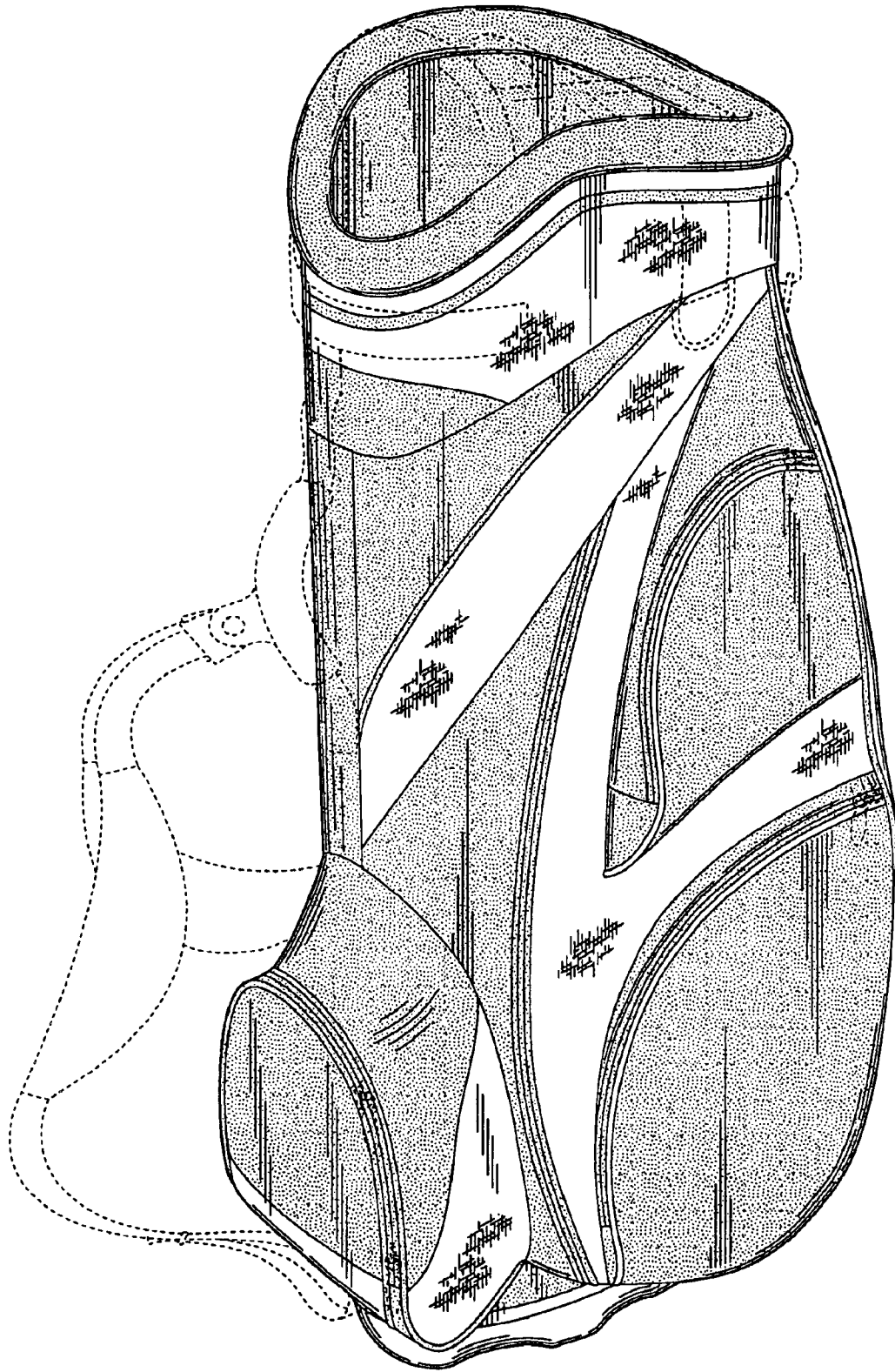
The ornamental design for a golf bag, as shown and described.

**DESCRIPTION**

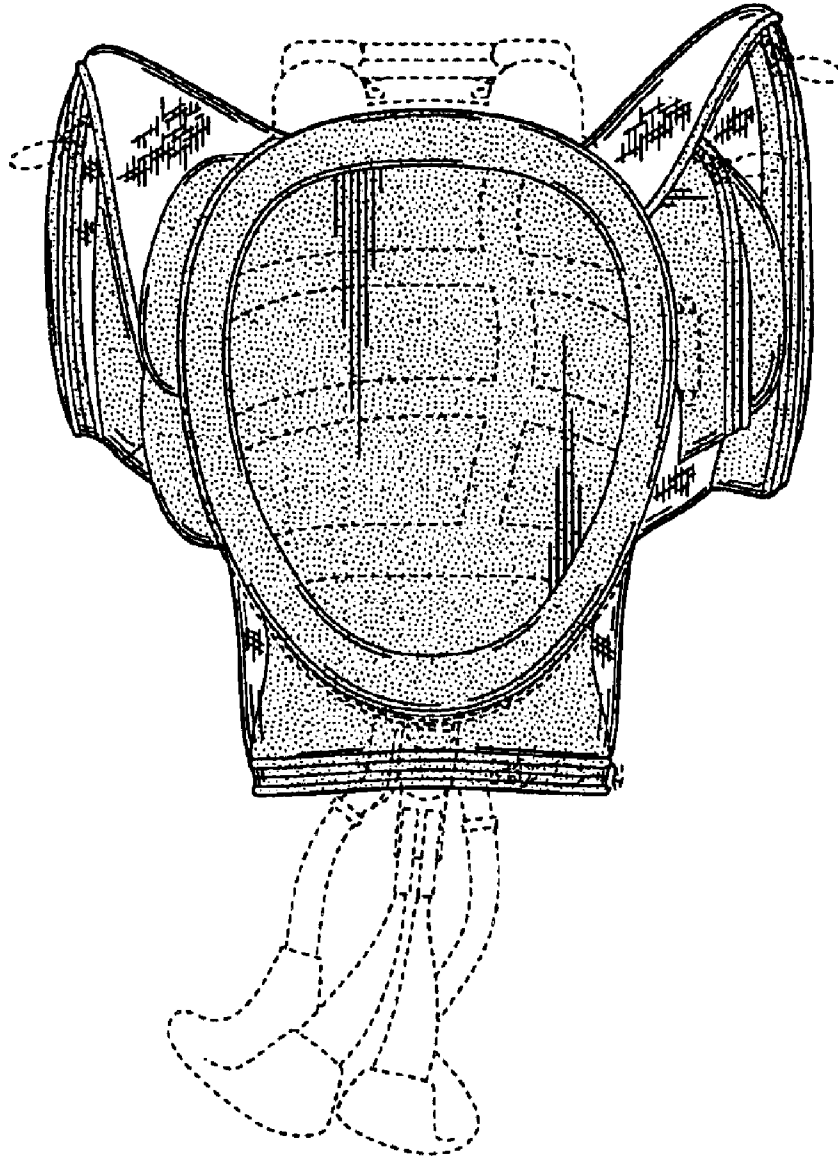

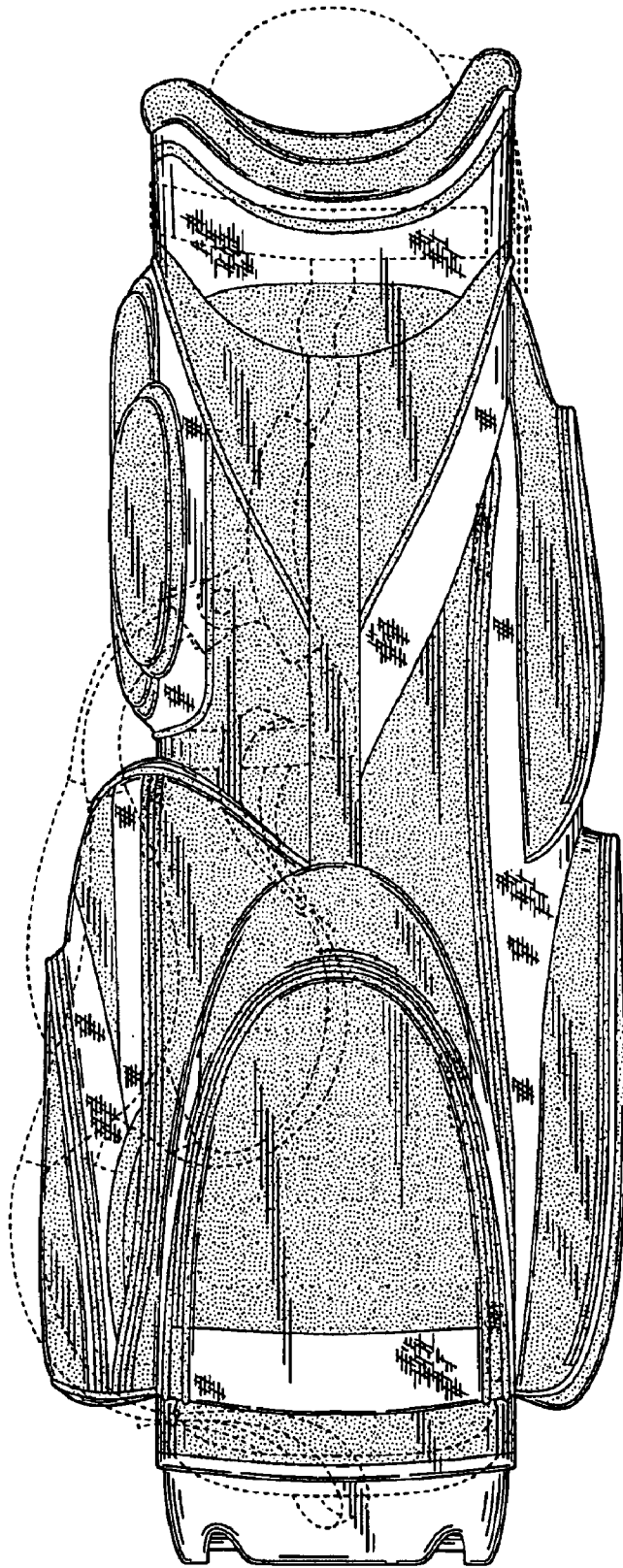




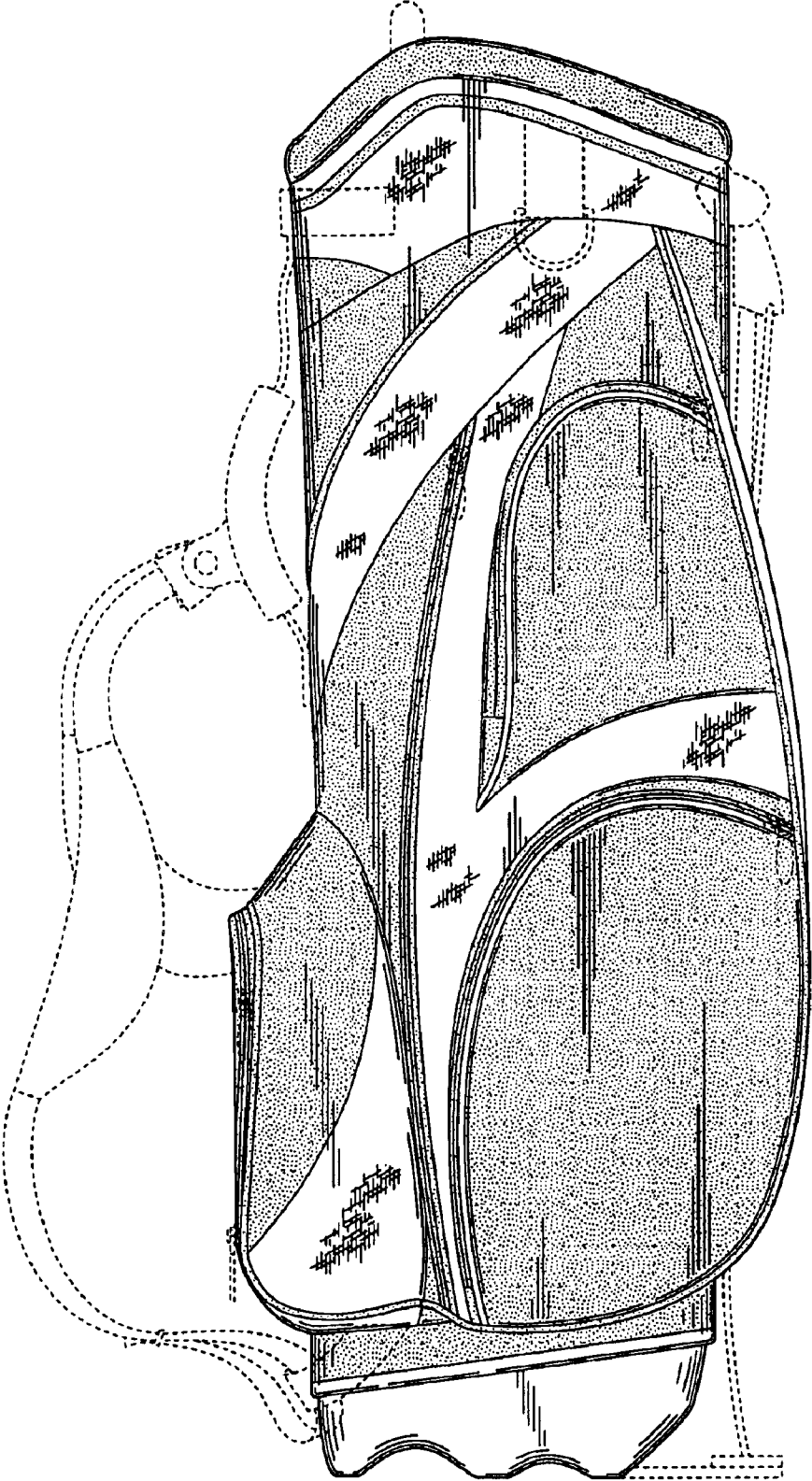

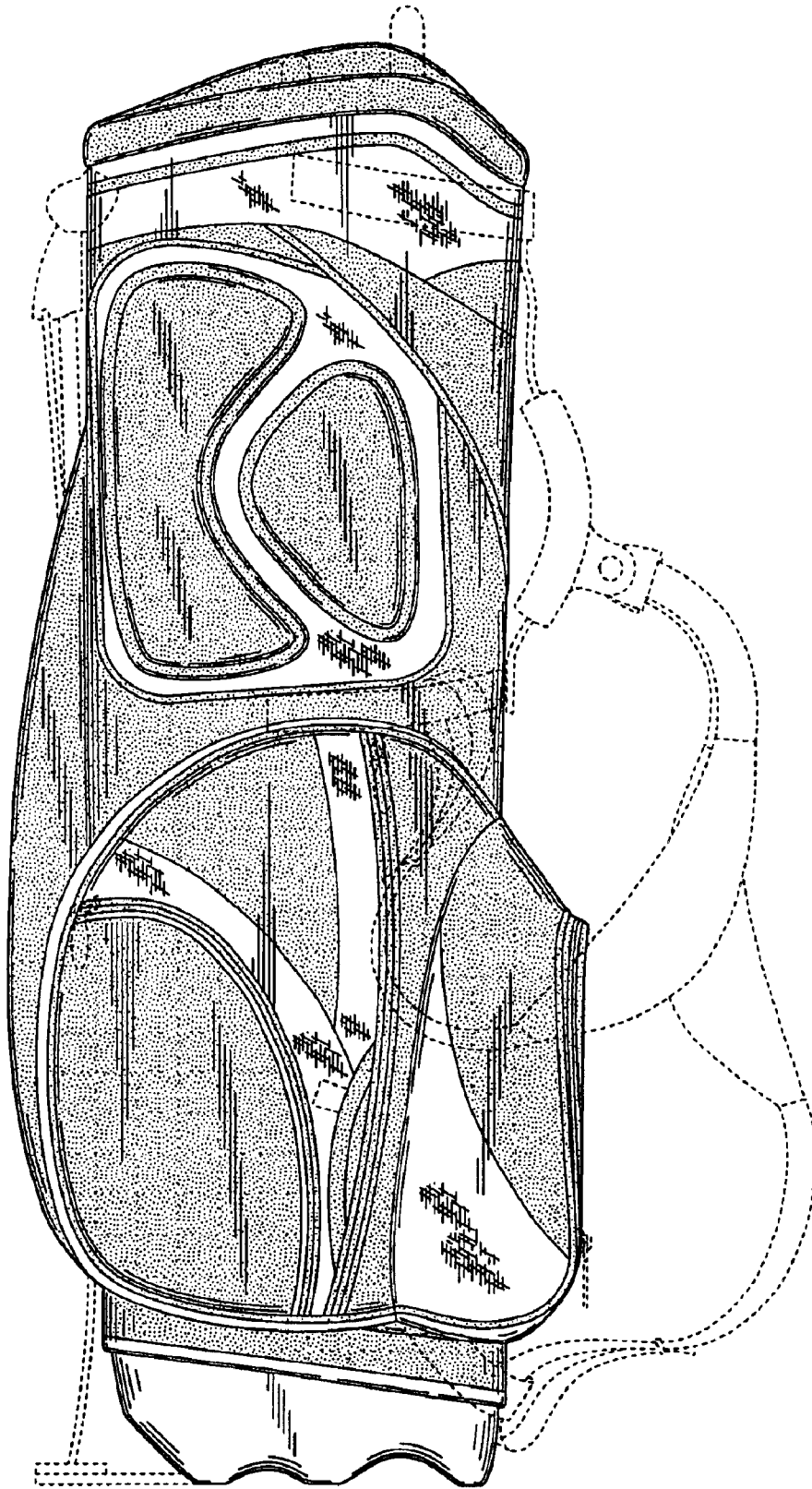

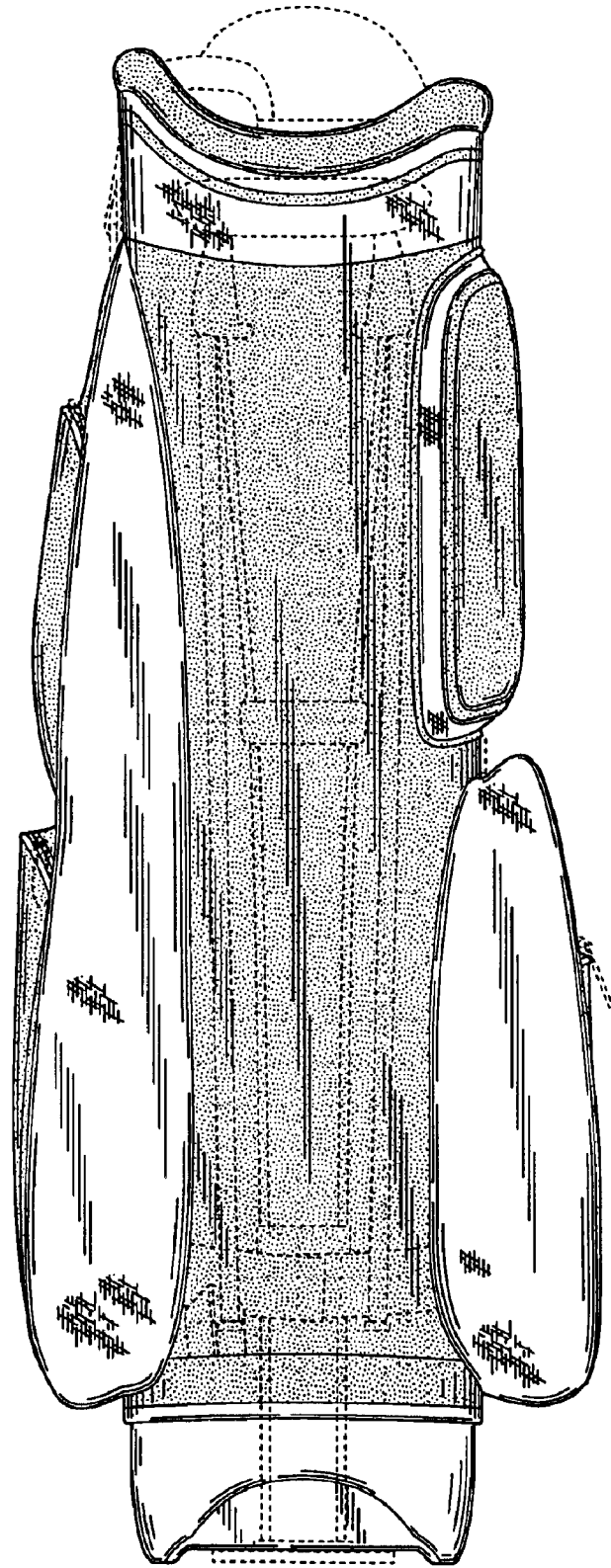
