DESCRIPTION

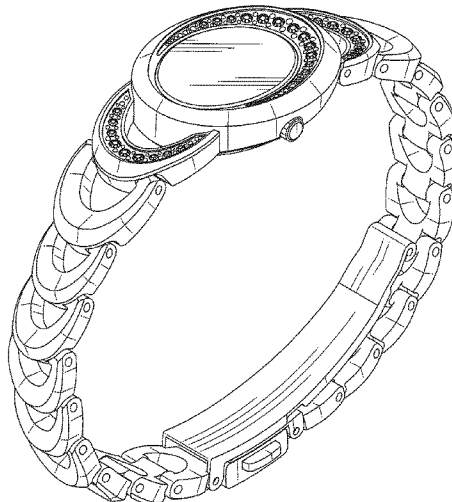

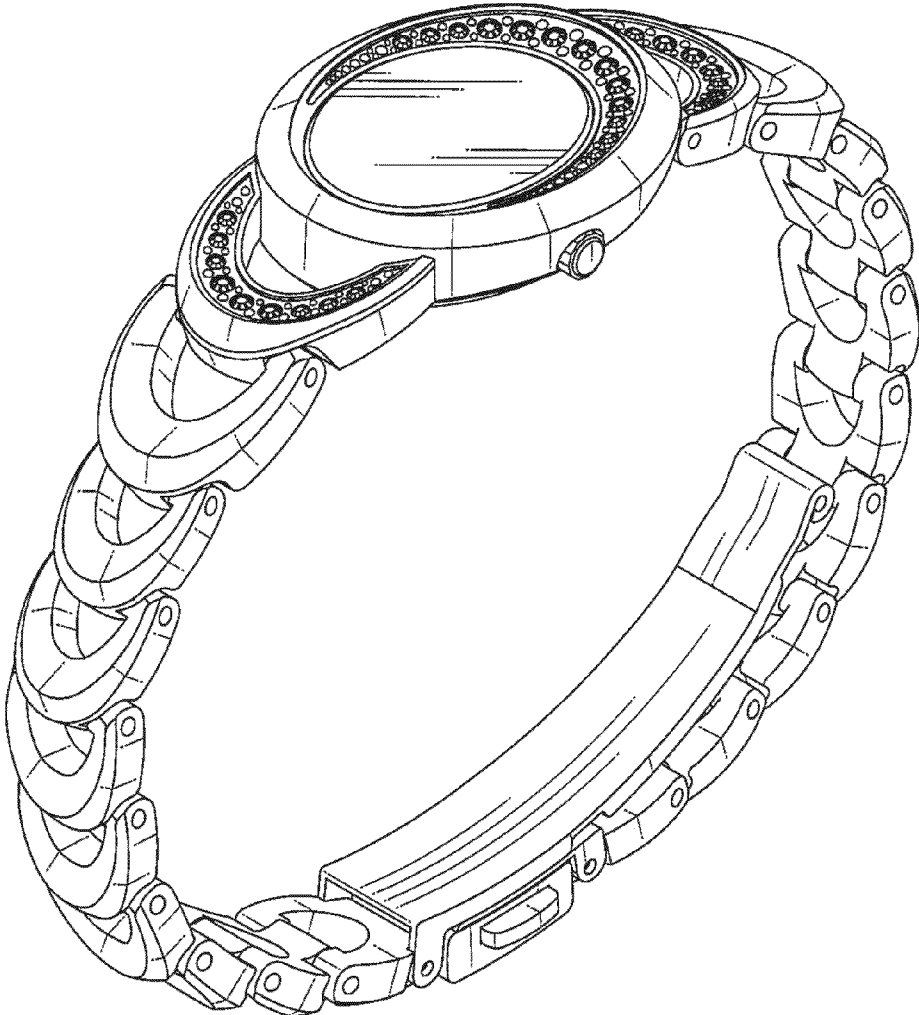

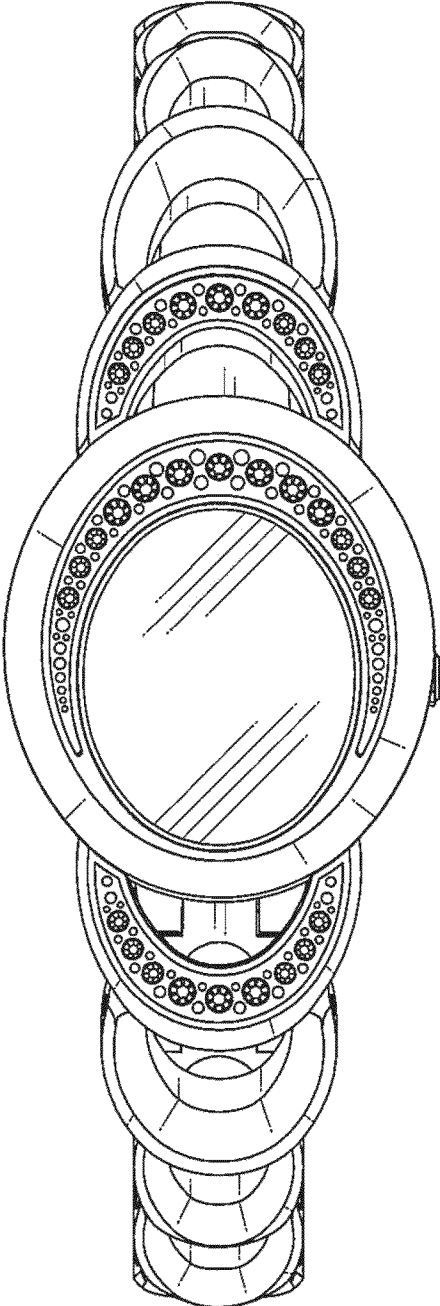

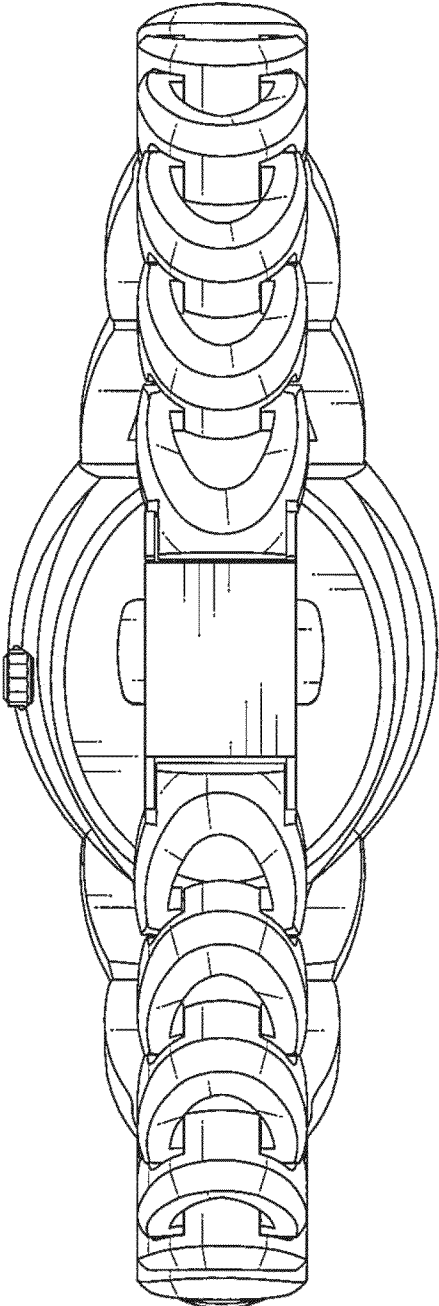

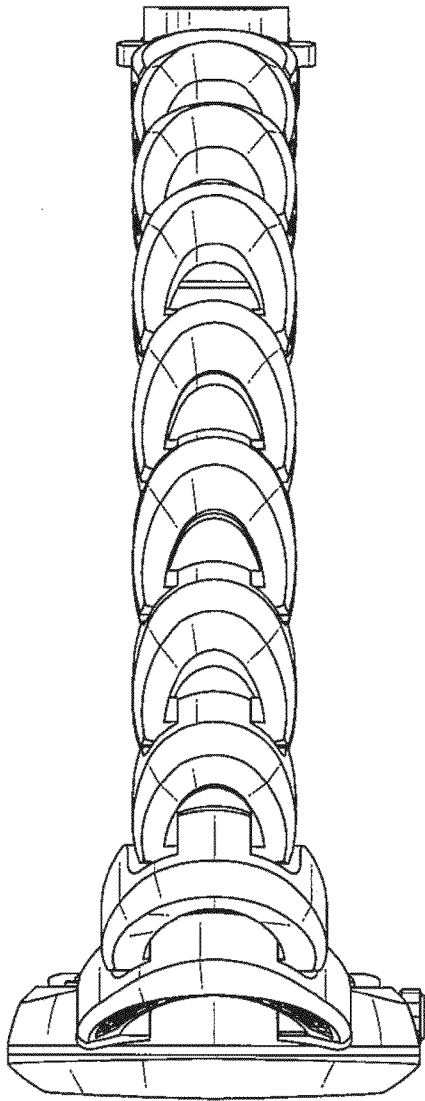

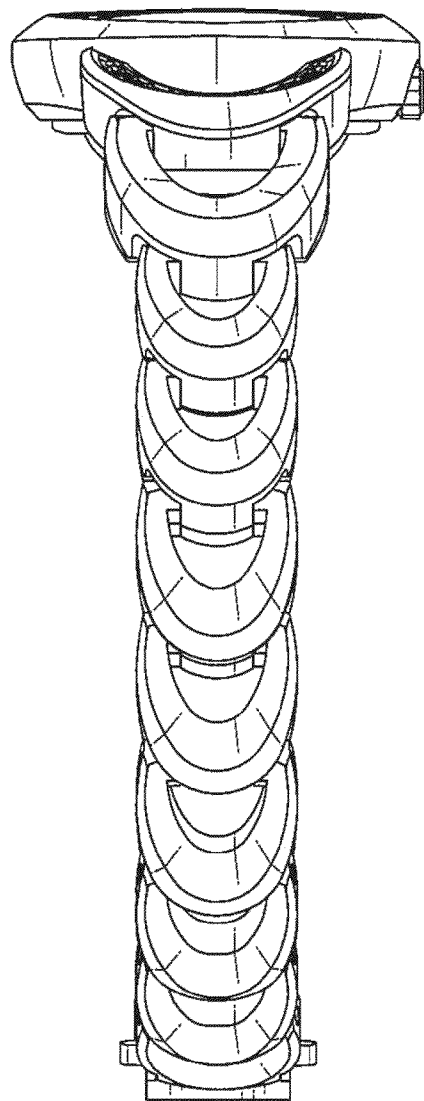

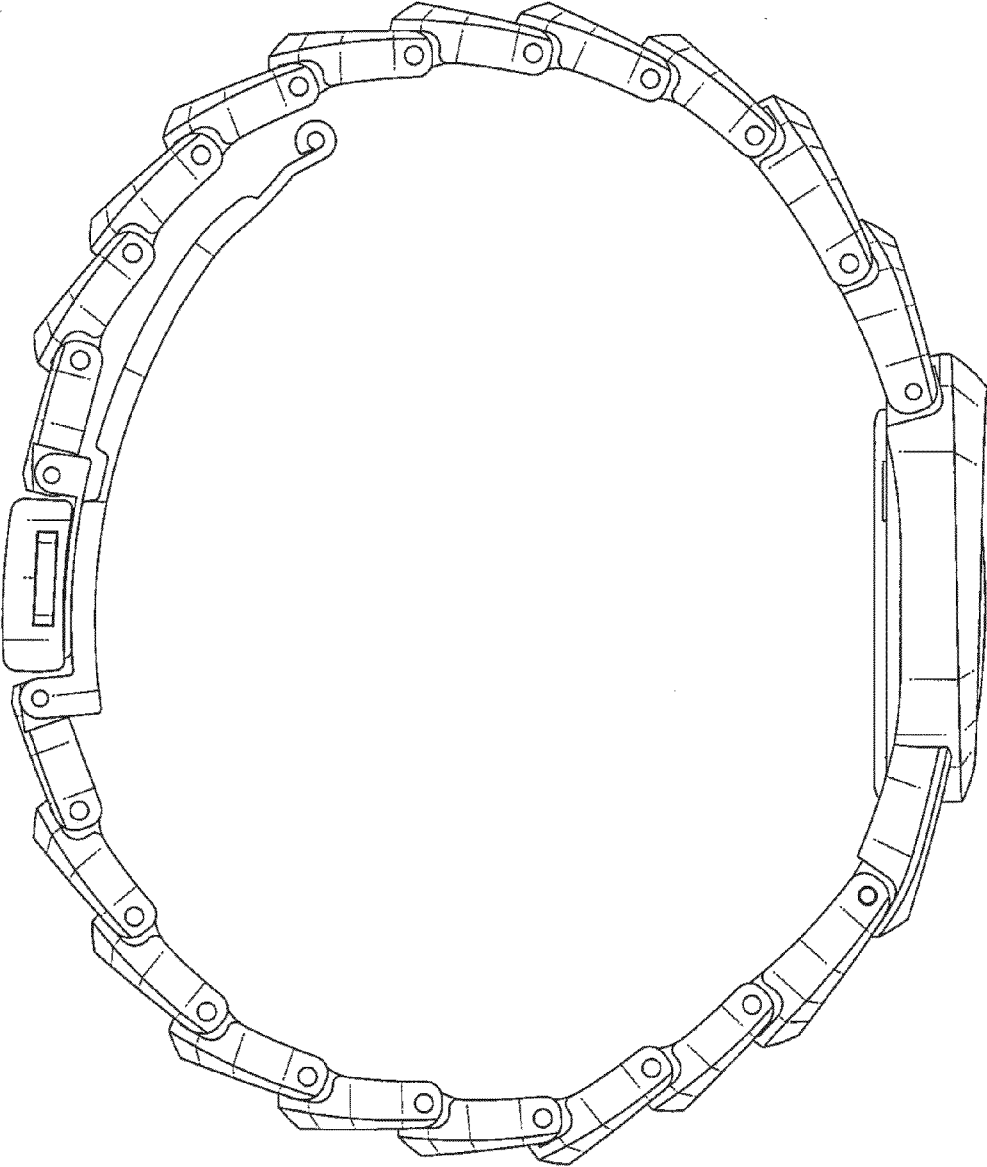

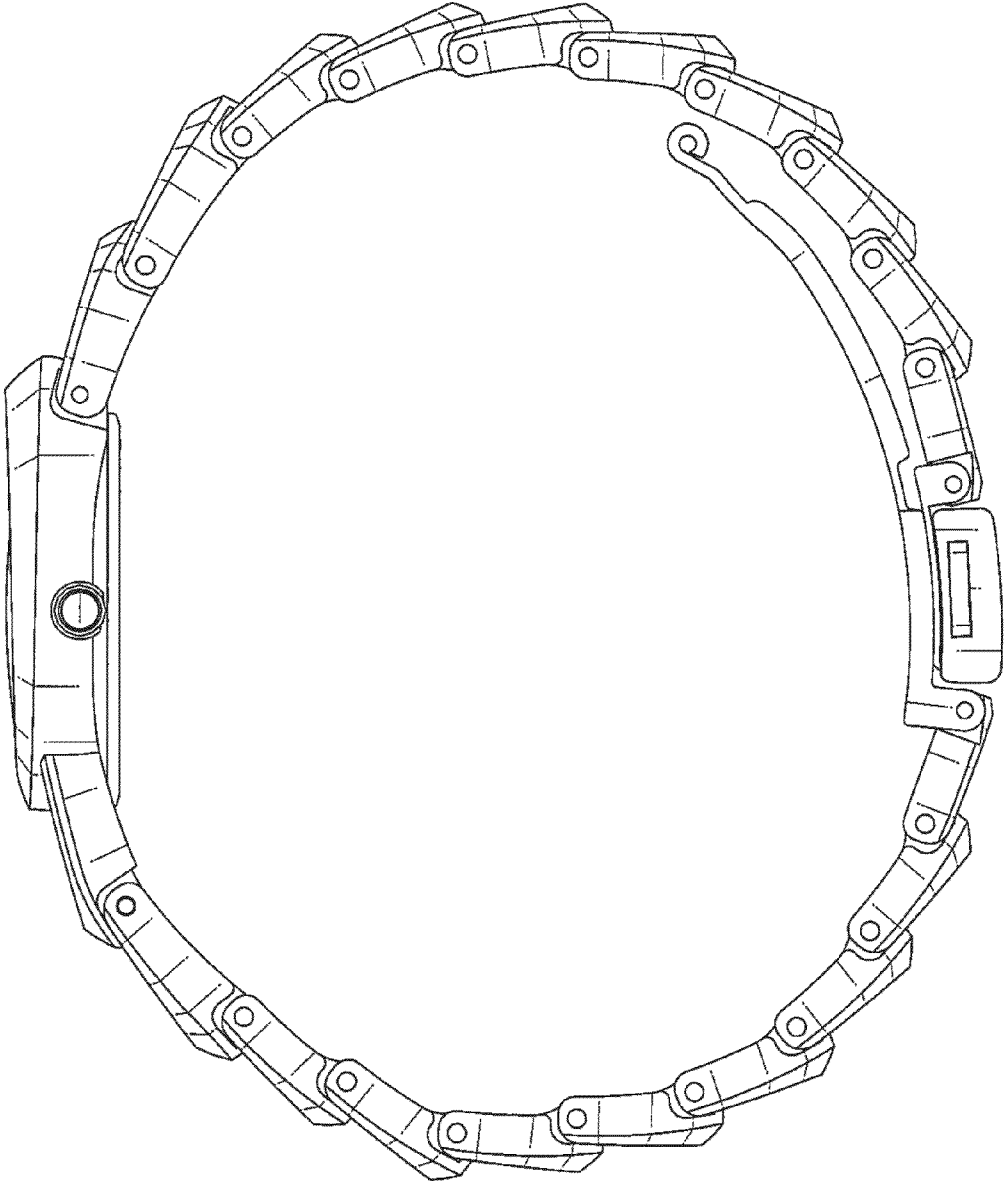

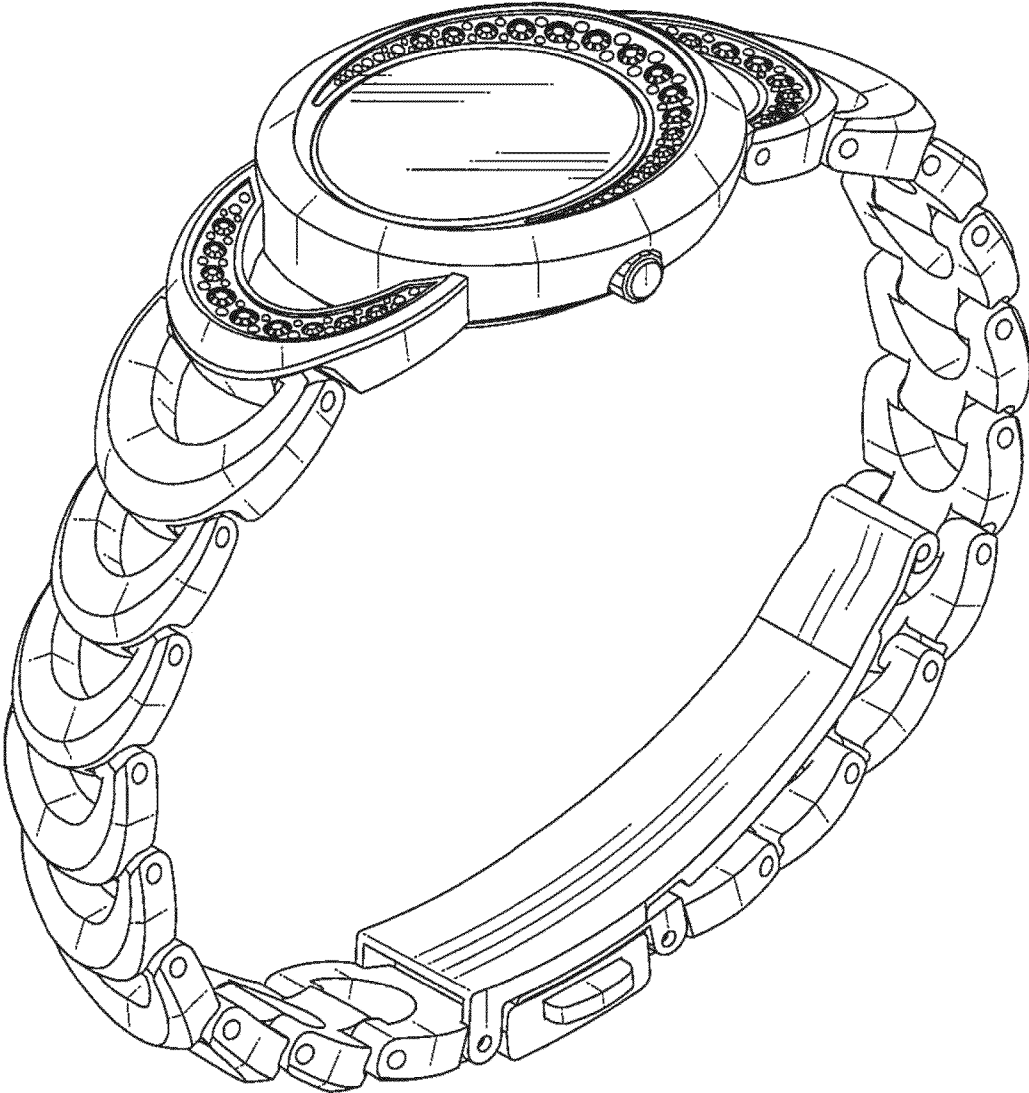

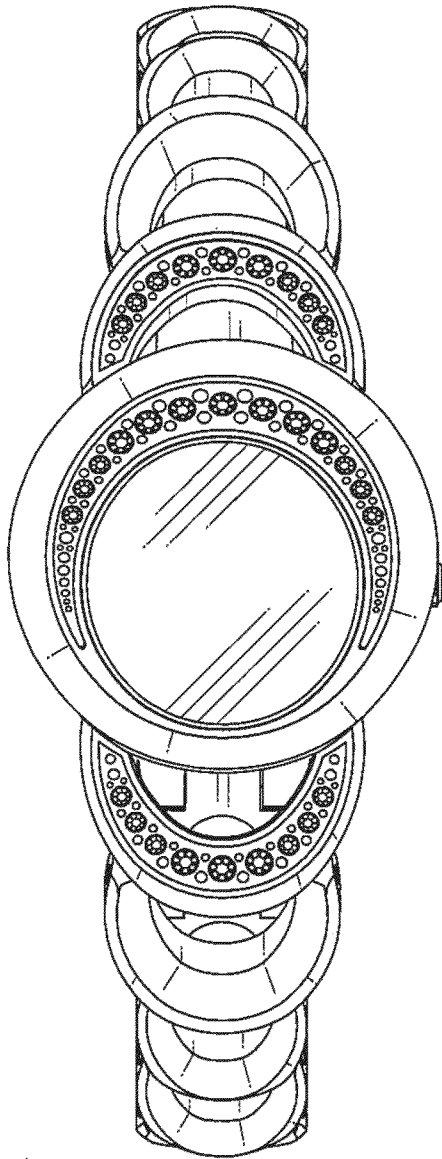

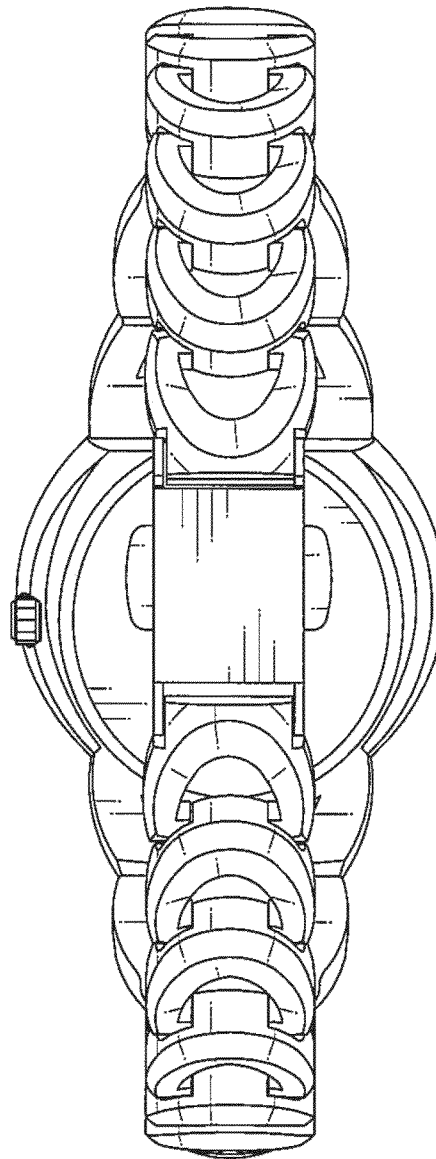

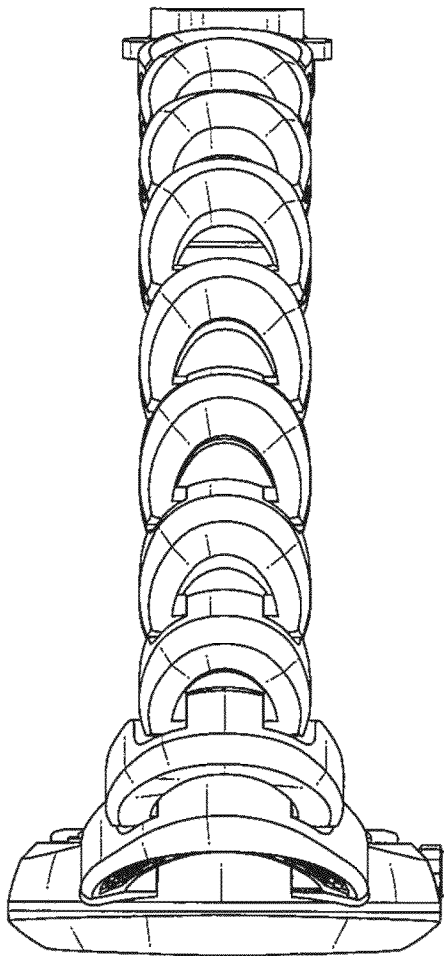

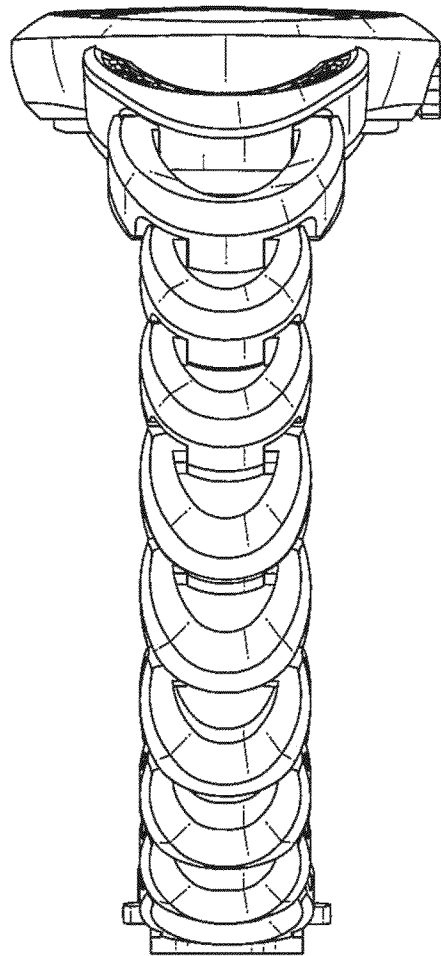

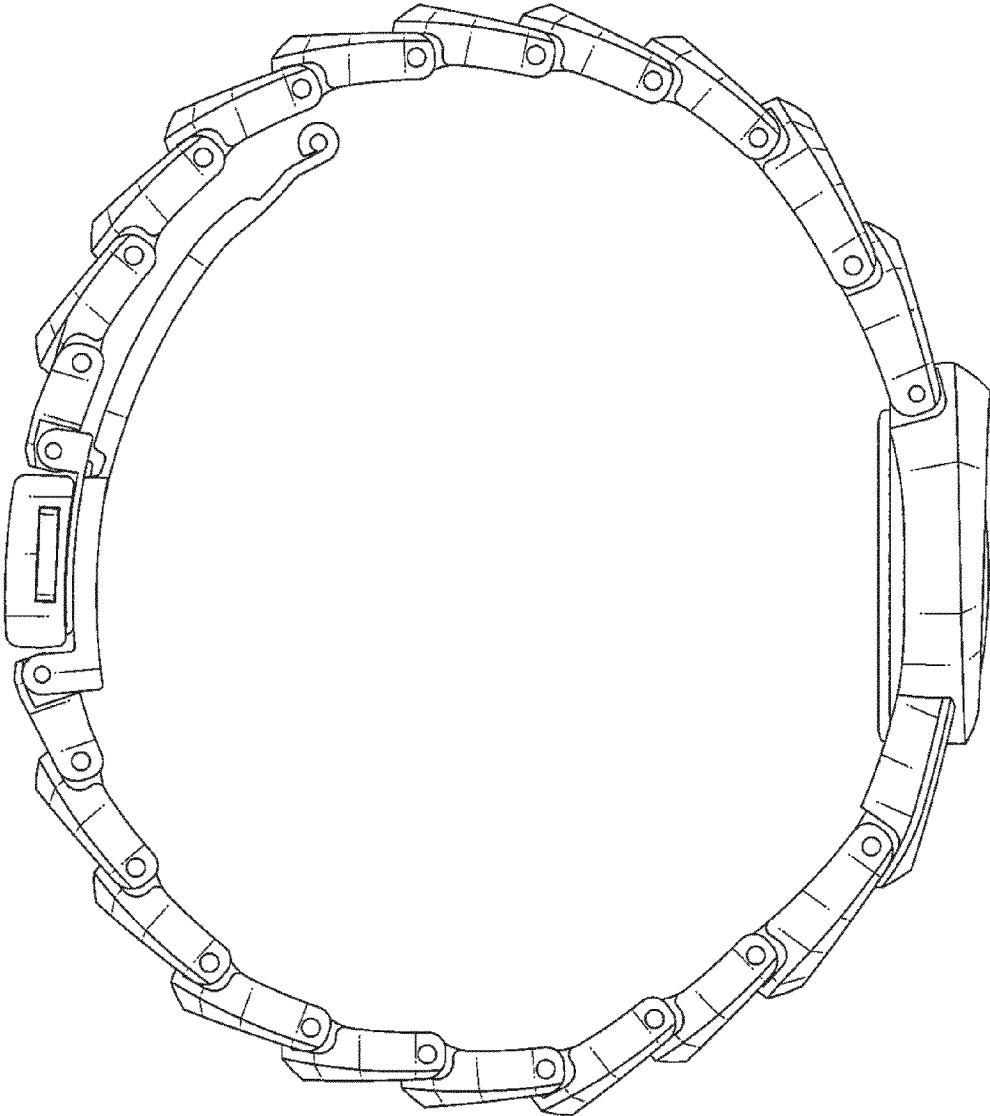
