(57) **CLAIM**

The ornamental design for a bar mat, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a bar mat showing our new design;

FIG. 2 is a rear elevation view of the bar mat of FIG. 1;

FIG. 3 is a left side elevation view of the bar mat of FIG. 1; the right side elevations views being a mirror image thereof;


FIG. 4 is a top view of the bar mat of FIG. 1; the bottom view being a mirror image thereof;

FIG. 5 is a sectional view of the bar mat of FIG. 1, taken in the direction of line 5-5 on FIG. 1;

FIG. 6 is a sectional view of the bar mat of FIG. 1, taken in the direction of line 6-6 on FIG. 1; and,

FIG. 7 is a sectional view of the bar mat of FIG. 1, taken in the direction of line 7-7 on FIG. 1.




