
(57) **CLAIM**

The ornamental design for a rack apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a rack apparatus; FIG. 2 is a front elevational view thereof; the rear elevational view being a mirror image; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a right side elevational view thereof; the left side elevational view being a mirror image. The ornamental design which is claimed is shown in solid lines in the drawings.










