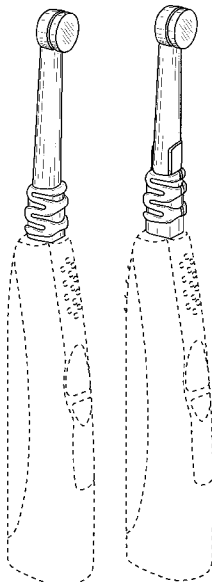
The ornamental design for a toothbrush, as shown and described.

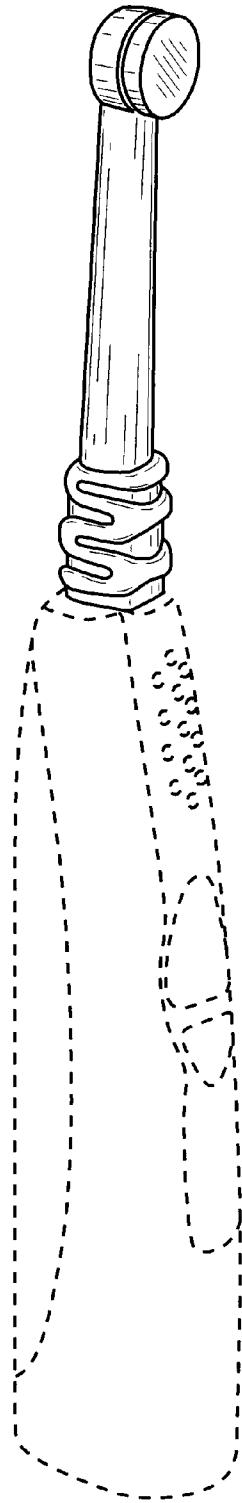
**DESCRIPTION**

 FIG. 12 is a bottom plan view of FIG. 7.

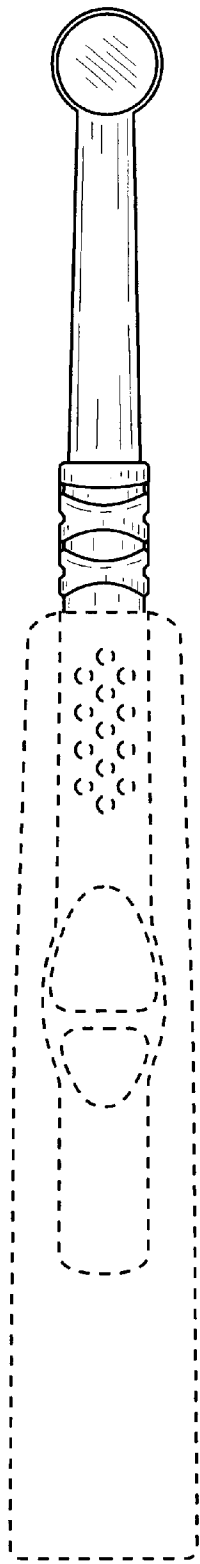
The portion of the toothbrush that is shown in broken lines in both embodiments is for illustrative purposes only and forms no part of the claimed design.

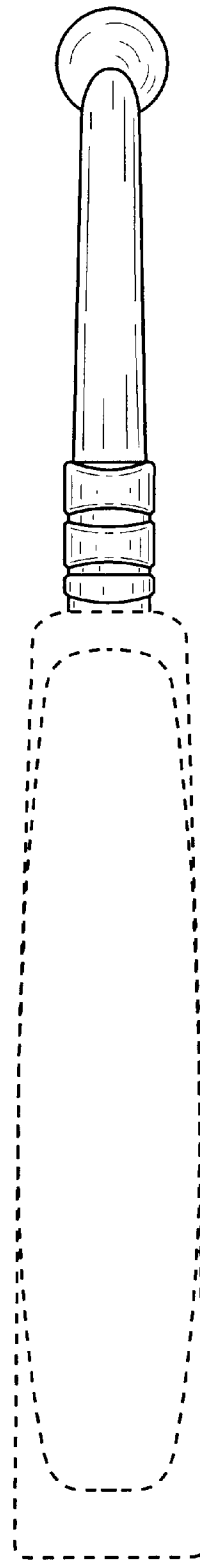




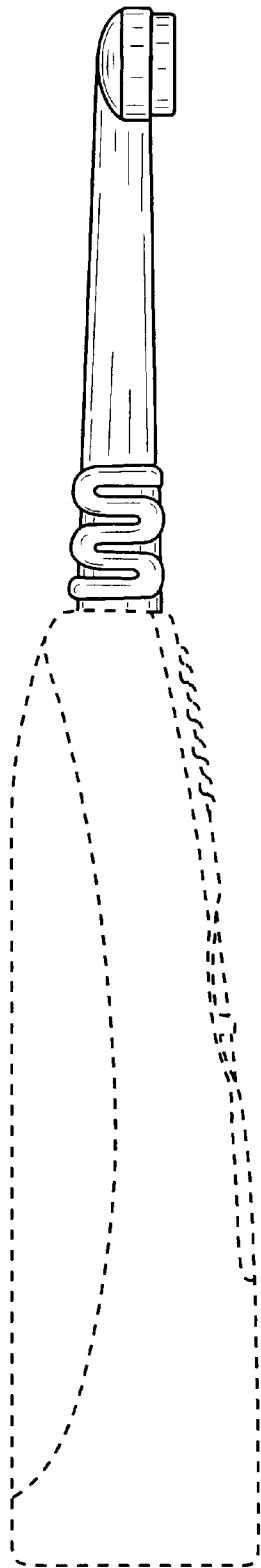

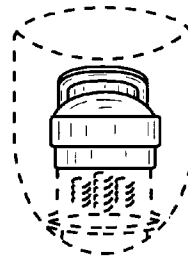

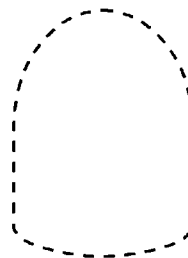

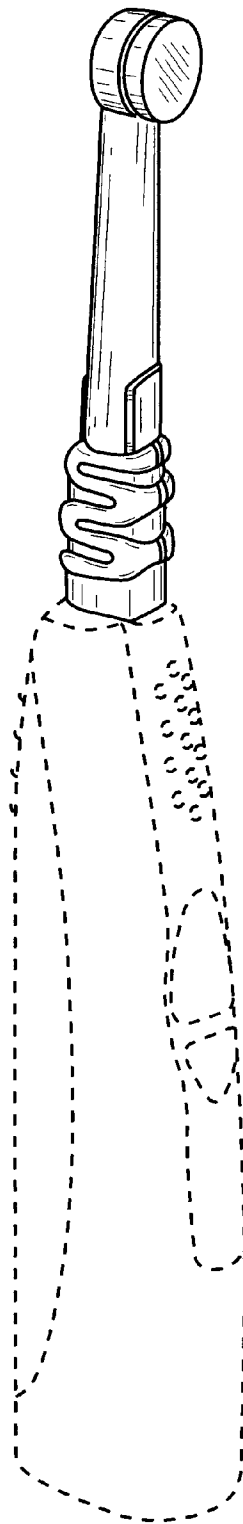

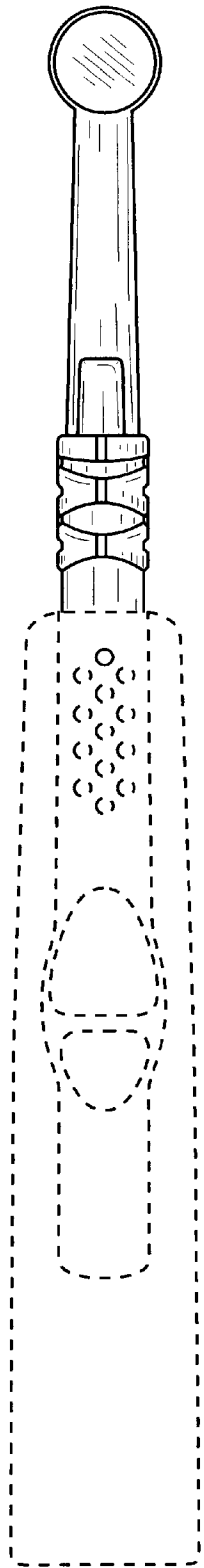

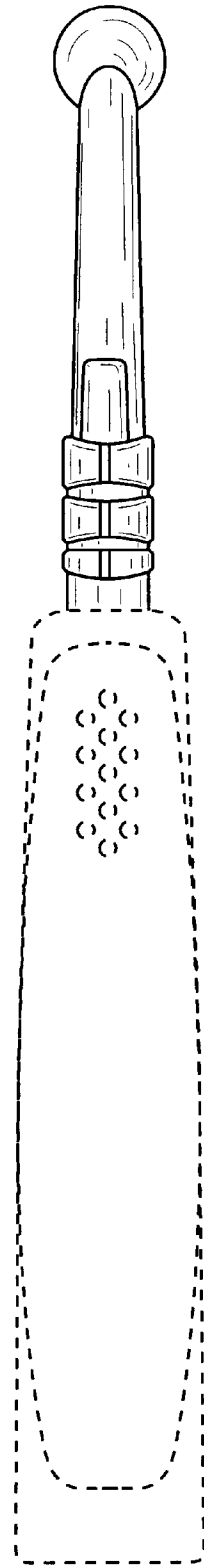

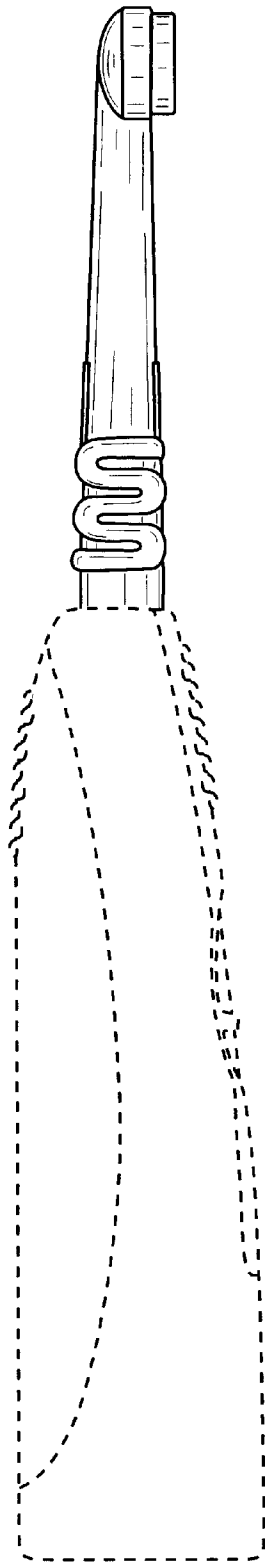

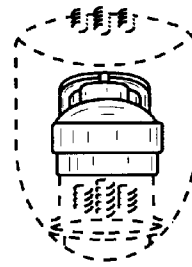

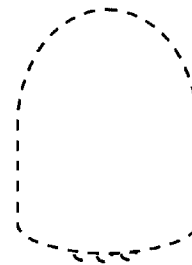
