The ornamental design for a ceiling fan blade, as shown and
described.

DESCRIPTION

FIG. 1 is a top perspective view of a ceiling fan blade in the
environment of a ceiling fan;
 FIG. 2 is a bottom perspective view of the ceiling fan blade
of FIG. 1, having the ceiling fan environment removed;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a rear view thereof;
 FIG. 6 is a front view thereof;
 FIG. 7 is a top view thereof; and,
 FIG. 8 is a bottom view thereof.


The broken lines illustrate portions of the ceiling fan blade
and ceiling fan environment. None of the broken lines form
part of the claimed design. The ceiling fan blades are shown
with a symbolic break in their length. The appearance of any
portion of the ceiling fan blades between the break lines
forms no part of the claimed design.










