DESCRIPTION

FIG. 1 is a front perspective view of a headboard showing my new design;

FIG. 2 is a left side elevational view, the right side being a mirror image thereof;

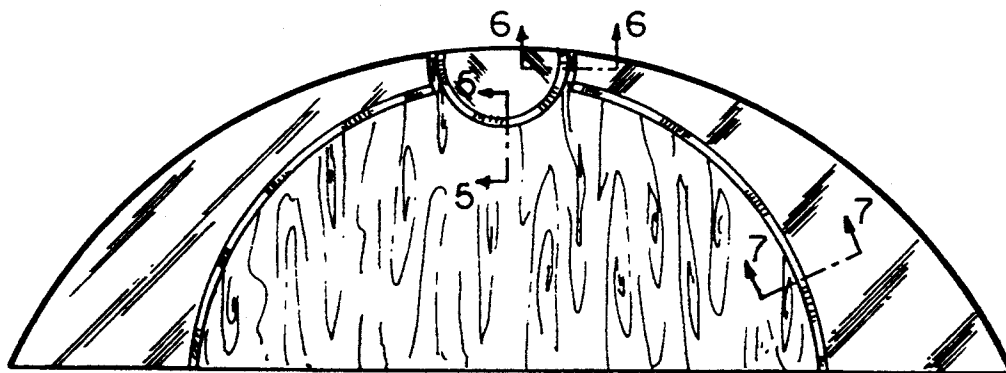
FIG. 3 is a top plan view thereof;

FIG. 7 is a cross sectional view, taken along line 7-7 in FIG. 1.



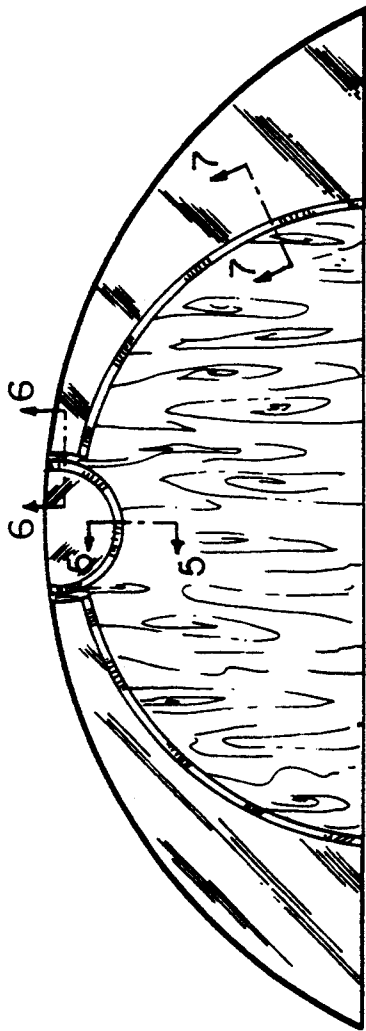
