(57) **CLAIM**

The ornamental design for a golf grip, substantially as shown and described.

**DESCRIPTION**

- FIG. 1 is a perspective view of the golf grip;
- FIG. 2 is a frontal view of the golf grip;
- FIG. 3 is a right side view of the golf grip when viewing from the front;
- FIG. 4 is a rear view of the golf grip;
- FIG. 5 is a left side view of the golf grip when viewing from the front;
- FIG. 6 is a top view of the golf grip;
- FIG. 7 is an enlarged fragmentary perspective view of the golf grip; and,
- FIG. 8 is an enlarged frontal view of the golf grip.
















