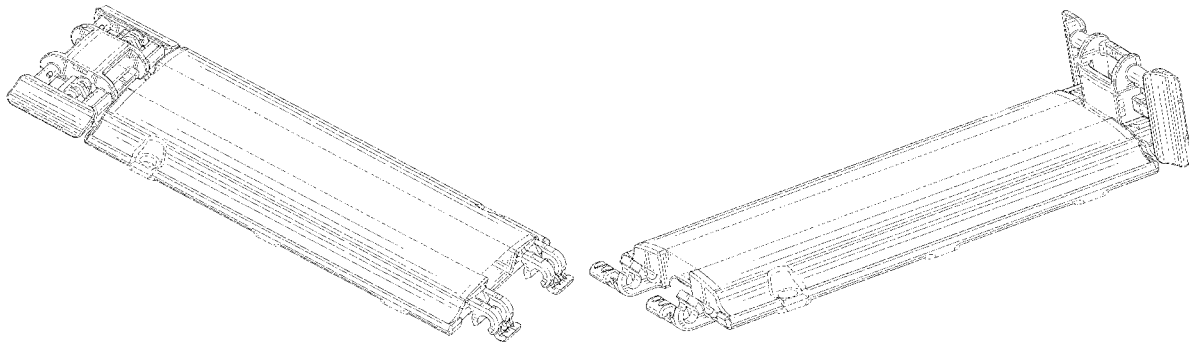
(57) **CLAIM**

The ornamental design for a guard and hinge structure, as shown and described.

DESCRIPTION

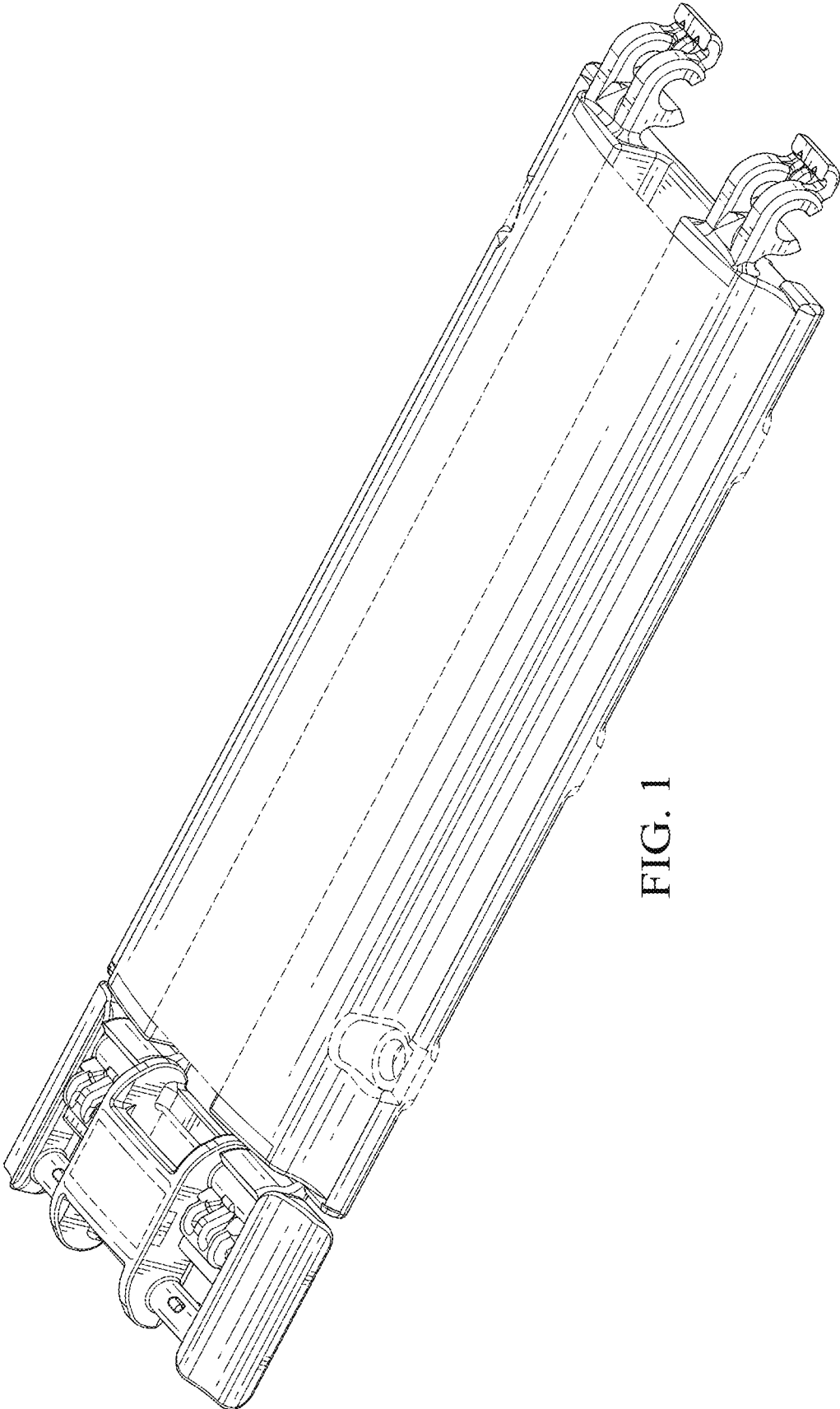

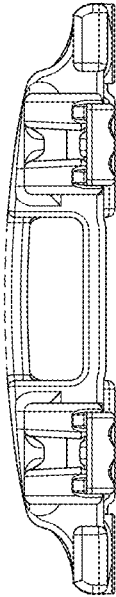

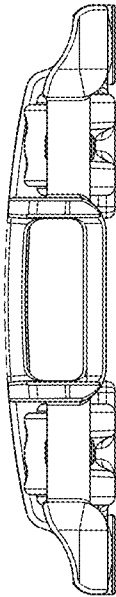

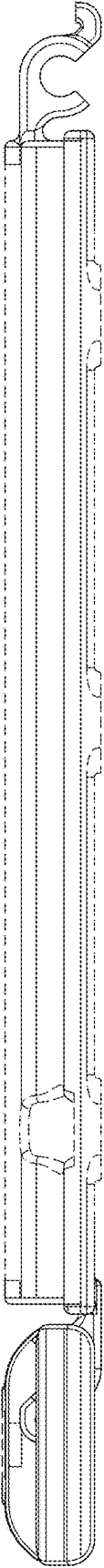

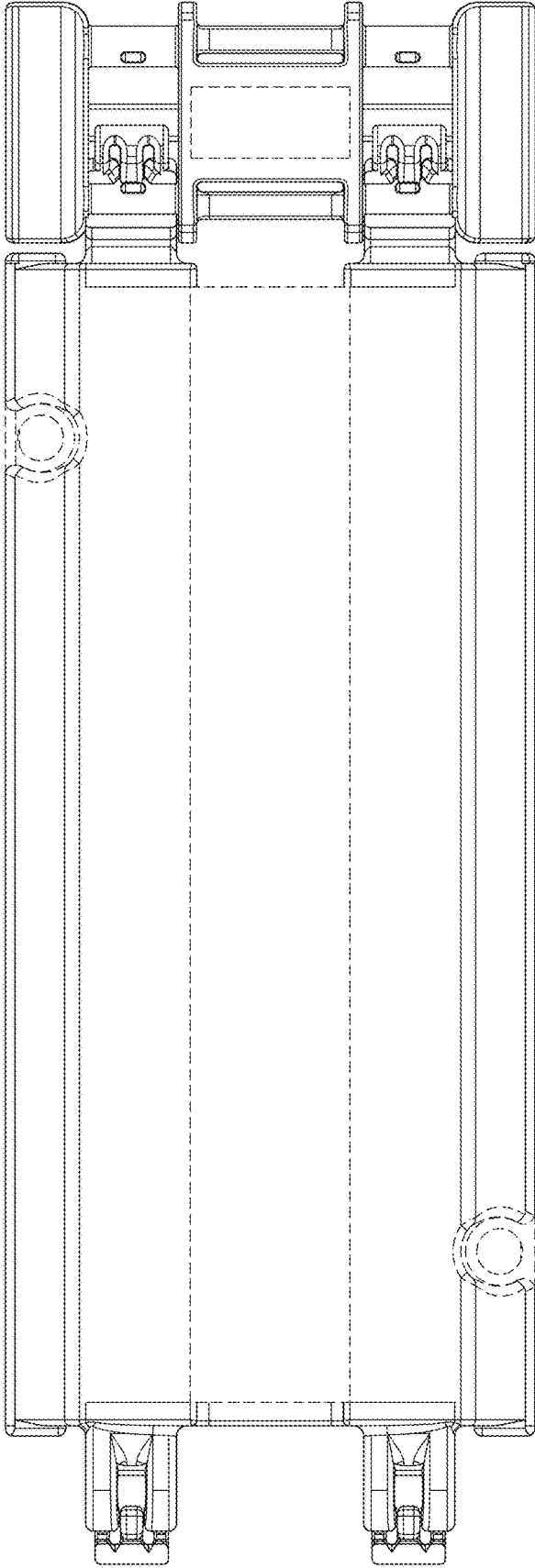

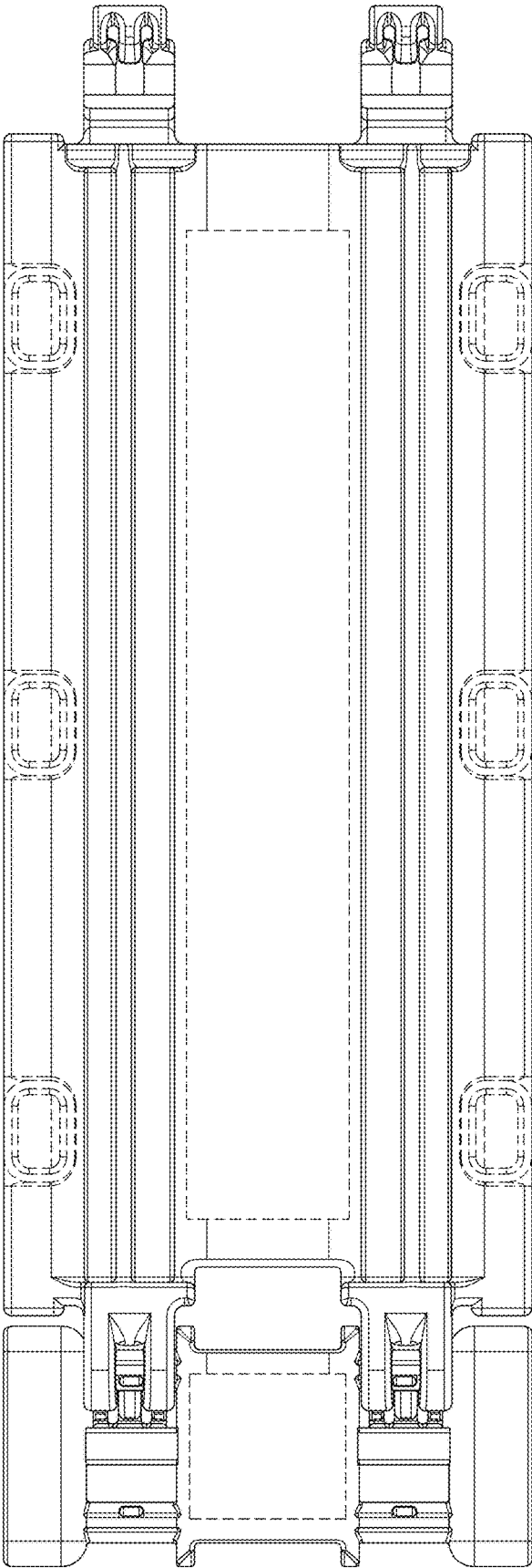

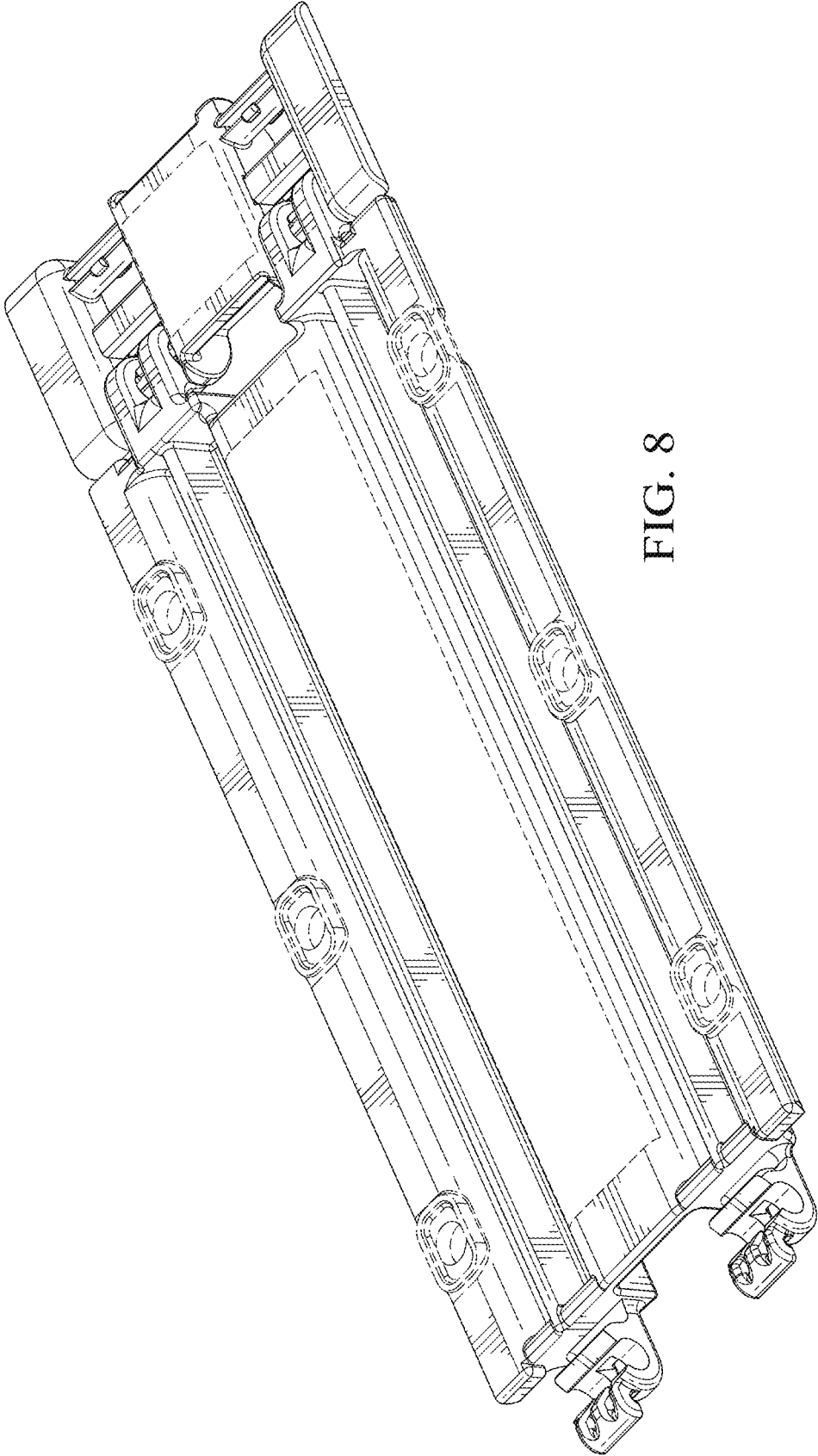

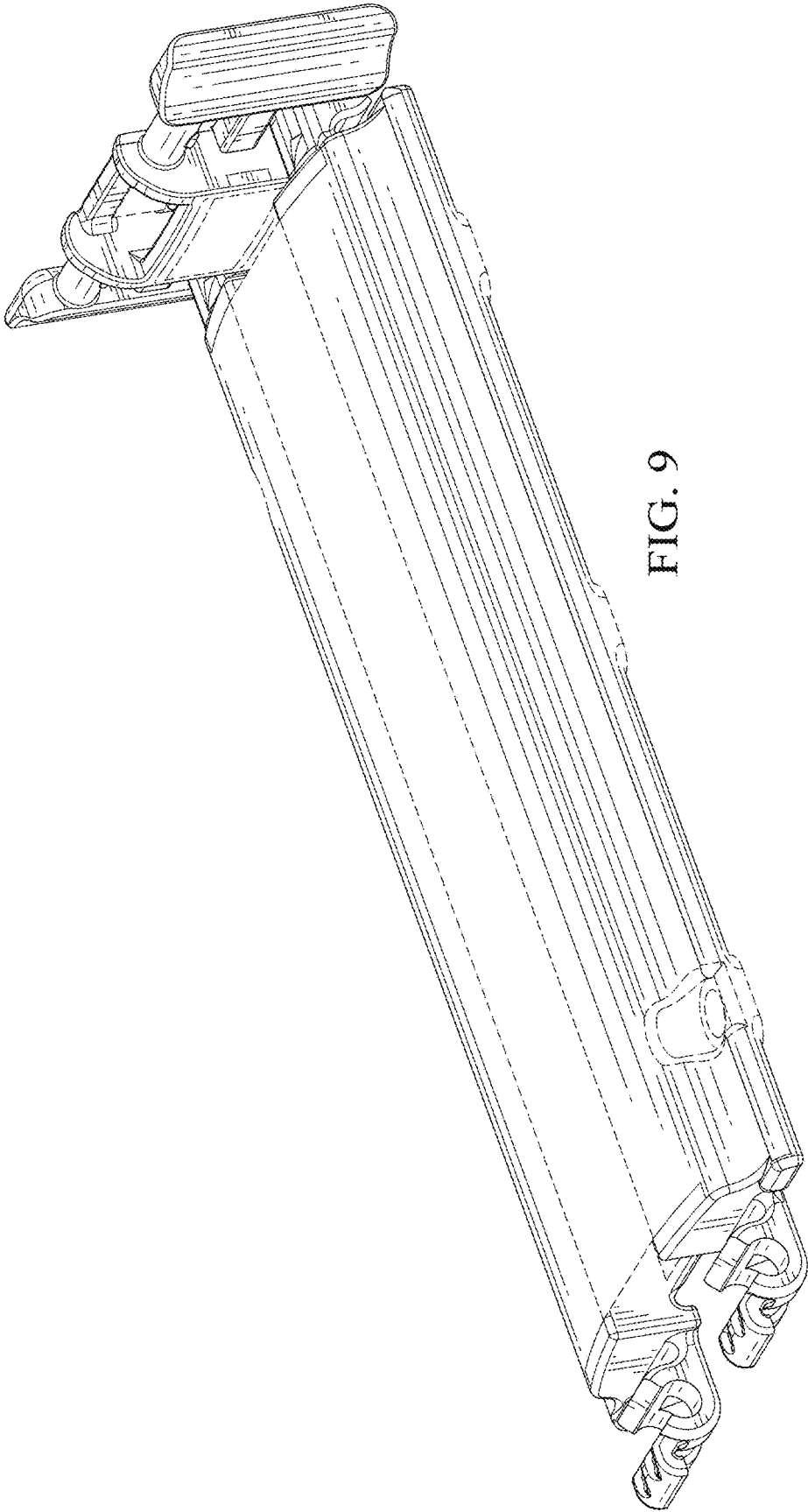

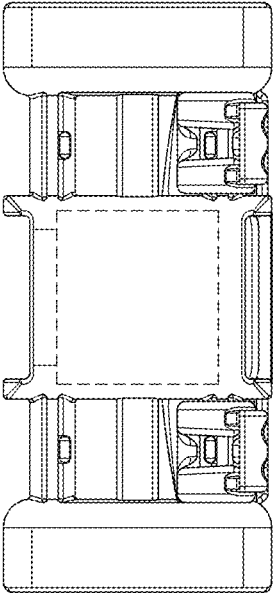

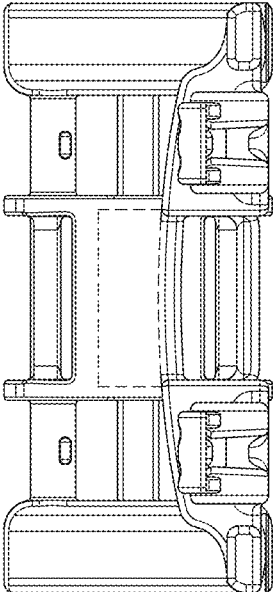

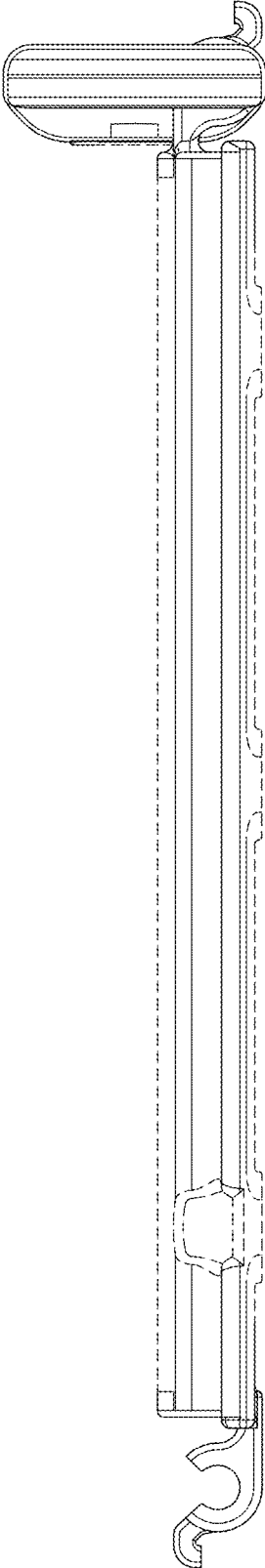

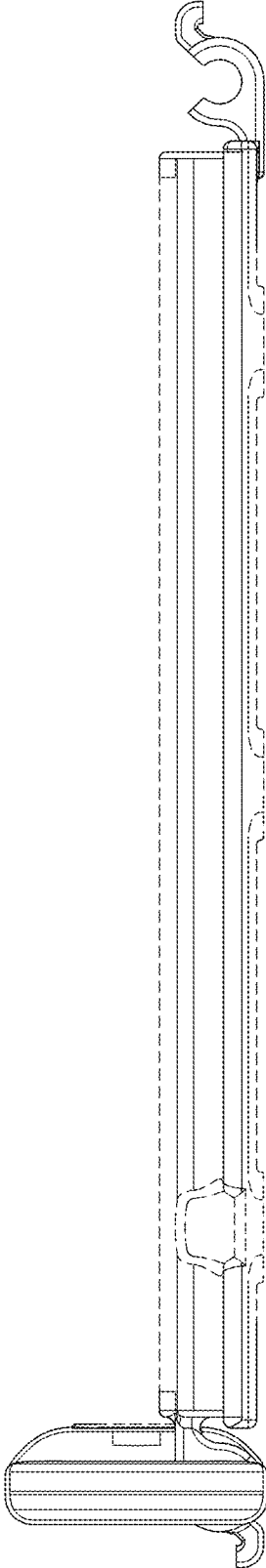

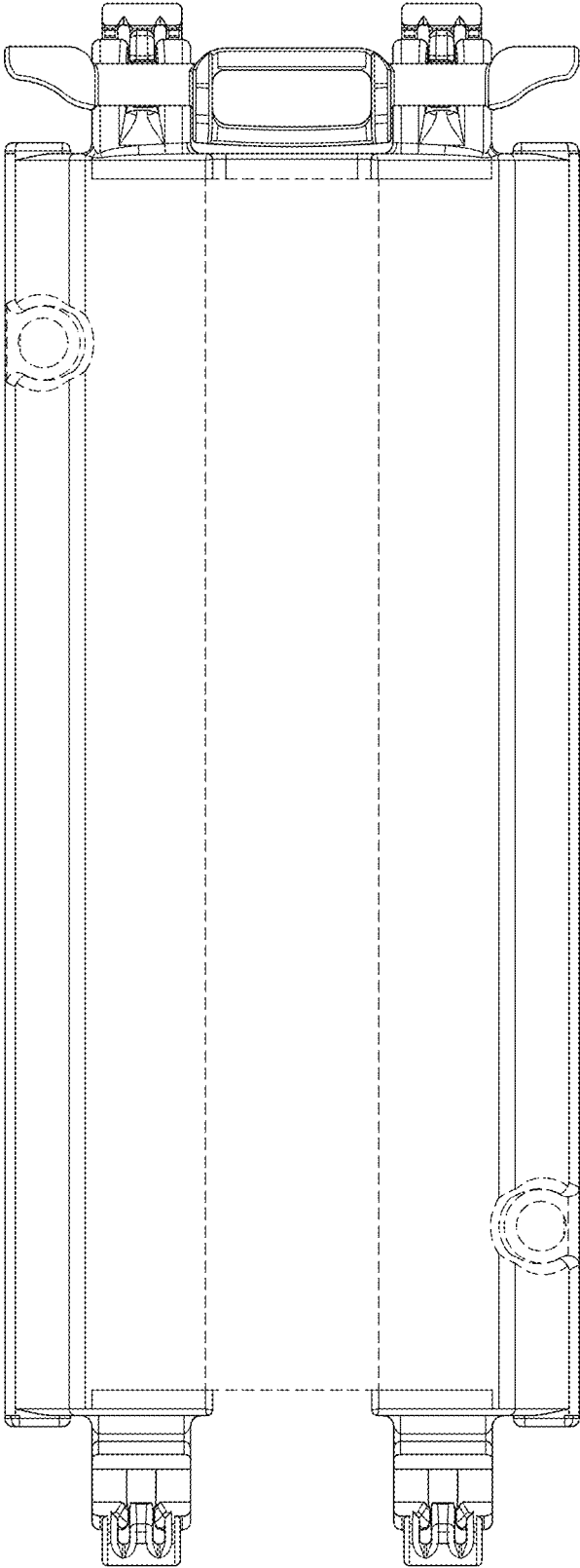

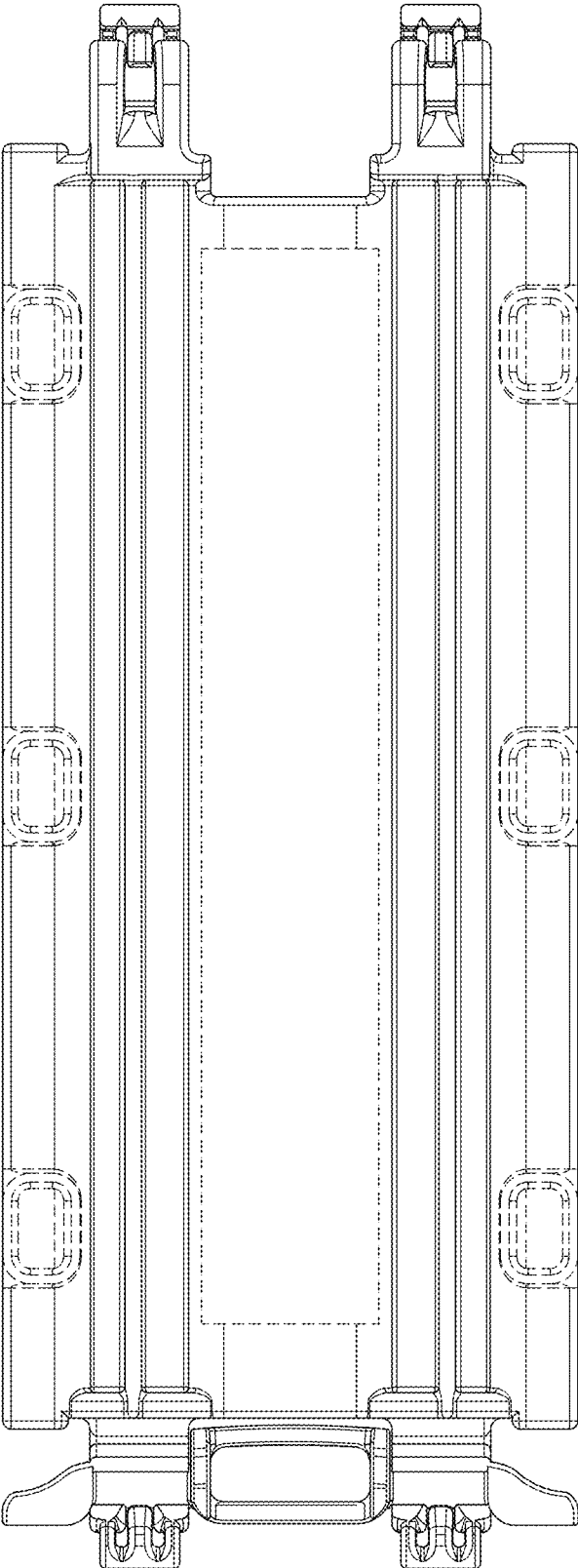

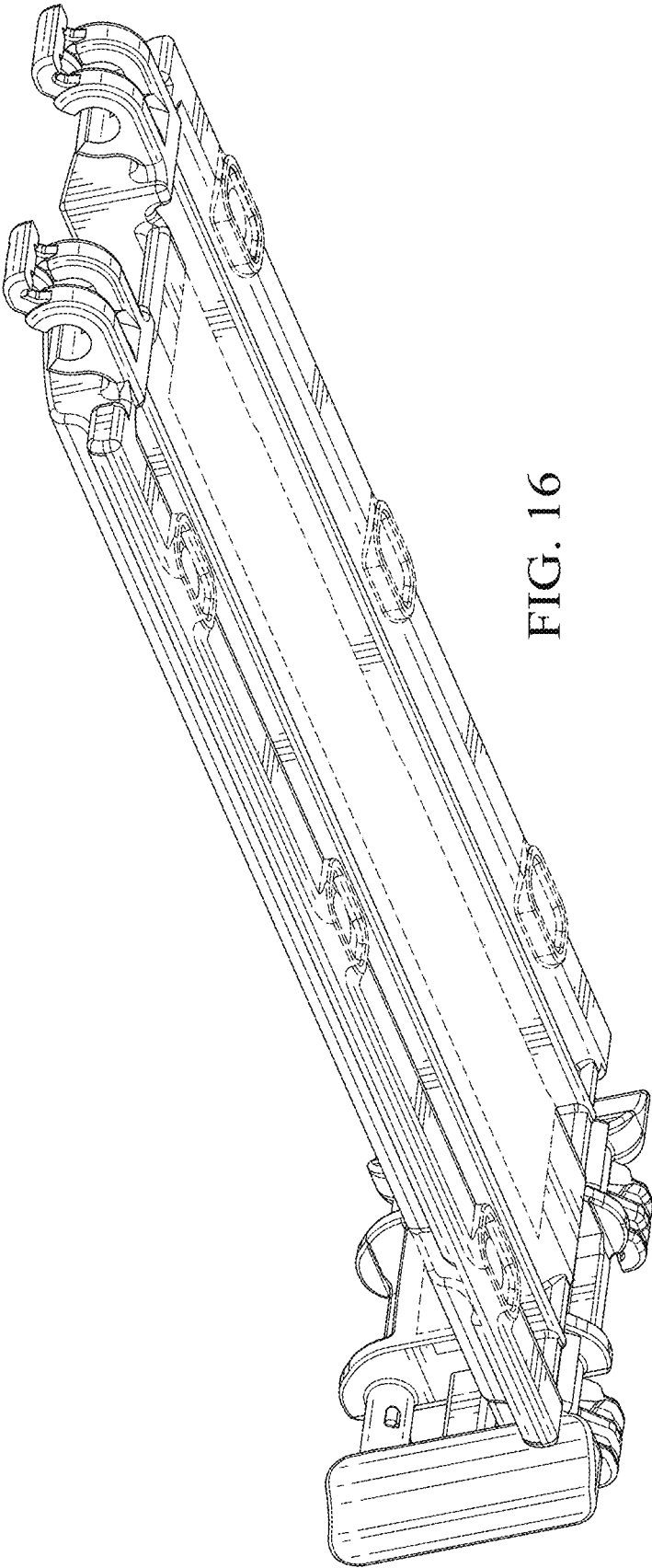
