(57) **CLAIM**

We claim the ornamental design for the spring head assembly for faucet, as shown and described.

**DESCRIPTION**

FIG. 3 is a right-side elevational view thereof;


FIG. 4 is a left-side elevational view thereof;


FIG. 5 is a back elevational view thereof;

FIG. 7 is a bottom plan view thereof.










