
(57) **CLAIM**

The ornamental design for a twelve tube vase, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a twelve tube vase; FIG. 2 is a bottom perspective view thereof; FIG. 3 top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a side view thereof; FIG. 6 is a side view thereof; FIG. 7 is a front view thereof; and, FIG. 8 is a back view thereof. 














